Labour and Environment.

The Principle on which the case study is written is the effective abolition of Child Labour.

Action taken to uphold this principle is Guranse Tea by providing teachers to the School established by the Government in the remote area where no teachers want to go and teach. We are automatically eliminating Child Labour as it is a normal practice for mothers working in gardens as pluckers to carry their children to work/work place. In this case as the Child grows up he/she automatically take up the kind of job/work the mother used to do which results in maybe not forced child labour but the parents take is as an additional income coming into the family.

By providing teacher/teachers to the Government School established by the Government in a remote area where no teachers want to go Guranse has provided teacher with paid salary so that the school can provide education which is the primary objective of all schools thereby effectively eliminating child labour.

Guranse has decided to sponsor two children of selected Woman laborers with their education. Guranse has no child labor on the tea estate.

#### Environment issue:

Since Guranse uses Organic fertilizers Guranse is preserving the Nitrate/Nitrogen content of the soil thereby preserving the ozone layer of the atmosphere and preventing Green House Gases forming and entering the atmosphere which otherwise would result in depletion of the ozone layer.
