Dear Mr. Secretary-General,

I am pleased to confirm that **Law Chambers of Vin Sa & Ian** supports the Ten Principles of the United Nations Global Compact on human rights, labour, environment and anti-corruption. With this communication, we express our intent to implement those principles. We are committed to making the UN Global Compact and its principles part of the strategy, culture and day-to-day operations of our company, and to engaging in collaborative projects which advance the broader development goals of the United Nations, particularly the Sustainable Development Goals. **Law Chambers of Vin Sa & Ian** will make a clear statement of this commitment to our stakeholders and the general public.

- A measurement of outcomes (i.e., the degree to which targets/performance indicators were met, or other qualitative or quantitative measurements of results).
