
We will implement the Global Compact and its principles in our strategy, culture and day-to-day operations. We will make a clear statement of our commitment to all our stakeholders and the general public.

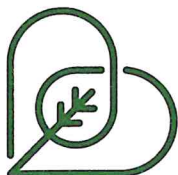
This includes:

- A measurement of outcomes (i.e., the degree to which targets/performance indicators were met, or other qualitative or quantitative measurements of results).
