### **Sustainable Development Goals**

Wesfarmers supports the Sustainable Development Goals (SDGs) (<https://www.un.org/sustainabledevelopment/sustainable-development-goals/>). The 17 SDGs present a broad sustainability agenda focused on the need to end poverty, fight inequality and injustice and respond to climate change. While they primarily target governments, the SDGs are designed to rally a wide range of organisations and shape priorities and aspirations for sustainable development efforts around a common framework. The SDGs recognise the key role business can and must play in achieving them. As part of our materiality study, Wesfarmers has identified nine SDGs where, by the nature of the business we are in, we feel we can maximise our impact on a global scale.
