Dear Miss Powell,

In accordance with our commitment last February, please find enclosed detailed information on our remediation activities on the coast of Peru in our annual progress report.

Although the ongoing investigations by the Peruvian judicial authorities suggest that the anomalous movement of the Mare Doricum broke Repsol submarine facility and, thus, caused the spill (which would mean that legal responsibilities should be borne by her Captain and shipowner), Repsol reiterates its absolute commitment to mitigate and repair the effects of this accident, which we deeply regret. From the very first moment, we put into action all our human, technical and economic resources to contain and clean up the spill as quickly as possible, while attending the needs of the affected population.

A web page compromisorepsol.pe was made available to all stakeholders from the outset, providing timely information on the progress of all the work being carried out; advances in remediation, assistance to communities, and the Action Plan. All this information is detailed in the more than 50 press releases that are published, as well as on Repsol's social media profiles.

According to the letter Repsol sent to the Working Group on the issue of human rights and transnational corporations and other business enterprises and Special Rapporteurs on last March 31st of 2022 [\(Link\)](#), our Company has conducted its work in accordance with our internal policies, which are



based on the highest international standards, including the UN Guiding Principles on Business and Human Rights and the 10 Principles of the Global Compact. We are currently working on the implementation of a social investment strategy and sustainable development projects based on project proposals according to the needs of the people affected by the incident and with the collaboration of social entities, national and international organizations, as well as the corresponding authorities.

Repsol has a firm commitment to its stakeholders and annually through the Global Sustainability Plan and its 18 local plans we make public our medium-term objectives and lines of action in the main axes of sustainability. Attached is the [2021 Sustainability Plan Perú](#)- published last June, which includes a report of the remediation activities carried out up to that date.

As participant of the UN Global Compact, Repsol remains fully committed to the Ten Principles. Our businesses follow the most strict HSE international standards, at times exceeding the requirements of the local regulations where we operate. And we remain at your disposal to continue this dialogue with you and the UN Global Compact to humbly assess the areas of improvement in our day-to-day operations and procedures.
