Dear Mr. Secretary-General,

I am pleased to confirm that Closed Joint-Stock Company «Minsk Soft Drink Factory» (CJSC «MZBN») supports the ten principles of the Global Compact on human rights, labour, environment and anti-corruption. With this communication, we express our intent to implement those principles. We are committed to making the Global Compact and its principles part of the strategy, culture and day-to-day operations of our company, and to engaging in collaborative projects which advance the broader development goals of the United Nations, particularly the Millennium Development Goals. CJSC «MZBN» will make a clear statement of this commitment to our stakeholders and the general public.
