建设澳大利亚凯特琳锂辉石矿和中国江苏张家港碳酸锂生产基地,积极为中国乃至世界的新能源建设出力。






## 总裁致辞

#### 二、科瑞集团简介

科瑞集团成立于 1992 年 7 月,是一家产业投资型跨国集团,重点投资涉及金融、制造、资源、地产等行业,总部设在北京。

科瑞集团得益于中国的改革开放,并努力希望企业成为改革开放的实践者和探索者。科瑞集团拥有丰富的金融高端人才,善于发现价值、培育价值并实现价值,曾开创性地设计"新世纪房地产投资收益券",建设性地推进"城市信用社",规范化地筹组中国民生银行,为改革开放中的民营企业开拓了许多重要的融资渠道。

科瑞地产注重人文情怀, 把更多的注意力放在调整都市紧张的节奏, 让烦躁的都市人通过亲和自然的休闲, 体味绿色生活的轻松与惬意。科瑞集团与长春市签署的开发莲花山协议, 提出了绿色生态休闲度假概念, 它的建成, 将为发展城市新型绿色旅游休闲项目提供范例。

Founded in July, 1992, headquartered in Beijing, Creat Group is a transnational investment group, which has developed a comprehensive investment portfolio across a range of sectors including financial services, manufacturing, resources and real estate.

Creat Group benefits from China's Open-door policy and strives to make itself the practitioner and explorer of the Reform and Opening-up. Creat Group has a large team of financial high-end talents, who is keen on the discovery, cultivation and realization of value. Creat Group has initially designed the "New Century Real Estate Investment Profit Securities", constructively promoted "Urban Credit Community",and standardized the organization of China Minsheng Banking Corp, Ltd, with the result of expanding various important financial channels for private-owned enterprises in the process of Reform and Opening-up.

Creat Group has consistently carried out the ideal of strengthening the country by industrial development, by allocating industrial investment and the integration of China's industrial capital, elevating China's industrial managerial level, improving China's industrial competitiveness, expanding China's role of industry in national economy and people's livelihood. With the advantage of farsighted vision and accurate judgment, Creat Group has integrated the win-win cooperation operational concept with the comprehensive strength of resources allocation, gained the ability of helping investment industry attaining favorable growth expectation, and realized transitional development by listed operation, thus establishing and strengthening its leading role in the industry. For example, Creat Group has invested and integrated Henan Pinggao Electric Company (HPE), Yantai Andre Juice, Shanghai Raas Blood Products Company (RAAS), which achieved a great success.

As Creat Group understand thoroughly that China's future development will encounter the potential risk of resources shortage, Creat Group has taken preventive measures, initiated to seek green mine resources and investment platform, by investing in succession not only in the ZZL Mine Company (now the changed name is Creat Resources), listed in London, but also in the Galaxy Resources listed in Australia. As the overseas mining funding platform of Creat Group, Creat Resources expects to stand at the height of national resource strategy, and provide active and effective assistance for Chinese enterprises' implementation of "going abroad" strategy. Galaxy Resources owns the second lithium mine resource in the world, transports the ores to Zhangjiang Port, Jiangsu Province of China by shipping. Then, Galaxy Lithium Mine Company processes the mines into battery grade lithium carbonate, making it the biggest lithium carbonate producer and impacting a positive impact on the development and utilization of clean energy.





#### **Introduction of CREAT Group**

Creat Group attaches great importance to humanism sentiment and focuses more on the adjustment of tense urban tempo and lets the fretting urban dwellers sense the relaxation and pleasure of green life by coming close to the nature. Creat Group and the Municipal Government of Changchun signed an agreement of Joint Development of Lotus Mountain, and put forward the concept of green ecological recreational holiday. The construction of such a resort will set an example for the development of a new green recreational urban holiday program.

With the strong consciousness of gratitude and reciprocation, Creat Group vigorously supports and participates in various charitable donations, activities of disaster rescue and social request for assistance, with the aim of shouldering the corporate social responsibility (CSR).





#### 三、2010年科瑞集团"全球契约"履行情况

2010年,科瑞集团积极宣传"全球契约"的基本精神,履行"全球契约"的各项约律,不仅将"全球契约"纳入集团的风险控制体系中,而且制定了《科瑞集团反贿赂与反腐败政策》,从制度上强化了反对商业腐败的原则。同时,科瑞集团利用筹组中国民营经济国际合作商会的工作机会,向更多民营企业宣传"全球契约"的基本原则,扩大了"全球契约"在中国民营经济领域的影响。

2010年,科瑞集团旨在保护环境的清洁能源开发与利用进入实质性实施阶段,银河资源位于澳大利亚的凯特琳锂辉石矿建成投产,位于中国江苏张家港的锂电池原料碳酸锂生产基地奠基开工。

在过去的2010年,科瑞集团不断完善公司各项规章制度,积极拓展新能源开发与利用的空间,努力承担着企业对社会与环境发展的历史责任。

#### 1、将"全球契约"纳入风险控制体系

科瑞集团十分重视"全球契约",因为它的基本原则与科瑞集团的企业文化精神相一致,因此,科瑞集团把防止违背"全球契约"作为重要的风险控制环节加以落实。

风险控制是科瑞集团对项目进行理性与安全把握的重要环节,2010年,科瑞集团要求各分支机构,每个项目的运作都必须符合"全球契约"的十项约律,并要求风险控制部门,将是否履行"全球契约"纳入项目审核的风险控制体系。

科瑞集团的公平竞争商业信仰,与"全球契约"中的"企业应反对各种形式的贪污、包括勒索和行贿受贿"的约律不谋而合。为了更加具体地践行契约,科瑞集团在2010年制定了《科瑞集团反贿赂与反腐败政策》并进行了全员培训,要求公司的领导、员工或代理人均不能利用行贿换取商业利益,任何违反本政策的人员都将受到纪律处分,包括终止劳动合同。

#### 2、在民营经济领域积极传播"全球契约"理念

2010年,全国工商联委托科瑞集团牵头筹备的中国民营经济国际合作商会筹组工作,得到了商务部和国家发改委的大力支持,进入到最后的国家审批阶段,2011年将完成注册成立。这个旨在服务大型民营企业"走出去"开展境外投资业务的全国性商





会组织,聚合了大部分中国民营企业中的佼佼者。科瑞集团受全国工商联委托,负责筹组商会的成立,与许多大型民营企业建立了良好的互信关系。科瑞集团希望利用中国民营经济国际合作商会这个平台,积极传播"全球契约"的基本理念,扩大"全球契约"在中国民营企业中的影响,希望更多的中国民营企业成为"全球契约"的签约者。

#### 3、强化以人为本的科瑞文化

创建伊始,科瑞集团就高度重视企业文化建设,倡导"忠诚、团结、勤奋、进取" 的创业精神,号召科瑞人将高昂的创业激情、现实的创业理性和务实的创业行动有机 结合起来,推动企业的发展。

经过发展,科瑞集团的战略决策更加稳健,运作经营更加理性,制度管理更加规范,企业文化更加鲜明,明确了"诚信重义、合作共赢、坚韧执着、创新高效"的核心价值观,突出了科瑞集团重视人的品质磨练,关注人的发展的新企业文化理念。

科瑞集团强化以人为本的企业文化,特别重视保护员工的权益,充分发挥工会的协调功能。2010年集团在改进管理制度的过程中,认真听取工会对"奖金管理办法"、"休假管理办法"、"员工福利、奖励、惩罚"等制度的意见,使集团在制订与员工切身利益相关的制度时,能够听到更多直接来自员工的声音。

本着以人为本的企业文化精神,科瑞集团工会建立了职工偶发事件关爱基金,对 遇到重病或遭遇重大家庭变故急需帮助的员工,给予必要的经济抚恤,让员工体味到 科瑞集团对员工的珍重与关爱。

#### 4、深化清洁安全新能源战略

科瑞集团相信,清洁安全的锂电池蓄能产业,是改变中国高投入、高排放、低产 出落后能源状况的一个理想选择,也是中国作为能源需求大国谋求持久发展的当然选 择。

2009年9月3日,科瑞集团与澳大利亚银河资源公司签署合作协议,科瑞集团成为银河资源第一大股东。

银河资源碳酸锂建设项目分为两个部分,一部分是澳大利亚凯特琳矿山采矿厂建设,另一部分是中国江苏张家港的碳酸锂加工厂建设。

2010年11月,经过一年的紧张建设,澳大利亚西澳州凯特琳矿山采矿厂正式建成

便强调对新能源的应用和减少对环境的破坏。

随着银河资源凯特琳矿山采矿厂建成投产,科瑞集团加快了中国江苏张家港碳酸锂加工厂的建设步伐,并开始积极寻求更多的锂矿资源,以求形成更大的产业规模,加快和扩大锂电池市场应用的速度和领域。

#### 5、启动绿色生态型地产战略

科瑞地产强调社会责任,关注城市的和谐发展,注重人文情怀,把更多的注意力放在调整都市紧张的节奏,让烦躁的都市人通过亲和自然的休闲,体味绿色生活的轻松与惬意,以释放紧张心情。





科瑞集团认识到,中国正处于工业化、城镇化的高速发展期和人民生活水平快速提升期。当前,中国城市化水平已经超过40%,未来十年,中国城市化率的目标是60%,集中体现为商业地产的持续需求和发展趋势。但是,任何不关注环境保护的野蛮开发,都可能给城市带来难以医治的创伤。

2010年,科瑞集团与长春市签署了开发莲花山协议,并提出了绿色生态休闲度假的概念,并为保护地区环境、美化地区环境制定了详细可行的方案。莲花山项目占地17平方公里,是集滑雪场、会所、温泉、生态酒店、康复中心、网球中心、生态住宅于一体的大型休闲旅游基地,它的建成,将为发展城市新型绿色旅游休闲项目提供范例。

#### 6、参与社会公益与慈善活动

2010年4月,科瑞集团捐款500万元帮助青海玉树地震灾区人民恢复重建。

2010年7月,科瑞集团牵头策划,并在北京成功举办了"血浓于水,大爱无疆——2010(北京)江西抗洪赈灾大型慈善活动",组织带动 23 家江西在外企业商会、各地赣商,向家乡江西洪涝灾区捐款捐物合计价值 3549 余万元。

科瑞集团还长期参与"红丝带基金"组织的公益活动,关心支持艾滋病患者和感染者。





#### **Ⅲ.Fulfillment of Global Compact of Creat Group in 2010**

In 2010, Creat Group was dedicated to promoting the soul of global compact and implementing various engagements of global compact. Not only has Creat Group put the global compact into the framework of its risk control, but also it has set out The Anti-Bribery and Anti-corruption Strategy of Creat Group in order to strengthen the principle of anti-commercial corruption institutionally. Meanwhile, Creat Group took the opportunity of establishing the China International Chamber of Commerce for the Private Sector to promote the fundamental principle of the global compact amongst the private sector and affected more in the field of private economy in the result.

In 2010, Creat Group put into action the clean energy exploitation project aiming to protect the environment. Not only was the Australian Cattlin spodumene lithium mine of the Galaxy Resources Ltd. completed and put into production, but also the Lithium carbonate production base in Zhangjia Port of China was founded. In the past 2010, Creat Group was committed to perfecting all the regulations of the company constantly, expanding new energy exploitation and utilization space as well as making every effort to assumed its historical obligation for social-environmental development.

#### 1 Incorporate "Global Compact" in the Risk Control System

Creat Group attaches much importance to the Global Compact, for its fundamental principle corresponds with the corporate culture of Creat Group. Therefore Creat Group regards the prevention of infringing on the Global Compact as an important risk control step for implementation.

The risk control is an important step for Creat Group to develop projects rationally and safely. In 2010, Creat Group not only required all the braches to make the running of every project comply with the ten engagements of the Global Compact, but also required its risk control department to put the Global Compact implementation into the project-auditing risk control framework.

Creat Goup's commercial belief of fair competition complies with the engagement in the Global Compact, which is that enterprises should be against corruption, extortion and offering or accepting bribes in any form. In order to implement the Global Compact more concretely, the Creat Group set out the Creat Group Anti-Bribery and Anti-Corruption Stratety in 2010, and conducted a training of entire staff requiring the managements, staffs and agents must not offer bribes for commercial benefits. Anyone who offends the requirement will be punished with disciplinary treatment or even labor contract termination.





## 2. Actively Promote the Thought of "Global Compact" in the Area of Private Economic Field

In 2010, Creat Group was entrusted by the All-China Federation of Industry and Commerce with a task to organizing the setting-up of the China International Chamber of Commerce for the Private Sector, which has stepped into the final stage of state approval and will be founded and registered in 2011 with strong support from the Ministry of Commerce and the State Development and Reform Commission. This national chamber of Commerce is to combine most of the best China's private enterprises with an aim to providing service for large-scale private enterprises' engaging in investment business outside the territory of China. Creat Group, who was entrusted by ACFIC with setting up the Chamber of Commerce, has established a good relationship based on mutual trust with many large private enterprises. Creat Group expects to promote the fundamental principle of the Global Compact by the platform of CICCPS and consequently strengthen the Global Compact's influence on China's private sector. Hopefully more and more China's private enterprises will be signatories of the Global Compact.

#### 3. Intensify Creat Group's Culture of Putting People First

Creat Group has paid much attention to the cultivation of corporate culture ever since its foundation. Creat Group advocates a pioneering spirit of "loyalty, Unity, Diligence, Enterprise", which calls on Creat's everyone to combine high pioneering spirit, and realistic venture rationality and practical entrepreneurship actions together and thereby push enterprises forward.

After long-term development, Creat Group makes strategic decision more firmly and safely, runs the business more rationally, adopts more canonical system administration and more fresh and clear corporate culture. Creat Group has made clear its core values of "frank honesty, win-win cooperation, firmness of purpose, innovation and efficiency", which highlights Creat's new corporate culture philosophy focusing on employees' character-forging and development.

With the purpose of strengthening people-oriented corporate culture, Creat Group attaches much importance to the benefits of its employees as well as brings the coordination function of its labor union into full play. In 2010, Creat Group listened seriously to the opinions of the labor union regarding such systems as bonus management, off day management, employee welfare &prize &punishment, by which the group could know more about employees' concerns when developing systems in relation to their benefits.

Based on the people-oriented corporate culture, the labor union of Creat Group has established a relief fund for employees' accidents, which can provide necessary comforts and compensations to needy employees caught in a deathly ill or suffering a family





misfortune. This makes employees feel the care and warmth from Creat Group.

#### 4. Deepen Clean Safe New Energy Strategy

We are convinced that the harmonious relationship between economy and environment will increasingly attract the world attention. People raise much higher and more specific demand and requirement to the clean energy. Meanwhile, security is the basic requirement of Creat Group to the new energy. If new energy is under potential danger, out of control and assessment, it may bring devastating damage to the future environment. Creat Group has always regarded the development and utilization of clean and safe energy as the goal and direction of the company's new energy strategy.

Creat Group believes that the clean safe lithium storage power industry is not only an ideal choice to change China's energy resources utilization status of high-cost investment, high emission and low yielding, but also an evitable choice for china with a massive energy demand to keep a sustainable development. On 3 September 2009, Creat Group signed a cooperation agreement with Australian Galaxy Resources Ltd. and became its biggest shareholder.

The Lithium carbonate project of the Galaxy Resources Ltd. consists of 2 parts. One is the Australian Cattlin spodumene lithium mine, and the other is the Lithium carbonate production base in Zhangjia Port of China. In November 2010, after one year of grueling construction, the Australian Cattlin spodumene lithium mine was formally completed and put into production, which signified that the new energy resource strategy of Creat Group had stepped into a development stage of real substance. As a practitioner of clean energy

resources application, we installed an electricity system composed of 14 huge solar photovoltaic panels during the construction of the Cattlin spodumene lithium mine especially for the mine's production, which highlighted new energy resources application and less environmental destruction.

After the Australian Cattlin spodumene lithium mine was completed and put into production, Creat Group sped up the construction of the Lithium carbonate production base in Zhangjia Port of China. Meanwhile, Creat Group began to look for more Lithium mine





resources so as to expand the scale of the industry and thereby give a boost to the Lithium battery market.

#### 5. Initiate Green Ecological Real State Strategy

Creat Group attaches great importance to corporate social responsibility, pays attention to urban harmonious development and humanism sentiment, and focuses more on the adjustment of tense urban tempo and lets the fretting urban dwellers sense the relaxation and pleasure of green life by coming close to the nature.

Creat Group recognizes that China is in the process of industrialization. Urbanization is at the phrase of rapid development and people's living is drastically escalating. At present, China's urbanization rate is beyond 40%. In the next ten years, China's urbanization rate's goal is 60%, with the concentrated characters of sustainable demand and development tendency in the commercial real estate sector. However, any brutal development which shows no concern about environmental protection may bring incurable trauma to the urban areas.

Creat Group and the Municipal Government of Changchun signed an agreement of Joint Development of Lotus Mountain, put forward the concept of green ecological recreational holiday, and formulated a detailed and feasible plan for the protection and beautification of the environment within the territory in 2010. Lotus Mountain project occupies an area of 17 square kilometers, serves as a large-scale recreational tourist basis combined the functions of skiing resort, club house, spa, ecological hotel, rehabilitation center, tennis center and ecological residence. The construction of such a resort will set an example for the development of a new green recreational urban holiday program.

#### 6. Participate in the Social Welfare and Charitable Activities

Creat Group has participated in social welfare and charitable work. Creat Group took the lead in planning and successfully holding "Blood Thicker Than Water, Boundless Love—Grand Charitable Activity Combating A flood and Relieving Disaster Victims in (Beijing) Jiangxi, 2010"in April, 2010.Creat Group organized and promoted 23 Chamber of Commerce out of Jiangxi, Jiangxi entrepreneurs to donate 3.549 million worth of money and goods to their hometown of Jiangxi. Creat Group has also participated in the public welfare activities organized by "Red Ribbon Fund" and supported AIDS patients and HIV carriers.
