

# PRINCIPLE 10 BUSINESSES SHOULD WORK AGAINST CORRUPTION IN ALL ITS FORMS, INCLUDING EXTORTION AND BRIBERY

The fight against corruption and bribery forms the basis of Global Advice Network's consultancy work and our work to help clients, i.e. businesses and institutions, in their endeavours to implement and live up to their integrity principles. A major part of this work has been to develop and operate the Business Anti-Corruption Portal (<u>www.business-anti-corruption.com</u>). The Portal is designed to support small and medium sized enterprises (SMEs) operating in emerging markets and developing countries to avoid and counter corruption in order to produce a better business environment. More than 60 business and corruption focused Country Profiles are available on the Portal and are regularly updated.

As part of the Portal, a number of tools are made available for general use. As part of Global Advice Network's commitment to the UNGC, some new tools have been developed pro-bono and made available on our website. In the case box on the following page, a description of the development of the Anti-Corruption Tools Inventory to assist businesses and organisations in the implementation of the Global Compact's 10th principle is provided.

Global Advice Network has developed a draft Code of Conduct related to corruption and bribery. The intention is to finalise this in the coming year and to extend the focus to cover all UNGC Principles.



### **CASE STUDY – DEVELOPMENT OF A FREE ANTI-CORRUPTION E-LEARNING IN RUSSIAN**

#### Background and Purpose

Global Advice Network has over the years conducted several anti-corruption business workshops in Russia and neighboring countries where Russian or languages close to Russian are spoken. We have also trained several young business leaders from Russia in Sweden. Parallel to this we have been working with companies operating in Russia and Ukraine. Together, this means that we have a large pool of knowledge regarding anti-corruption in Russia.

Following a request from Ukraine, we decided to develop an e-learning module in Russian, meaning that it also can be used in Ukraine. So far a beta version has been developed, presented and approved at a workshop in Petrozavodsk. The next phase of the project will be to develop a final version in cooperation with key stakeholders in the area. These stakeholders include local government, business associations and civil society.

### **Description of the Russian Anti-Corruption E-Learning:**

The e-learning project is the first of its kind in Russia. It will be the first free of charge tool in Russia. The e-learning has the following features:

- Covers international anti-corruption conventions
- Russian cases of corruption
- Specific information on Russian anti-corruption legislation
- Covers grey areas (facilitation payments, gifts, donations, travelling, etc.)
- A quiz to test knowledge retention

The e-learning will teach Russian speakers about; corruption, what sort of corruption risks they are likely to face and the relevant legislation. Upon completion of the e-learning, users will have a greater knowledge of corruption and of how to avoid it.

The e-leaning has been developed by Global Advice Network based on its own research and knowledge acquired through conducting many workshops on corruption, especially those conducted in Russia or Russian speaking countries, and through our professional activities with companies operating in Russia and Ukraine.
