Subject: 90-day COP deadline extension to all GC business participants in Japan

Dear Ms. Hanafusa,

Following the devastating earthquake and tsunami that hit Japan on 11 March, many Japanese companies in the Global Compact have undertaken significant efforts to provide assistance and support to the affected communities along the Pacific Coast of Northern Honshu. The Global Compact Office recognizes that relief and recovery operations are a national priority and will continue to impact much of Japan's social and economic life in the coming weeks and months.

In order to accommodate Japanese businesses trying to cope with the consequences of the disaster, we have decided to offer a 90-day COP deadline extension to all GC business participants in Japan. Any company wishing to make use of this offer should inform Christine Weinreich (weinreich@un.org) from the Communications on Progress team. It will **not** be necessary to submit a grace period request. We hope that this modest measure will be of help in this time of crisis.

We would greatly appreciate if you could share this information with the network members. Our thoughts continue to be with Japan these days. Please let us know if and how we can be of any further assistance.
