
- ECCA-Nepal was established in 1987 as a non profit, non political, non government organization,

ECCA believes that for new methodology consists of two ways for information flow and getting feedbacks. For any flow of information, youths (counselors) are trained by the experts. Counselors interact within themselves and give feedbacks. These youth then travel to different parts of the country and create awareness campaigns through camps, campaigns and interactions. The target groups of Counselors are children and interactions between them are encouraged. Finally, the message is dispersed into the community through children. During this, feed backs and interaction are collected within different level as well.



1.1 Wise use house



With the objective of operating different organizations independently for mutual benefit, it is envisaged to house several link-minded NGOs in the ECCA building – named as "Wise-use House" - and in adjacent buildings and develop a new concept in networking. This had been launched not only to make optimum and efficient use of available resources but also to bring together like minded individuals and groups of people to a common platform from where we can launch our best ideas and efforts to secure a sound ecological, prosperous and just future for Nepal and our planet.

Besides ECCA, other offices in the wise-use house complex are: Kathmandu 20/20, Nepal National Committee of IUCN, Center for Renewable Energy (CRE), Versatile Research and Training Academy (VRATA), Chandra Gurung Conservation Foundation (CGCF), Group for Rural Infrastructure Development – Nepal (GRID), Group of Engineers for Appropriate Technology (GREAT Nepal), Society of Mechanical Engineers Nepal (SOMEN) and Future Now Pvt. Ltd. (FN).

Environment friendly practices at the Wise-use House

- Solar photovoltaic system
- Rain water harvesting
- **Grey water treatment:** Grey water and Black water are separated. Grey water (i.e. water from kitchen and urinals) are passed through the constructed wetland (reed bed) to treat and collected in 500L underground tank, which is then pumped to overhead 500L tank to re-use for flushing of toilet urinals and cubicles. This practice has also saved fresh water.
- **Black water management:** Black water (i.e. sewage from toilets) is collected in two chambered septic tank. The overflow enters into the soak pit.

2 Enterprise Initiatives Unit:

ECCA Nepal understands that economic development initiatives and facilitations are effective and sustainable only if these initiatives are aligned with business principles. ECCA Nepal believes in global compact's three bottom lines of sustainable development viz: - planet, people and profit. Since its establishment, ECCA Nepal has been working for the conservation and advancement of planet and people. Enterprise Initiatives (EI) is a new endeavor of ECCA Nepal (initiated from January 2008) walking-the-talk towards 'think-like-business' and



adopt business principles in development activities. El is established as an additional unit of ECCA Nepal. Along with its establishment El unit has formulated a new professional team to carry out El activities effectively.

Corporate Social Responsibility (CSR) is another approach for EI to explore private sector world for partnership. The CSR approach focuses on the triple bottom line approach which is economic, environment and society.

Major Achievements

SRBDN Forum (www.srbdn.org.np)

Socially Responsible Business Development Network (SRBDN) was formed in October 2004 to create awareness on Corporate Social Responsibility in Nepal through discussion forums on different responsible issues. The main objective of SRBDN is to create awareness on responsible business/CSR to businesses in Nepal. ECCA Nepal, through EI unit, has been backstopping the SRBDN secretariat and its activities since January 2008. Action Aid Nepal (AAN) is also partially supporting SRBDN secretariat. Three forums were held in the past year having the themes "Good Practices on CSR", "CSR and Business Schools", "Employer and Employee Relationship" and "Private-Development Sector Partnership for Sustainable Development".

Linkage with SAFoRB

South Asian Forum on Responsible Business (SAFoRB) is a regional voluntary association of a group of civil society organizations (CSOs) in South Asia united by a common vision and goal for "Responsible Business ECCA–Nepal is an organisational committe member of the forum since its inception and also represents at steering committee.

Study on State of Nepali Readymade Garment Industries

Solidaridad is an initiator and driving force behind Fair Trade, and an active player in organic agriculture. It was established in 1976 in The Netherlands and is intensely involved in CSR models such as Utz Certified, Social Accountability International (SAI) and Business Social Compliance Initiative (BCSI).

Solidaridad - South and South East Asia and ECCA Nepal conducted a study on the Nepali Readymade Garment (RMG) Industries, with the objectives of understanding the social and environmental status of Nepali RMG units and studying the future of RMG units in Nepal.

Study on Nepalese Private Sector's Involvement in Water and Sanitation

This study conducted for UN HABITAT - Water for Asian Cities Programme Nepal was completed. Major findings from the study was that the respondent were aware about CSR issues and were willing to join hands with develoment organisations to carry out activities relating to responsible businesses.



Private and Development Sector Partnership

Preparation work are going on to develop communication between Private Sector and NGOs. Viraf Mehta ED, Partners in Change, India was the main speaker in the SRBDN fourm on Private – development sector 'Partnership for Sustainable Development'.

Recycling of scrap paper makes use of waste as a resource and adds value to it by producing various products. Besides managing the waste problem, paper recycling also has the added benefits for saving natural resources, reducing dependency on foreign resources and products, creating jobs and generating revenue. The challenge still exists to change our society's habit of "throwing" into the habit of "recycling". To replicate the concept and to further promote paper recycling in Nepal, ECCA has been helping other organizations as well to setup their own paper recycling unit.

ECCA's PapAgain is presently being managed by Innovative Ideas Pvt. Ltd.

3.0 PROGRAMS

3.1 Children school rights and Environment Conservation Follow up Program

ECCA has been very successful in providing environment awareness to youths and students but could not promote desirable action and behavior because their environment does not encourage them to do so. Therefore it was realized that work should also be done on improving the school environment.

This program was launched from February 2006 with the support of Taksvarkkiry, Finland to provide school environment that is child and student friendly and welcoming for a child. School environment not only includes quality curriculum and trained teachers but also clean toilets, safe drinking water, greenery by proper management of open space, and privacy (especially for a girl child). Classroom management and relationship among children, teachers and community also plays an important role in improving the school environment.

The project contributes towards UN Decade on Education for Sustainable Development (DESD), in achieving the Millennium Development Goals (MDGs) and in "Education for ALL" campaign of Government of Nepal.

3.2 Human Values-Based Water, Sanitation and Hygiene Education (HVWSHE)



In Nepal, there is general lack of awareness in and understanding of water conservation. It is in this context that HVWSHE has been launched so as to build capacities of schools and communities in order to facilitate changes in behavior and personal attitudes among people and to promote better understanding of the critical roles that water conservation, among other things, play in human development and survival. It is also a strategic entry point for bringing about positive attitudinal and behavioral changes and, in the longer term, for helping develop a new water-use ethic in society.

ECCA has been piloting the HVWSHE in partnership with Ministry of Education and Sports (MoES), Stepping Stone, PWEDO and the schools with the financial support of UN HABITAT Water for Asian Cities Program.

4.0 Biodiversity Conservation Initiatives through Grassroots Participation (BCIGP)

BCIGP Project was launched in five village development committees (Maipokhari, Sulubung, Pyang, Nayabazar and Gorkhe) of llam district (eastern Nepal) for the period of 2 years (April 2007 – March 2009) with the financial support from Critical Ecosystem Partnership Fund (CEPF), USA. The project is aimed at conserving biodiversity of Kanchenjunga - Singalila Corridor complex by incorporating Biodiversity Conservation (BC) elements into the community forest (CF) operation plans (OP). Most of the existing CF operation plans only loosely incorporate biodiversity elements, giving high priority to fuel wood, fodder and timber production. As the area is rich in biodiversity and has many endangered species, they need to be protected along with sustainable harvesting of daily needs of local users.

5.0 Campaigns

LIGHT-FOR-ALL

In Nepal, 2.4 million households are to this day compelled to use kerosene based *Tuki* for household lighting, as they do not have access to electricity (either because of the geographical remoteness from the national grid or because of not having the capacity to pay for the electricity connection even in the place where national electricity grid is available). This form of lighting is neither cost effective nor is it environment friendly

Plant-a-Tree

Global warming has threatened the future of the Earth. No doubt, the increasing human activities have brought the consequence where Nepal is no exception. A country, where majority of people depend on agriculture,

Ram Saran Magar, resident of Dalchowki, Southern Lalitpur, user of Solar tuki from last one and half years says that the oil-wick lamps used in his home before solar tuki was a nuisance. He adds, "My two small kids who do their homework under oil - wick tuki always strain their eyes and there is a big risk of catching fire. Now there is no need to wait in kerosene queues and no need to buy batteries for the radio. This is a good solution for us who don't have any electricity facilities. Now we are safe



forest for firewood, and rain for water, will have severe consequences from shifting of hydrological cycle, shifting of vegetation and outbreak of diseases with even a rise of one degree centigrade.

ECCA has initiated Plant-a-tree campaign by linking it with the on-going ECCA projects (school environment improvement, beautification, wise use of open spaces). Through these on-going projects, basic facilities are already supported and this campaign will value add to it and vice versa.

Support-a-Child

Although the development in the education sector is significant, the situation where Nepal stands now is still far from the world status. About 50% of the 6+ year age group population is still illiterate and about 30% of primary age children are still not enrolled in school. A significant proportion of the children who are enrolled in primary school are dropped out from school. Many of these problems pertain to the social and economic situation of the country. Resource crunch has always been a problem in education. In Nepal, there are still many parents who do not send their children to school because of the financial situation. ECCA Nepal will facilitate to allocate and distribute resource through this campaign.

Adopt a Child

Adopt a child program encourages direct support of individual students. Those who are financially backward need financial support to continue the study and maintain the education standard. By adopting a child, an individual or institution could support student by providing scholarship for tuition fee and acquiring other educational materials. Adopt a child program also aim to develop the capacity of the students through different capacity development activities

School to school

One urban school with an average strength of about 1,500-2,000 students can support 4 to 5 rural schools, which have around 200 students. The focus is on sensitizing the urban school children and their parents to the needs of their counterparts in rural areas. ECCA helps to channelize their discarded material like old books, uniforms, shoes, school bags etc. to the needy school in Nepal, thereby reducing the dropout rate of the students in the rural school due to the lack of the stationary materials.

6.0 United Nations Youth Advisory Panel (UNYAP)

The UNYAP is a part of the UN Country Team's (UNCT) commitment to the young people's empowerment and rights in accordance with basic human rights principles and the Convention on the Rights of the Child. UNCT recognizes the value of dialogue between young people and the UNCT for an effective implementation of the UN Development Assistance Framework (UNDAF) 2008 – 2010 and the attainment of the Millennium Development Goals (MDGs).

Formalization of UNYAP (in Nepal) was done on October 23, 2008. ECCA representative has participated actively in various programs (Consultative meeting on Youth Environment Corps that is focused on generating employment for Nepali youth in the environment sector, National Consultative Workshop on Youth and the



ICPD, Youth Meet – 'All Different, All Equal' - Consultative Seminar to identify the strategies for National Youth Programs and Policies, Regional Youth Summit (Central Nepal).

7.0 Professional Volunteer Program

Life Skill Program

In FY 2063/64, ECCA had initiated life skill and physical education training classes in 5 government schools in Lalitpur City in partnership with Lalitpur Sub-Metropolitan City Office and Canadian volunteers. For its continuation, life skill group had been established within the nature club in each of these schools. These groups organize life skill program in the school regularly under the guidance of ECCA counselors and school teachers. Research proposal on life skill was approved by Nepal Health Research Council. Accordingly, Dr. Tanya Forneris conducted refresher training.

8.0 Training /Seminar/Awareness

Regional Seminar on Safe Water

ECCA in partnership with Vertical Shaft Brick Kiln / Cost Effective Social and Environmentally Friendly Technology Transfer Programme (skat and SDC) and ANTENNA Technologies, Switzerland held regional seminar on safe water (April 20-21, 2009). The aim was to share, to learn and to demonstrate the technologies (especially WATA chlorinator device recently tested in Nepal, India and Bangladesh), modalities and best practices on Safe drinking water targeting the agencies working in the area of safe water. The participants were from Nepal, India, Bangladesh and Switzerland.

World Drug Day: June 26, 2009

Street dramas were performed so as to make aware the public about the negative impacts of drugs.

Youth Summit on Global Warming

ECCA (along with ICIMOD and VSBK) supported one-day Youths' Summit on Global Warming (15th January 2009) organized by Team for Nature and Wildlife (TNW) Nepal in Kathmandu. During the occasion, Mr. Anil Chitrakar was felicitated and presentations were made by four resource persons. More than 40 youths participated from different sectors like media, film, theatre, sports, human rights, law, arts, business, culture, fashion and modeling, music, politics, education, etc.
