Dear Ms. Christine Weinreich

I'm Masa Nakamura, the focal point for Kuroda Electric Co., Ltd. and this is to request an adjustment of COP submission deadline.

My understanding is that a grace period of 90 days may be granted by the Global Compact Office if a reasonable explanation for the extension is posted on the Global Compact website with an expected date of COP submission.

As you know, Kuroda Electric Co., Ltd. participated in the Global Compact on March 2, 2011. Therefore, Kuroda must submit a COP by June 2, 2012 on the assumption that a grace period of 90 days is granted.

However, we would like to request a further extension of the COP submission deadline to be synchronized with the realistic schedule for the issue of our first CSR report. The reason for the adjustment request is because Japan's fiscal year ends on March 31, 2012 and environmental data (such as electricity usage, fuels etc.) will be available around the end of April or early May. So, it is difficult to finalize our CMS report within a month from early May since this is the first time to issue so-called CSR report although the following CSR report can be issued within one year.

Due to the reason described above, I would like to request an adjustment of COP submission deadline and June 30, 2012 be accepted as the new expected deadline.

I would highly appreciate it if you could grant our request.
