
2011年,我行成功引入战略投资者,完成社保基金100亿元入股。

Capacity Building

CDB has installed a special department in charge of social responsibility in its headquarters and appointed a social responsibility liaison officer in every department and branch bank. In 2011, we continued to strengthen staff training on sustainable development concepts and skills, and incorporated social responsibility management into our in-house performance evaluation system for the first time, making the sustainable development philosophy better integrated with institutional strategy and daily operation.



In 2011, CDB dedicated itself to deepening and broadening its domestic cooperation on development plans and went full speed ahead in the international front (see the section of international cooperation on development plans) to spare no efforts in serving national development strategies.

Sub-region. In May, 2006, Chairman Chen Yuan promised that CDB would "help Guangxi make longer-term and better development plans for the Beibu Bay Economic Development Zone." With the support of CDB, the Development Plan on Beibu Bay Economic Zone of Guangxi Autonomous Region was approved for implementation by the central government in 2008, while the opening-up and development of Beibu Bay has been elevated into a national strategy. CDB's research proposal on using development finance to support the development plan of Beibu Bay Economic Zone was adopted by the local government.

By the end of 2011, CDB has extended more than 200 billion yuan of loans to several projects in Guangxi, including the ecological treatment of Silvery Beach District in Beihai, the infrastructure construction in Fengling and Wuxiang Districts of Nanning.



Enrich China's Financial Ecology

In 2011, CDB issued financial bonds of 1.16 trillion yuan, underwrote another 264.4-billion-yuan of bonds as the lead manager and posted a trade volume of 19 trillion yuan. CDB has become the largest bank specialized in bond services, complete with the functions of bond issuance, underwriting, investment and trading. The bank also established fairly good partnership with savings bank to complement each other's advantages and commonly shore up the economy.



Support Infrastructure, Two Basic and One Pillar Industries

Infrastructure and the basic and pillar industries are the foundation of national economic development and where CDB gives priority support to. In 2011, CDB extended 858.5 billion yuan of loans to eight key industries, issued new loans of 429.4 billion yuan to the coal, power, oil, transportation, agriculture, forestry and water industries and supported a number of railway, power, highway and coal projects.

Water Conservancy

CDB has broken down the institutional obstacles by using innovative financing services to dissolve financial difficulties and pushed forward a leapfrog development in domestic water works. In 2011, CDB issued water conservancy loans of 30.7 billion yuan, about 30 percent of its kind issued by domestic financial institutions, and registered an outstanding loan of 147.2 billion yuan, further consolidating its leading position in water conservancy financing.

and industrial uses in cities and of great significance to the sustainable development of the old industrial base. CDB has formulated a tailor-made financing plan for the costly program with a long construction period. Since the commencement of the project in 2003, CDB has accumulatively made loans of 4.363 billion yuan.

When it was put to formal use in 2011, seven cities in central and southern Liaoning with an aggregate population of 10 million were no longer plagued by water shortfall. This is a commendable contribution of CDB to local water conservancy construction during the 12th Five-Year Period.

Electricity

In 2011, China registered a maximum power deficit of 40 million kilowatts. People's life and economic activities were seriously disrupted by power outage. To remedy the situation, CDB took the initiative to help finance the power generation industry by issuing new loans of 123.4 billion yuan. About 37.8 percent of China's power generation investment relies on CDB loans which has so far financed a variety of generating plants involving hydropower, wind power, solar energy, nuclear power, thermal power in where there is a heavy load demand, and coal-electricity joint management projects.

The Yangjiang Nuclear Power Plant in Guangdong to be installed with six one-million-kilowatt pressurized water reactor generators is the largest of its kind under construction in China, involving a total investment of 69.6 billion yuan. As the leading bank of the project's consortium loans, CDB has issued 4.7 billion yuan of RMB loans and foreign currency loans of 41.86 million euros. The project broke ground on 16 December in 2008, with the first generator designed to be put to use in 2013.

2011年,我行加大公路建设贷款力度,新增贷款 1,174 亿元,同业占比 36%,重点支持了西部综合交通枢纽工程等国家高速公路网建设项目。

Highways

In 2011, CDB increased its support to highway construction by issuing new loans of 117.4 billion yuan, which took up 36 percent of all relevant loans made by Chinese banks and mainly went to the national highway networks including the comprehensive transportation hub in the western areas.

我行牵头组建了黑龙江省历史上最大的基本建设银团贷款,累计为该省公路建设投放314亿元,支持建设高速、一级、二级及农村公路共计7万公里。

Three years ago, the expressway mileage in Heilongjiang Province was only 1,044 kms. Now the figure has exceeded 4,000 kms. Moreover, its highway mileage was extended to 14,151 kms, up 42 percent over the same period of time. Highway and expressway construction have directly pushed up the province's GDP by 126 billion yuan in the past three years, posting a direct contribution rate of 3.37 percent, indirectly generated an aggregate output of 414 billion yuan and created more than four million jobs both directly and indirectly.

CDB led the largest infrastructure consortium loan in Heilongjiang and provided a total of 31.4 billion yuan of loans to support the contruction of expressways, highways and rural roads with a total mileage of 70,000 kms.

铁路

铁路建设是我行2011年重点支持的领域。截至年末, 铁路行业贷款余额 3,489 亿元, 为上年的 3.8 倍, 重点 支持了"四纵四横"高铁、煤运通道、中西部资源开 发通道等项目。

铁路是国家重要基础设施和公共交通工具,关系到国 家的经济发展和人民群众的出行。2011年下半年,受 "7·23 温州动车追尾事件"等多种不利因素影响, 大量铁路在建项目面临资金链断裂风险。

为此, 我行以极短的时间完成了 1,000 亿元铁路专项 融资和 100 亿元铁道部贷款的发放,占全部铁路应急 贷款的一半,确保了铁路建设资金偿付、重点项目推 进及配套项目实施。

Railways are significant infrastructure, which have a direct bearing on a nation's economic and social development and public transportation. In the

Railways

CDB gave priority support to railway construction in 2011. In the end of the year, the bank's outstanding railway loans reached 348.9 billion yuan, which was 3.8 times as much as that in the previous year. These loans have been mainly extended to support highspeed trunk railroads construction, coal transportation railways and large communication facilities for resources development in central and western China.

second half of 2011, after the high-speed rail crash in Wenzhou on July 23, a raft of railway developers were faced with the capital chain disruptions.

Against this backdrop, CDB raised a special railway fund of 100 billion yuan in a very short period of time and extended another 10 billion yuan of loans to the Ministry of Railway, which took up half of the contingency loans made to the railway sector. CDB's efforts helped sustain the capital flow in railway construction and facilitated the implementation and advancement of key and auxiliary projects.

Xi'an metro line 2 started trial operation on 16 September in 2011, with the first-day passenger reaching 300,000 people. Upon its completion, the city's metro services will cover 52 major passenger transport hubs, handling 25 percent of the daily transportation demand of local residents.

The project is also of significant value to China's agricultural industrialization, quicker distribution of farm produce, broadening the distribution channels of rural households and the stability of vegetable supply.

我行"融智+融资"支持哈达湾老工业区异地搬迁 改造项目,推动东北老工业基地振兴。该项目总投资 104亿元,目前贷款余额6亿元。将原有的铁路改造 成便捷的城市公共轨道交通,将城市污水变为住宅供 暖的热源,将固态废物转化成电厂的发电燃料,让哈 达湾实现了从老工业区到低碳生态城的华丽转身。

昨天,哈达湾老工业区的辉煌仍历历在目;今日,哈 达湾正实现自己的完美蜕变;明天,哈达湾将是一个 低碳官居的生活新天地。 To help renovate the Hadawan old industrial base and boost the development of northeastern rust belt, CDB pooled both capital and wisdom. The Hadawan project cost 10.4 billion yuan in total. Currently CDB posted some 600 million yuan in outstanding loans. In this project, railways were renovated for urban rail transit while urban sewage and solid wastes were respectively turned into the source of heat supply for residential purpose and powergeneration fuels.

After this perfect facelift, Hadawan no longer settled for its past glory as the industrial base but marched forward toward a low-carbon and more livable future.

促进产业结构调整优化

2011年,我行积极推动钢铁、煤炭、水泥等产业布局调整、技术改造,支持了宁波万华技术改造等重点项目;建立战略性成长型企业识别培育和授信评审机制,全年发放战略性新兴产业贷款 2,825 亿元,支持了清华同方 LED、广州生物岛等项目。

Promote Industrial Restruction

In 2011, CDB vigorously promoted the adjustment of industrial layout and technical renovation concerning

the iron and steel, coal and cement industries, supported a number of key projects including the technical renovation project of Ningbo Wanhua Polyurethanes Co. LTD. CDB has put into place a mechanism to identify, foster and review the credit of small and medium-sized enterprises with strategic potential. In 2011, it issued aggregate loans of 282.5 billion yuan to emerging but strategic industries, including the LED project of Tsinghua Tongfang Company and the Bio-island project of Guangzhou.

Light-Emitting-Diode or LED for short is regarded as the fourth-generation lighting source that is

energy-efficient, environment-friendly, small in size and durable. Developing LED not only conserves energy but also is conducive to China's industrial upgrading.

In 2011, CDB financed the LED project of a subsidiary of Tsinghua Tongfang Co. which effectively filled the market vaccume in high-end domestically-made semiconductor lighting products, promoted national brands and secured the supply of key raw materials for China's national semiconductor lighting project.

国开行支持煤炭产业转变发展方式、调整产业结构、 实现稳定健康发展。完成了《煤炭行业系统性融资规 划》等十余项规划研究,组建了全国大型煤炭基地项 目工作组,支持优势企业开展跨地区、跨行业、跨所 有制、跨国兼并重组。

2011年以来,已成功支持煤矿企业兼并重组和资源整合类项目75个,累计发放贷款71.8亿元,位居同业首位,共整合产能8,325万吨/年,整合资源量142.5亿吨;向8省市17家煤矿企业发放41亿元瓦斯防治专项贷款;开创矿业权出让转让贷款等新模式,累计完成陕煤化、国电等16个项目;设计中长期贷款、中短期流动资金贷款等方案,为企业提供全方位金融服务。

CDB supported the colliery industry to transform their production mode and adjust industrial structure to achieve steady and healthy development. The bank has completed a dozen development plans including the Systematic Financing Plan for Colliery Industry, established a special work team for the

construction of large national coal mining bases and supported competitive enterprises to stage crossindustrial, cross-regional or even international mergers and acquisitions regardless of their ownerships.

Since 2011, CDB has financed 75 merger-and-acquisition as well as resource integration projects of the colliery industry by accumulatively extending loans of 7.18 billion yuan. The production capacity and sources integrated reached 83.25 million tonnes a year and 14.25 billion tonnes respectively. The bank has issued special loans of 4.1 billion yuan to 17 collieries in eight provinces and cities for coal gas disaster prevention. It also innovatively used the transferrable mining rights as the collateral and successfully financed 16 projects involving the Shaanxi Coal and Chemical Industry Group and the China Guodian Corporation. Through mediumand long-term loans and liquidity loans, CDB has provided all-round financial services to enterprises.

Vigorously Support the Development of Cultural Industry

Speeding up the development of cultural industry is significant to China's economic restructuring and industrial upgrading. In 2011, CDB continued to deepen cooperation with the Ministry of Culture and ten provincial-level regions including Beijing to fuse the capital market with the cultural industry. The bank posted 120.4 billion yuan in outstanding cultural loans in the end of 2011 and issued relevant new loans of 22 billion yuan last year, making itself a main force in shoring up the cultural industry.

It is gorgeous at dusk when a colorful musical fountain was operated. The park was open to the public in September 2011. During the first ten days, it has received 1.2 million tourists and attracted more than 200 cultural companies.

强化综合金融服务

Strengthen Comprehensive Financial Services

我行形成了包括国开金融、中非发展基金、村镇银行、 国银租赁及国开证券在内的投资、贷款、债券、租赁、 证券的综合金融服务架构,努力通过提供一站式综合 金融产品和服务满足中长期投融资领域客户的多元化 金融需求。

债券承销

作为国内最早探索债券承销业务的银行,国开行积极利用债券资本市场支持实体经济。2011年,我行为90多家企业主承销债券2,644亿元,推动企业直接融资;支持上海、浙江、广东、深圳等省市政府构建市场化发债模式,筹集引导各类资金投资于保障房、农业、水利、中小企业等瓶颈领域。

"新华集团已经进入资本市场,债券市场门槛高,效益也高。通过发行中期票据,在3个月内募得10亿,融资效率大大提高。事实上,我们获得的最大收获不是资金,而是开拓了一种新的融资渠道。"新华发行集团常务副总经理刘建伟说。

我行坚持规划先行,通过贷款、债券承销等多种形式 支持安徽省文化产业集团。2011年,我行创造性地通 过债券承销业务为安徽新华发行集团募集资金10亿元,该集团也成为全国发行行业首家成功发行中期票 据的文化产业企业。 CDB has established a comprehensive financial service framework consisting of the CDB Capital, China Africa Development Fund, village banks, CDB Leasing and CDB Securities, and strived to provide one-stop financial services ranging from investment, loans, bonds, leasing to securities to satisfy the diversified financial demands of clients in the sphere of medium- and long-term investment and financing.

Bond Underwriting


A spearhead in the domestic bond underwriting market, CDB vigorously supported the real economy through the debt capital market. In 2011, CDB underwrote bonds worth 264.4 billion yuan accumulatively for 90-strong enterprises and inspired enterprises to make use of direct financing. The bank also helped the authorities of Shanghai, Zhejiang, Guangdong and Shenzhen to establish a market-oriented bond issuance mechanism to raise and channel funds into the bottleneck sectors such as social housing construction, agriculture, water conservancy and small and medium-sized enterprises.

"Xinhua Distribution Group has ventured into the debt capital market where access requirements are strict and the yields are high. By issuing mediumterm notes, we have efficiently raised one billion yuan within three months. But the greatest gain of us is actually not the capital but a new tool in access to finance," said Liu Jianwei, Executive Deputy General Manager of the Xinhua National Distribution Group.

By adhering to the practice of prior planning, CDB

has supported the Cultural Industry Group of Anhui Province by various means, including loans and bond underwriting. In 2011, the bank creatively raised one billion yuan for Xinhua Distribution Group of Anhui through bond underwriting. The deal also turned the distribution group into China's first cultural enterprise to have successfully issued medium-term notes.

2011年, 国开金融有限责任公司积极推进城镇开发、 产业投资和海外业务,设立了国开城镇发展基金、装 备制造产业基金、国开国际控股有限公司等。其中, 国开国际控股有限公司的设立,标志着我行以香港国 际金融中心为起点的海外投资平台正式登陆全球资本 市场。

CDB Capital

CDB Capital dedicated itself to facilitating urban and township development, industrial investment and overseas business in 2011, and launched the Urban Development Fund, Equipment Manufacturing Fund and the CDB International Holdings Ltd.. The establishment of the International Holdings marked the bank's formal debut in the global capital markets with the international finance center of Hong Kong as its starting point.

国开四川(龙泉驿)城乡统筹发展基金,是由国开金 融与成都市龙泉驿区政府共同出资设立的全国第一支 城乡统筹发展基金。它将在未来5-10年内解决龙泉 驿全区 20 万农民的合理安置,实现"农田不减少、 农民变市民,城市新社区、城乡共融合"的城乡一体 化高级形态与区域可持续发展。

目前, 龙泉基金已启动首个农民安置项目, 33 万平米 高品质农民安置房已开工建设,我行承诺贷款17亿元。

"Farmers here will say good-bye to the days of perennial water shortage, traffic inconvenience and poor housing. They will each get a free housing of 35 square meters and a business premise of 10 square meters, as well as social insurance and a new job. They will no longer identify themselves as a farmer but an urban dweller," said Chen Zhengming, the Assistant Mayor of Chengdu.

The CDB-Sichuan (Longquanyi) Urban-Rural Coordinated Development Fund was the first of its kind jointly established by the CDB Capital and the Longquanyi District Government. In the next 5-10 years, some 200,000 rural residents would be properly relocated into a sustainable new community complete with urban facilities, making no sacrifice of local tillable land.

The first relocation program financed by CDB's Longquan Fund and involving housing placement of 330,000 square meters was started. CDB has promised to loan some 1.7 billion yuan.

China-Africa Development Fund

CDB launched China's only equity fund for Africa, the China-Africa Development Fund, in 2007. Through this key platform for China's African investment, CDB channeled 690 million U.S. dollars to Africa in 2011, with the contract investment reaching 792 million U.S. dollars, both having registered a new record high. By the end of 2011, CDB had accumulatively invested 1.1 billion U.S. dollars through the fund, overshooting its first-phase investment target of one billion U.S. dollars.

Nigeria is West Africa's biggest economy and major oil producer. The country's rapidly expanding economy has outgrown local port facilities.

In cooperation with the China-Africa Development Fund, China Merchants Group acquired a 47.5 percent stake in a container terminal of Tin Can Island, one of the three sections of Nigeria and West Africa's biggest port Lagos, at 150 million U.S. dollars in 2010.


Upon taking over the terminal's operation, the Chinese side has been promoting infrastructure construction, providing more efficient custom-clearing services and expanding cargo handling capacity. These efforts have created 400 more jobs and generated tax revenue of more than 10 million U.S. dollars for local government.

CDB Securities

CDB Securities fully tapped its collaborative advantages in corporate development planning, reorganization consultation and bond underwriting in 2011. By the end of last year, the bank had issued 11 corporate bonds, securing a market share of 4.61 percent. Depending on its professional services, CDB also developed, with government endorsement, social housing projects involving an aggregate investment of 16.57 billion yuan.

Situated in the Yangtze River Economic Belt, Yichang is dubbed as the Pearl of Three Gorges and a hydro-power city of the world.

Affected by the macroeconomic policies, investors dumped urban construction investment bonds in 2011. Despite the adverse market sentiment, CDB Securities successfully issued urban construction investment fund of one billion yuan for Yichang. It was the first bond exclusively underwritten by CDB Securities and created the so-called "Yichang Speed" for having taken the shortest time to complete the full bond-issuing procedures in Sichuan. The capital raised was mainly used to support municipal works, public rental housing and sewage plant construction and other projects of great significance to the development strategies of Hubei Province and the urban construction of Yichang.

Through sale-leaseback financing, CDB Leasing innovatively supported the public rental house construction in Qianjiang of Chongqing Municipality in 2011. It also vigorously explored the collective lease for small and medium-sized enterprises, increasing its business volume by 60 percent year-on-year, with collaborative business taking up 87%. The leasing arm of CDB has been industrial leading domestically in asset size, balance on leased assets and new leasing business volume in the end of 2011.

In 2011, it continued to consolidate its overall risk management, implemented economic capital management, strengthened risk prevention in development finance, and promoted the healthy and orderly development of financial ecology.



Support Social Housing Construction

我行积极创新保障性住房建设融资模式,破解保障性 安居工程建设资金难题,助力中低收入家庭安居乐业。

2011年, 我行发放保障性安居工程贷款 1,302 亿元, 余额新增 1.095 亿元,同比增长 155%,占全国同业份 额 63%, 累计支持了 855 个项目, 惠及 1,700 多万中低 收入人群,成为保障房建设融资主力银行,为2011年 全国 1,000 万套保障房决策的实施提供了强有力支撑。



CDB vigorously explored innovative financing methods to ease the capital constraint in social housing construction and help to improve the living conditions of middle- and low-income households.

In 2011, CDB channeled some 130.2 billion yuan in loans to social housing projects, adding 109.5 billion yuan to the relevant outstanding loans, up 155 percent from a year earlier. With a market share of 63 percent, CDB has accumulatively supported 855 projects and benefited more than 17 million middleand low-income people. It has become a leading bank financing social housing construction and given solid support to the national plan of building 10 million units of social housing in 2011.

Shanty town renovation in Jiangxi

"外面下大雨,屋里下小雨", "冬天冰窟窿,夏天 "Battling water leakage when it rains" and "Feeling 火炉子"——这是城市棚户区的真实写照。棚户区的 现状,是历史沉积的难题,由于地方财力有限,江西 省多数市县棚户区改造进度缓慢。

2011年, 我行牵头组建银团, 贷款 130亿元, 以创新 的方式支持江西省完成 1,494 万平方米城市棚户区改 造,解决14.6万户、61.6万低收入人群住房难问题, 有效推动了城市功能的完善,促进当地经济社会发展。

freezingly cold in winter and scorching hot in summer"—This is the life of those who live in the shanty town. Due to financial constraints, however, little progress had been made in the shanty town renovation, a problem left over by history in many cities of Jiangxi Province.

CDB led a bank consortium in 2011 to have innovatively provided 13 billion yuan of loans in support of the shanty town renovation in Jiangxi Province. With these loans, the province renovated 14.94 million square meters of shanty

town areas, solving the housing problems for 146,000 households or 616,000 low-income people, effectively accelerated the improvement of local urban facilities, and promoted the coordinated development in the economy and society.

2011年底,已有7,000多户家庭、2万余人入住了民心佳园公租房新居。优质的工程质量,完善的商业、生活配套,专业的物业管理和便捷的交通服务,公租房的品质和周边的商业房小区相差无几。

民心佳园公租房项目是我行重庆分行 2011 年贷款支持的 15 个保障房项目之一。2011 年,重庆分行共向保障房项目发放贷款 58 亿元,引入社保资金 45 亿元,惠及 19.63 万户困难家庭,解决了 45.42 万人的住房问题。

More than 7,000 households or 20,000-strong people have moved into the Minxin Jiayuan Public Rental Housing neighborhood in the end of 2011. With professional real estate management and sound living facilities, the well-constructed public rental housing community on an easily accessible location does not have much difference with peripheral commercial housing.

Minxin Jiayuan is one of the 15 public rental housing projects financed by CDB's Chongqing Branch in 2011. The branch accumulatively extended loans of 5.8 billion

By the end of 2011, CDB has accumulatively channeled 460 billion yuan in loans to 1,191 housing projects for the middle- and low-income households with an aggregate construction area of 380 million square meters, including social housing, shanty town renovation and rural housing placement, benefiting 6.07 million households or 19.95 million middle- and low-income people.

关注教育医疗

Contribute to Education and Medical Care

教育是民生之基础,医疗是民生之保障。2011年,我行助学贷款发放突破100亿元,市场份额达80%;中小学基础教育、高等教育、职业教育等教育贷款余额(不含助学贷款)1,114亿元;医疗卫生贷款余额223亿元,累计支持598个医疗卫生项目建设。

Education and medical care are the foundation and guarantee of the wellbeing of the people. In 2011, CDB's student loans exceeded 10 billion yuan, taking up 80 percent of the market share. Its outstanding education loans to primary and secondary schools, institutions of higher education and vocational schools reached 111.4 billion yuan (excluding student loans), while its outstanding loans to 598 medical care and public heath projects totaled 22.3 billion yuan.

推进助学贷款

截至 2011 年末, 我行助学贷款业务体系覆盖全国 25 个省(区、市)、1,695 个县(区)和 2,546 所高校, 服务网络覆盖全国广大城乡县域乃至乡镇, 学生上大 学前在家乡就可以获得贷款,包括新疆和西藏在内的 中西部 18 个省份均实现了业务全覆盖。

2011年,我行重点加强助学贷款管理信贷系统建设,各地资助管理中心建设进展明显,有效提高了助学贷款的管理能力和水平。全年新增合同187万余份,累计签订贷款合同560余万份,惠及贫困学生340余万人。

Advancing Student Loans

In the end of 2011, CDB's student loans covered 25 provincial regions, 1,695 counties or districts and 2,564 institutes of higher learning in China. In most counties or even townships, including those in the 18 central and western interior provinces such as Xinjiang and Tibet, students can obtain loans in their hometowns before they enter universities.

In 2011, CDB strengthened the student-loan credit system construction in all local education financing centers and further improved its student loan services. With 1.87 million new contracts inked last year, the bank has accumulatively signed 5.6 million student loan contracts, benefiting 3.4 million needy students.



With the provincial education financing centers as its management platforms and the student service centers at counties or universities and colleges as its operating platforms responsible for receiving student loan applications, collecting individual credit information and providing credibility training, CDB has put into place a unique student loan management platform which features top-down management from CDB, provincial financing centers, county (college) student service centers to individual students.





In the end of 2011, CDB posted 21.913 billion yuan in the outstanding loans for school building safety project and supported 16 projects in Qinghai, Shanxi, and Inner-Mongolia.



Support Small and Medium-Sized Enterprises

支持中小企业是保持经济社会稳定发展的战略举措。 截至2011年末,我行中小企业贷款余额1.55万亿。累 计支持中小企业、个体经营户180万户,创造就业岗 位超过460万个,融资支持了小型微型企业、个体工 商户、创业青年、城市下岗职工及农村劳动妇女等融 资瓶颈客户和社会弱势群体。

Supporting small and medium-sized enterprises (SMEs) is a strategic measure to maintain social

stability and economic development. CDB posted 1.55 trillion yuan in outstanding SME loans in the end of 2011, accumulatively benefiting 1.8 million SMEs and self-employed individuals and generating 4.6 million jobs. The loans mainly targeted those who either had difficulty to obtain loans or were socially disadvantaged, including small and micro-enterprises, self-employed individuals, young entrepreneurs, urban laid-off workers and rural working women.

Hao Hongfu is the owner of a small business — Xinda PVC Products Shop in Dehui City of Jilin Province. After several years of operation, his business ran into difficulty due to the lack of capital and laborers. Just when he was at his wit's end, CDB came to his rescue with a petty loan of 500,000 yuan. "This is like a timely rain. With the money from CDB, I no longer have to worry about the purchasing of raw materials and new equipment." Hao Hongfu has thus tided over his toughest days in business.

The "Business Startup Petty Loan for 10,000 People" adopted an operation model which consisted of a three-party risk-sharing mechanism, namely the financing platform, industrial associations and parks, an incentive mechanism based upon discount interest and a mechanism to timely limit losses. In the end of 2011, CDB accumulatively issued petty loans of 1.021 billion yuan, benefited 23,000 self-employed individuals and micro-enterprises and successfully created jobs for 122,000 people.



自 2008 年至今,我行已在陕西省汉中市西乡县实施了两批创业促就业小额贷款项目。第一批为席静等 19 名城镇下岗女职工提供了 44 万元小额贷款,帮助其再就业;第二批为王恩秀等 113 名农村妇女提供了 50 万元贷款,帮助其开展具有当地特色的农副产业,使她们增收致富,实现自强自立自主。

2012年3月7日,我行支持的陕西西乡妇女发展协会 荣获英国驻华使馆发起的"社会企业家技能项目资助 计划"设立的"增爱社会企业创投奖"。 By integrating the platforms of loan management, loan providing, loan guarantee and loan publicity with professional associations, CDB has provided unified loans to the targeted groups, for instance providing petty loans to rural women in Xixiang County of Shaanxi. Such efforts have made financing accessible by the most vulnerable rural women and helped them start up business and embark on the road toward a more prosperous and sustainable future.

From 2008 to now, our bank has made two batches of petty loans in Xixiang County of Hanzhong City. The first batch of 440,000 yuan helped Xi Jing and 18 other laid-off women get re-employed while the second batch of half a million yuan allowed Wang Enxiu and 112 other rural women to independently start small business on agricultural and sideline products with local speciality.

On March 7, 2012, CDB-financed Women's Development Association of Xixiang County, Shaanxi Province, won the Love-Enhancing Entrepreneurship Award for Social Enterprises sponsored by the Skills for Social Entrepreneurs, a global project initiated by the British Council.

In September 2011, CDB signed with Sunlon a cooperation agreement involving a total volume of 30 billion yuan and helped it broaden financing channel by issuing medium-term bills of one billion yuan, which marked a valuable effort in term of securing food safety, maintaining price stability and stabilizing market supply.

The project also serves as the city's alternate water source for both domestic and industrial uses and speed up the integration of local urban-rural water supply.



甘肃省泾川县是国家级新农村建设示范县。2007年, 我行发起设立了全国第一家国有银行控股的村镇银 行——泾川汇通村镇银行,5年来累计发放了3.1亿 元。该行的客户王德良开办的陇新牧业公司现有员工 36人, 年纯收入100万元左右。他担任理事长的养殖 协会, 汇集了156名村民会员, 户均年纯收入达5万元。

Jingchuan is an exemplary county in China's New Rural Construction drive. In 2007, Jingchuan Huitong Village Bank, the first of its kind controlled by a state-owned bank in China, was established. Over the past five years, the bank had issued 310 million yuan of loans accumulatively. A customer of this bank, Wang Deliang started the Longxin Animal Husbandry Company which now employs 36 people and rakes in some one million yuan a year in net income. He doubles as the director-general of an animal husbandry association which has 156 members. The net household income of each member reached 50,000 yuan on average.


应急贷款

截至 2011 年末, 我行累计发放应急贷款 163.1 亿元, 贷款余额 24.9 亿元。其中, 2011 年发放应急贷款 36.1 亿元、向河北、江苏、河南等地发放抗旱应急贷款 12.9 亿元等,为抗击自然灾害、应对突发事件提供了 快捷、高效的金融支持。

Emergency Loans

In the end of 2011, CDB accumulatively issued emergency loans of 16.31 billion yuan and posted 亿元,包括向江苏、江西等地发放抗洪应急贷款 17.2 2.49 billion yuan in the outstanding emergency loans. The newly issued emergency loans amounted to 3.61 billion yuan in 2011, including some 1.72 billon yuan in support of the flood combats in Jiangsu and Jiangxi and 1.29 billion yuan for drought prevention in Hebei, Jiangsu and Henan. These loans have provided fast and efficient financial support in case of emergencies.

2011年,持续干旱使河南受旱小麦面积多达 2,700 多万亩,对粮食增产丰收造成严重威胁。我行迅速启动应急预案,向郑州、新乡等 11 个受灾严重地市派出工作组,发放抗旱应急贷款 5.6 亿元,支持受灾地区打井取水、管渠修缮以及灌溉机械购置等,惠及农田1,300 余万亩,有力支持了抗旱保丰收。

Lingering drought damaged 27 million mu of wheat in Henan and posed a severe challenge to local grain crop production in 2011. On hearing the news, CDB rapidly activated its emergency plans, dispatched 11 work teams to the worst hit regions including Zhengzhou and Xinxiang and issued emergency loans of 560 million yuan in support of well digging, water pipe repairs and the purchase of irrigation equipment. More than 13 million mu of farmland has been saved.

Poverty Alleviation in Designated Areas

Poverty elimination is a key task of the Millennium Development Goals of the United Nations. In 2011, CDB continued to use lending as its main tool to support poverty alleviation and donation as a supplement. Last year, the bank arranged credit capital of 167 million yuan and donated another 5 million yuan to support seven designated poverty-stricken counties, including Shucheng and Yu'an of the Anhui Province, to build up their capacity for independent development.

With the endorsement of the State Council, Bijie Experimental Zone (BEZ) was established in 1988 to explore poverty alleviation through development and ecological construction. CDB started to support BEZ through development finance in 2007 and has

been focusing on institutional building since then to reduce the zone's dependency on external help so that it could get rid of poverty by itself. The major measures we've taken are as follows.

Eliminating poverty through ecological construction based on sound development plans. CDB has provided planning consulting, complete with financing plans, on desertification control, resident relocation and the return of farmland for lake in Weining Caohai Wetland Reserve.

Innovating on institutional building to facilitate poverty alleviation and support governmental projects by market-oriented means. In 2011, CDB extended loans of 368 million yuan for urban construction, industrial loans of 281 million yuan and public rental housing loans of 73 million yuan. The bank also supported Bijie City to boost its tourism industry, specialty farming such as potato cultivation and medical equipment procurement.





"We have been financially strapped for many times. But with the support of CDB and the China-Africa Development Fund, we have obtained relevant

operation qualifications in nearly 10 African countries," said Pang Xinxing, chairman of the StarTimes Communication Network Technology.

In December 2011, CDB, the China-Africa Development Fund and StarTimes agreed to jointly establish wireless digital TV platforms in Africa. StarTimes has so far opened more than 60 channels for 900,000 subscribers. In next five years, its subscribers are expected to reach 7 million while its TV signals may cover 600 million African people. Such cooperation will not only promote Sino-African cultural exchanges but also enrich the cultural life of local residents.

Support Enterprises to "Go Global"

In response to the government's call for enterprises to "go global", CDB supported competitive Chinese enterprises to tap the global market and outsource their production and transfer their technologies and laborers in an orderly manner. In 2011, CDB financed many enterprises including power company Goldwind and auto service provider Shou Qi Group to explore the American and European markets.

By the end of 2011, CDB has extended a line of credit of 19.6 billion yuan (including 777 milion U.S. dollars) in total to the leading engineering machinery maker Sany Heavy Industry as well as its subsidiaries and lend customers through medium- and long-term loans, working capital loans and finance lease. Apart from capital support, the bank also provided Sany consulting services on financing plans to facilitate the company's industrial upgrading and improve international competitiveness.

With the support of CDB, Sany has put its American and German manufacturing bases into production. As the quality of these products is widely recognized, Suny has further elevated its competitiveness in European and American markets and created muchneeded jobs.





The plant, situated in Tema City of the Greater Accra Region of Ghana, has a designed generation capacity of 200 MW for the first-phase construction, equivalent to nearly one-sixth of the country's total power supply, and plays a vital role in easing the power shortage of Ghana and the West Africa at large. It also created a raft of jobs for local community and solidly supported Ghana's economy.

支持农业发展

加快农业产业的健康发展是许多国家经济发展和社会稳定的迫切需要。2011年,我行合作完成了俄罗斯、乌克兰等6国农业资源开发规划,累计完成了覆盖非洲、南美25个国家的农业专项规划,与数十家农业龙头企业建立了战略合作关系,支持当地农业发展。截至2011年底,共贷款支持58个农业国际合作项目,累计贷款承诺额约53亿美元、发放额约21亿美元,支持了包括埃塞俄比亚肯色(Kesem)糖厂建设项目、阿根廷大豆生产等多个项目。

赞比亚盛产棉花,全境棉花种植面积12万公顷,但是一直以来由于技术落后、棉种退化等限制,棉业发展缓慢,棉农收入受到影响。

国开行与旗下中非发展基金投贷结合协同支持,组建了中非棉业赞比亚分公司,集棉花种植、加工、销售以及棉油提炼为一体,拥有2个棉花加工厂,年生产加工能力57,000吨,所加工的棉花质量已达国际先进水平。该公司的成立,带动了赞比亚棉花产业的发展,为当地直接创造2,000多个就业机会,间接带动35,000户农民收益,为促进非洲农业发展做出了重要贡献。

Facilitate Agricultural Development

Building a healthy and booming agricultural industry is a pressing task of many countries hoping to secure social stability and boost economy. CDB completed agricultural resources development plans for six countries including Russia and Ukraine in 2011 and has so far finished agricultural plans for 25 African and South African countries. By the end of 2011, CDB had promised to extend loans of 5.3 billion U.S. dollars to 58 international agricultural projects. The loans had amounted to 2.1 billion U.S. dollars and benefited a number of projects including Ethiopia's Kesem Sugar Plant and the soybean production in Argentina.

With 120,000 hectares of cotton fields, Zambia has been the world's major cotton producer. Due to backward technology and seed deterioration, however, Zambian cotton industry has been growing sluggishly and thus caused not much improvement in cotton growers' income.

Relying upon CDB loans and the investment of CDB affiliate China-Africa Development Fund, China-Africa Cotton Development Limited set up a subsidiary in Zambia to engage in cotton cultivation, processing, distribution and cottonseed oil extraction. The subsidiary's two factories have a combined annual processing capacity of 57,000 tonnes, and the quality of processed cotton is among the world's best. More than 2,000 jobs have been created locally and 35,000 rural households benefited from the new subsidiary.

中德中小企业发展专项贷款

2011年6月28日,《中华人民共和国与德意志联邦共和国首轮中德政府磋商联合新闻公报》宣布,"由中国国家开发银行提供总额20亿欧元的专项贷款,为两国中小企业的合作提供资金支持"。

我行通过设立 20 亿欧元中德中小企业发展专项贷款,推进两国中小企业合作,助力解决就业,促进中小企业结构调整和产业升级。2011年,我行发放中德中小企业贷款 2.09 亿美元,有力支持了我国企业在精密机床、汽车零配件等行业的跨国并购。

Special Loan for Chinese and German SMEs

China and Germany issued a joint press communique following their first-round inter-governmental consultation on June 28, 2011, announcing that China Development Bank would extend a 2-billion-euro special loan for small and medium-sized enterprises of both countries.

By setting up the special loan, CDB dedicates itself to facilitating the cooperation between the Chinese and German SMEs, boosting employment and promoting the restructuring and upgrading of SMEs in both countries. In 2011, the bank issued 209 million U.S. dollars of SME loans to finance the cross-border merger and acquisition by Chinese enterprises in the sectors of precision machine tools and auto spare parts.

Chongqing Light Industry and Textile Holding Group took over Germany's SaarGummi Group with the support of a CDB loan of 34.4 million euros, becoming the first Chinese enterprise to have successfully acquired a German automobile part supplier. The transaction helped SaarGummi's 4,300-strong employees retain their jobs and boosted the Sino-German economic and technological collaboration.

Special Loan for African SMEs

In the end of 2011, the bank has promised to grant 774 million U.S. dollars of aggregate loans to the SMEs in 29 African countries and posted an outstanding loan of 262 million U.S. dollars. The arrangement has so far created 10,200 jobs, indirectly benefited 390,000 farm and herding families and generated Sino-African trade volume of 311 million U.S. dollars. The special loan has evolved into a significant means to benefit African people at the grass-roots level, stabilize African employment and bolster African market and economy.







发展可持续能源

Develop Sustainable Energy

能源是连接经济社会发展和环境保护的一条"金线"。 国开行坚持以金融资源配置引导能源结构优化调整, 为新能源产业提供全方位金融产品和服务,并重点支 持可持续能源发展、促进碳排放降低。

2011年,我行严格控制向高能耗、高污染项目提供贷款, 重点支持水电、风电、太阳能发电等清洁可再生能源 项目和赛维 LDK、英利集团等可持续能源龙头企业。 截至 2011 年末,累计发放水电贷款 3,759 亿元,约占 全部水电投资的 25%,覆盖全部大型水电项目;累计 发放风电、太阳能发电、生物质能发电行业贷款 1,149 亿元,支持项目装机容量 1,500 多万千瓦,占比三分之 一以上。

Economy and environment are the two sides of the energy coin. CDB continues to improve energy structure through the allocation of financial resources, provides all-round financial products and services to

the new energy industry and gives priority support to the development of sustainable energy to curb carbon emission.

In 2011, CDB put strict restrictions on loans for energy-consuming and heavily polluting projects, favored clean and renewable hydro power, wind power and solar energy, and gave priority to the financing demand of leading sustainable energy enterprises including LDK Solar and Yingli Green Energy. By the end of 2011, it had issued loans of 375.9 billion yuan accumulatively for hydropower projects, which took up 25 percent of China's total hydropower investment and covered all large projects. The bank also supported more than one third of China's investment in wind, solar and biomass power generation with an aggregate industrial loan of 114.9 million yuan, involving a combined installed capacity of 15 million kilowatts.

光伏电站 Photovoltaic power station

中国广东核电集团有限公司是我国清洁能源的重要供 应商。我行积极支持其发展太阳能、风电等可再生能 源,累计为其太阳能项目承诺贷款15亿元,发放贷 款逾12亿元。在我行融资支持下,该公司已投运11 万千瓦光伏电站项目,并积极开发海外太阳能及生物 质能发电项目。

我行还是中国一次性建设规模最大的风电项目——中 广核内蒙古宏基30万千瓦风电项目的贷款牵头行, 按火电每千瓦时电量消耗 380 克标准煤计算,该项目 每年可节约标准煤 276,439 吨,减少烟尘 2,520 吨、 CO₂ 208,960 吨、SO₂ 5,760 吨、废渣 36,000 吨。

Guangdong Nuclear Power Group is China's leading clean energy supplier. CDB vigorously supported the company to develop renewable solar and wind power. It promised to lend 1.5 billion yuan for its

solar power project, of which more than 1.2 billion yuan had been made. With the financial support from CDB, the company has put an 110,000-kilowatt photovoltaic power station into operation, and actively tapped overseas solar and bio-mass power generation projects.

CDB led the consortium loan to the group's HongJi Wind Farm in Inner Mongolia, China's biggest single investment in term of wind power generation with an installed capacity of 300,000 kilowatts. Compared to thermal power plant which normally consumes 380 grams of coal equivalent to generate one kilowatt hour of electricity, the wind farm can save 276,439 tonnes of coal equivalent, avoid emitting 2,520 tonnes of dust, 208,960 tonnes of carbon dioxide, 5,760 tonnes of sulfur dioxide and 36,000 tonnes of solid wastes every year.

至龙口河段末端,是万家寨水利枢纽的配套工程,水 库总库容1.96亿立方米,电站总装机容量为42万千瓦, 年均发电 13.02 亿千瓦时。

2007年7月18日, 我行与新华水利水电投资公司 就该工程项目签订人民币中长期贷款合同,合同金 额 27,000 万元。截止 2011 年 10 月底, 贷款余额为 25.800万元。

黄河龙口水利枢纽项目,位于黄河中游北干流托克托 Longkou Water Conservancy Project across the northern main stream linking Togtoh with Longkou in the middle reaches of the Yellow River is a supporting project of the Wanjiazhai Water Conservancy Project, with a water storage capacity of 196 million cubic meters, an installed power generation capacity of 420,000 kilowatts, and a yearly average electricity production of 1.302 billion kilowatt hour.

> On July 18, 2007, CDB agreed to extend 270 million yuan of medium- and long-term loans to Xinhua Hydropower investment. In the end of October 2011, CDB posted 258 million yuan in relevant outstanding loans.

支持节能减排

Support Energy Conservation and Emission Reduction

国开行积极支持企业节能改造工程。2011年,重点支持了锅炉改造、建筑节能等一系列节能改造工程,如新疆乌鲁木齐城市燃煤锅炉拆并工程、燃煤电厂综合升级改造和安吉节能环保设备租赁项目等,全年发放节能重点工程贷款204亿元。

CDB supported the energy conservation transformation of enterprises with an aggregate loan of 20.4 billion yuan in 2011, involving a number of projects including the removal of coal-fired boilers in Urumqi City of Xinjiang, technical upgrading for coal-fired thermal power plants and the leasing of energy-efficient equipment by Anji Leasing.

天然气是低碳、高效、安全的清洁能源,具有经济、 环保、热效率高的特点。我行信贷支持了江苏苏北首 个天然气发电项目——国信淮安 2×180MW 级燃机热 电联产工程。该项目总投资 14亿元,我行贷款承诺 11.4亿元。

工程投产后,将淘汰供热范围内近60台小锅炉,满足淮安楚州城区工业、商业、民用采暖需求,对改善区域环境、深化节能减排、优化电网结构、缓解电网和天然气管网调峰压力具有积极的意义,对淮安市实施新能源和清洁能源建设将起到良好的示范作用。

Natural gas is a clean energy safe and efficient to use. CDB has promised to finance the first natural gas power plant in northern Jiangsu Province, the Guoxin Huai'an 2×180 MW combined heat and power project with a loan of 1.14 billion yuan. The project's total investment is 1.4 billion yuan.

Upon its completion, the gas-fuled plant will replace nearly 60 small boilers to supply heating to the Chuzhou District of Huai'an for industrial, commercial and domestic uses. It is examplary in the use of clean energy, conducive to improving local environment and boosting energy conservation, and allows an integrated use of the power grid and gas pipeline network to ease rush-hour demands.

治理工业污染

Industrial Pollution Treatment

我行以"减量化、再利用、再循环"为目标,大力支持工业企业污染治理和资源循环利用项目。2011年,重点支持了青海、甘肃等国家级循环经济示范区的建设和发展。

Sticking to the goal of "reduction, reutilization and recycle", CDB vigorously supports industrial pollution treatment and the recycling of energy and resources. In 2011, Qinghai and Gansu established state-level recycling economic zones with the financial support of CDB.

重庆钢铁集团是具有百年历史的大型钢铁企业,同时也是重庆主城区重要污染源之一。

2007年启动的重钢环保搬迁,是继首钢之后中国钢铁工业第二家实施环保搬迁的大型企业。我行于 2009年向重钢授信 111.5亿元用于项目实施,环保搬迁后,重钢集团吨钢能耗由搬迁前 676公斤标准煤下降到 611公斤标准煤,降幅 10%;污染排放大幅降低,新区 SO₂排放平均值为 0.043mg/m³N,只有原厂的 40%。

Chongqing Iron and Steel Group is a 100 year-old large steel enterprise and a major source of urban pollution at the municipality's downtown area.

It is also China's second large iron and steel enterprise after the Shougang Group to have started relocation for environmental protection. CDB provided a loan of 11.15 billion yuan to Chongqing Iron and Steel in 2009 to facilitate its relocation started in 2007. After the relocation, the company consumes 611 kilograms of coal equivalent to produce one tonne of steel, down 10 percent from the previous 676 kilograms of coal equivalent. Its sulfur dioxide discharge now averages 0.043mg/m³N, only 40 percent of the previous discharge.

东北特钢集团大连基地环保搬迁项目是国家振兴东北 老工业基地的项目之一。项目建成后,将成为当今世 界最先进水平、最具竞争力、品种最全、精度最高、 质量最优的精品特殊钢材生产基地。截至目前, 我行 为该项目累计综合授信75亿元,累计实现发放贷款 60 亿元和滚动发行短期融资券 14 亿元。

该项目用于环境治理、节能措施的投入达10多亿元, 实现烟气排放浓度低于 50mg/m³ 以下, 达到欧洲国家 先进标准; 水的重复利用实现"零排放"目标; 年可 节约用煤30万吨以上,成为优质、低耗、高效、清 洁的现代化特殊钢企业。

Relocating Dalian manufacturing base of Dongbei Special Steel Group is one of the national projects aimed to rejuvenate China's northeast old industrial base. The newly established plant is a world-leading special steel production base capable of producing a variety of most competitive products of the finest quality. CDB has extended a comprehensive line of credit of 7.5 billion yuan accumulatively to the project, including an aggregate loan of 6 billion yuan and a short-term financial bill rollover to the tune of 1.4 billion yuan. Dongbei Special Steel Group has invested more than 1 billion yuan in environmental treatment and energy conservation. The dust concentration of its flue gas now falls below 50 mg/ m³, up to the world-leading European standards. Discharging no wastewater and sparing more than 300,000 tonnes of coal a year, the plant has turned into a clean, highly efficient, energy-saving modern special steel maker.

推进环境综合治理

Promote Comprehensive Environmental Treatment

国开行通过支持流域、城市环境综合治理, 促进水资 源的保护、存续和使用, 使经济社会发展与水资源相 协调。截至2011年末,流域、城市环境综合治理贷款 余额 2.195 亿元。

CDB has applied itself to supporting watershed and urban environmental treatment and boosting water resources protection. In the end of 2011, CDB's outstanding loans for comprehensive environmental treatment amounted to 219.5 billion yuan.

2011年,我行重点支持了长江中下游、太湖、滇池等 重点流域水污染防治项目,与环保部、发改委等五部 委联合下发《关于印发 < 长江中下游流域水污染防治 规划(2011-2015)>的通知》,推动解决长江中下游 流域水环境、饮用水水源和生态安全问题。

Support Key Watershed Treatment

It also joined five ministerial departments including the Ministry of Environmental Protection and NDRC to release the Water Pollution Prevention and Treatment Plan for the Middle- and Lower-reaches of Yangtze River (2011-2015) in an effort to improve local water environment, protect drinking water sources and strengthen ecological security.

The sprawling aquaculture farms have been cutting into the aquatic life on the eastern waters of Taihu Lake in Wujiang City of Jiangsu Province for nearly a decade. They also caused an increasingly serious siltation problem and damaged local water environment.

CDB financed a comprehensive environment treatment project in this watershed with an aim

of stimulating economy, improving ecology and strengthening flood-preventing facilities. By the end of 2011, CDB has accumulatively provided 973 million yuan of loans to the project, with 495 million yuan granted last year, and posted an outstanding loan of 522 million yuan. Thanks to the support of CDB, the environment and flood-preventing capacity of the Taihu Lake have both improved. People say the pearl to the south of Yangtze River shines again.

Support Comprehensive Treatment of Urban Environment

In 2011, CDB helped a number of regions including Jiangxi, Guangxi and Shenzhen to improve their sewage disposal facilities and supported the low-carbon development of Suzhou Industrial Park and the Taihu New District of Wuxi City.

2007 年广西自治区仅有 10 个污水处理厂、13 座生活垃圾无害化处理设施。我行创新投融资模式,承诺 70 亿元专项贷款集中支持广西全区城镇污水生活垃圾处理设施建设。

截至 2011 年末,累计发放 44.77 亿元贷款,支持了覆盖全区所有市县的 103 个污水垃圾处理设施建设项目,支持广西成为西部地区第二个县县建成污水处理厂的省区,城镇平均污水集中处理率、垃圾无害化处理率均超过 60%,为广西打造秀水青山新环境做出了突出贡献。

Guangxi Zhuang Autonomous Region had only 10 sewage-processing plants and 13 pollution-free domestic waste disposal facilities in 2007. CDB used innovative financing methods to grant the region a special loan of 7 billion yuan, helping it renovate domestic waste and sewage disposal facilities.

By the end of 2011, the bank had issued an aggregate loan of 4.477 billion yuan to finance the

region's 103 relevant projects. Guangxi thus has become the second western provincial region to have had sewage treatment facilities available in all its counties. Currently, more than 60 percent of the region's urban sewage has been put to concentrated disposals while the proportion of its urban domestic wastes subject to pollution-free treatment also exceeded 60 percent.

Adhere to Green Operation

国开行大力推行绿色运营,将环保节约理念融入日常运营的全过程。从纸、电、水的节约使用,到建设绿色数据中心,推行视频会议减少公务旅行,全面减少碳排放,降低自身运营的环境影响。

CDB vigorously promotes green operation, and has incorporated the concepts of environmental protection

and energy conservation into the entire process of its day-to-day operation. The bank strives to reduce its environmental footprints by saving paper, power and water, establishing a green data center, facilitating video conferences to avoid unnecessary business travels and curbing carbon emission by all possible means.

2011年,我行正式成立由行领导任组长的国家开发银行节能节约工作领导小组,定期发布《"节能节约" 工作简报》,全面推广绿色办公。

Boost Green Office

In 2011, CDB installed a management panel headed by the bank leader to supervise in-house energy conservation and emission-reduction, and regularly released briefings on the latest developments of this work to boost green office.

LEED 金级预认证证书 LEED Gold Pre-certification

国开行厦门分行办公楼,在建设中高度重视环保、节能,项目按照绿色建筑标准设置了低碳、节能、节水、节材、环保的设计及技术,并于 2010 年获得了 LEED-CS 金级预认证。

项目采用抗震性能极佳的全钢结构,降低了施工对周边环境的污染及能源的消耗;采用安装精度高,抗震性能好的全单元式玻璃幕墙系统,能阻挡65%以上的辐射热及99%以上的紫外线;设置雨水、空调冷凝水回收及中水处理系统,采用节水洁具实现一般性日常用水减少30%,利用喷灌技术实现景观用水减少50%;采用纳米光子除臭装置,设置专用回收品集散地,用来分类、收集和储存各类无危险物质。

CDB Xiamen Branch's office building has obtained the 2010 pre-certification at the Gold level for Leadership in Energy and Environmental Design for Core and Shell (LEED-CS), an internationally recognized benchmark for green building, for having attached great importance to environmental protection and energy conservation during the construction and for having adopted environment-friendly designs and technologies to save energy, water and raw materials.

Adopting earthquake-proof full-steel structure for its office building, the bank has managed to minimize the energy use during the construction as well as the impacts of its construction debris to peripheral environment. The building's full earthquake-proof glass curtain wall can absorb 65 percent of radiant heat and more than 99 percent of ultraviolet lights. Its daily water consumption falls by 30 percent because of the use of water-efficient toilets and a water-recovery and reclaimed-water processing system that can recycle rainwater and air conditioner condensation. The use of sprinkling irrigation technology has resulted in a 50-percent decline in water consumption for greening and landscaping. A nanophotonic deodorization device and special recycling stations have been installed for the collection, classification and storage of nonhazardous solid wastes.


Facilitate the Use of Video Conference

CDB's high definition video conferencing systems have covered all its domestic affiliates and the overseas branches in Cairo and Moscow. In 2011, the bank convened 424 video conferences, approximately avoiding 130,000 business trips involving an aggregate flight mileage of 260 million kilometers, which otherwise would produce 23,700 more tonnes of carbon emissions.

建设绿色数据中心

作为银行经营跳动的心脏,数据中心的能源消耗较大。 在新数据中心的建设中, 我行积极采用绿色的理念和 技术,保证数据中心既安全高效,又绿色节能。在采 取节能减排措施后,新数据中心的 PUE 值(数据中心 的输入电能与 IT 设备消耗电能之间的比值)将从现有 数据机房的2降低至1.82、接近世界一流数据中心的 水平。





在供电系统设计方面,采用了10KV高压柴油机组、 电过程中的损失降低约 20%;

For power supply, a 10 KV high-pressure diesel generator and high-frequency uninterruptible power supply (UPS) equipments with a high input power factor of 0.99 were installed, which would cut the power losses in transmission by 20 percent.

Build Green Data Center

Being the central nerve system of a bank, data center is energy consuming. CDB therefore adopted green technology to guarantee the safe, efficient and environment-friendly construction and operation of the new center. It's estimated that the new center's power usage effectiveness, the ratio of total amount of power used by a computer data center facility to the power delivered to computing equipment, will drop from the present 2 to 1.82, close to the world-leading level.

> The center also adopted the advanced chilled water air conditioning units (Coefficient of Performance close to 6) and the free cooling technology, which were expected to raise cooling efficiency by 30 percent to 40 percent.







为强化青年员工开发性金融理念,了解国情、民情,提高基层金融工作能力。2011年,我行组织开展了"青年农村金融服务行动"。发动青年员工深入田间地头,围绕农村水利基本建设、农村饮水工程、农村危房改造、中小企业融资等一系列社会热点和我行业务发展重点,成立课题研究小组和青年突击队,全年参与调研1,465人次,与当地农民同吃同住同劳动914人次。

To promote an in-depth understanding of the development finance concept among the young employees, CDB launched the campaign of Youth

on the Move for Rural Finnancial Services in 2011, mobilizing young employees to go to the rural to conduct field surveys on a range of hot social issues and CDB's priority agenda, such as rural water conservancy construction, rural drinking water supply, renovation of dilapidated rural houses and SME financing. In 2011, a total of 1,465 employees participated in grass-roots surveys. Of the total, 914 had stayed in the rural, dining and working together with farmers.

By establishing an innovation evaluation and credit accumulation mechanism, CDB keeps motivating its employees to innovate on financial services and products. In 2011, the bank's 350 employees won credits for having contributed to key projects while another 1,268 employees accumulated credits for having made significant innovations.

The bank also took care of the employees with special difficulties in their life, mapped out the 2011-2015 work plan on the care and management of retired employees and set up three community recreation centers for the retired. The employee satisfaction rate of CDB was 87 percent in 2011.



Because of the credit curb in 2011, Guangdong Communication Group was hit by capital constraint and could not advance its expressway construction as scheduled. The close cooperation between CDB and Xinyuan raised the latter's visibility in the financial industry and helped the latter open up the Beijing market. Xinyuan later provided technical support for the construction of the cfcpn.com, a collective procurement web site for the financial industry under the People's Bank of China. This case epitomizes CDB's will and efforts to grow with its suppliers for win-win results.



All CDB employees have received integrity training and committed themselves to clean and honest operation while the bank tightened its control by monitoring the corruption-prone posts and business, and imposing serious penalties to the perpetrators. In 2011, the bank received 19 complaints (including one from the previous year), and closed 89 percent of them. Three employees were punished for violating the Party and administrative disciplines.

In 2011, apart from putting all its loan projects under such joint supervision, CDB conducted random onsite audits over 959 projects, ferreted out 137 problematic cases involving an aggregate value of 26 billion yuan. About 99.1 percent of them or 136 projects have been rectified.

我行组织开展"12·4 反洗钱法律法规宣传日"活动,通过多种形式向员工和客户宣传、介绍防范洗钱风险工作的相关知识和内容,增强了员工及客户的反洗钱意识,提高了我行反洗钱工作的影响力。我行风险管理局、辽宁分行风险管理处、四川分行风险管理处被中国人民银行授予全国反洗钱工作先进集体称号,刘萱等六位同志被授予全国反洗钱工作先进个人称号。



Prevent Money Laundering

CDB seriously implements its anti-money laundering responsibilities by actively assisting money-laundering investigation, monitoring suspicious transactions and enhancing anti-money laundering abilities. In 2011, the bank reported three suspicious transactions to the China Anti-Money Laundering Monitoring and Analysis Center and organized 93 anti-money laundering training courses for 4,916 participants.

On December 4th, the National Day for the Publicity of Legal System, CDB organized a special campaign to spread the legal knowledge of anti-money laundering among both employees and its clients to raise anti-money laundering awareness and build up anti-money laundering capacity. CDB's Sichuan Risk Management Bureau and the Risk Management Divisions of Liaoning and Sichuan Branches were awarded the national title of Excellent Anti-Money Laundering Groups by the People's Bank of China; and six employees, including Liu Xuan, won the prize of Excellent Anti-Money Laundering Individual in China.

We have been engaged by the Directors of China Development Bank Corporation (the "Bank") to perform a limited assurance engagement on the selected key data as at 31 December 2011 and for the year then ended as defined below in the 2011 Social Responsibility Report (the "SR Report").

We have also been engaged to gain an understanding of the Bank's application of the AA1000 AccountAbility Principles Standard (AA1000APS (2008)) of inclusivity, materiality and responsiveness ("the AccountAbility Principles") with respect to stakeholder dialogue.

Directors' responsibilities

The Directors are responsible for the preparation and presentation of the selected key data in accordance with the basis as set out in the Reporting Guidelines, the definitions of key data in the Appendix of Glossary and the note to the table of key data of the SR Report (the "basis of reporting"). This responsibility includes designing, implementing and maintaining internal control relevant to the preparation and presentation of the selected key data; and making estimates that are reasonable in the circumstances.

In addition, the Directors take responsibility for the Bank's adherence to the AccountAbility Principles.

Practitioner's responsibilities

Our responsibility is to express a conclusion on the selected key data in the SR Report based on our work performed. We report our conclusion solely to you, as a body, in accordance with our agreed terms of engagement and for no other purpose. We do not assume responsibility towards or accept liability to any other person for the contents of this report.

We conducted our work on the selected key data in accordance with the International Standard on Assurance Engagements 3000 "Assurance Engagements Other Than Audits or Reviews of Historical Financial Information". This Standard requires that we comply with ethical requirements and plan and perform the assurance engagement to obtain limited assurance as to whether any matters have come to our attention that causes us to believe that the selected key data as at 31 December 2011 and for the year then ended in the SR Report is not prepared in all material respects in accordance with the basis of reporting.

Committee, Party Committee, Administration Management Department, Retired Staff Department, Experts Committee, Client Service Management Center that are involved in providing information for inclusion in the SR Report in relation to the selected key data;

- 2. At Head Office of the Bank, examination, on a test basis, of documentary evidence relating to the key data on which we report; and
- 3. At visited Branches, interviews with management and personnel involved in providing information for inclusion in the SR Report in relation to the selected key data, and examination, on a test basis, of documentary evidence relating to the key data on which we report.

Our work was limited to the selected key data as of 31 December 2011 and for the year then ended in the SR Report. We have not performed any procedures over other data included in the SR Report for 2011, nor have we performed any procedures on other data or data prior to 2010. In addition, our work performed was not for the purpose of expressing an opinion on the effectiveness of the Bank's internal controls.

Conclusion

Based on the limited assurance work which we have performed, nothing has come to our attention that

causes us to believe that the selected key data as at 31 December 2011 and for the year the ended has not been prepared, in all material respects, in accordance with the basis of reporting.

Supplementary observations

We have also gained an understanding of the Bank's application of the AccountAbility Principles with respect to stakeholder dialogue by making inquiries and holding interviews with management representing the different functions in the Bank in respect of the Bank's application of the principles of inclusivity, materiality and responsiveness in the preparation of the SR report. Our work was restricted to gaining an understanding of the Bank's application of the AccountAbility principles and hence we do not express any assurance opinion as to whether the Bank has adhered to the AccountAbility Principles.

We have the following observations: Inclusivity

The Bank has established its social responsibility management system focused on "Enhancing national strength and improving people's livelihood", and has compartmentalised its social responsibility commitments into six areas: (strengthening responsibility management; serving national strategies; commitment to inclusive finance; implementing global responsibilities; tackling climate change; and building social harmony) through its

development finance activities. The Bank has also been integrating social responsibility into its business operations and corporate strategies. Departments of the Bank, including those departments of the four branches we visited this year, have developed processes to identify key stakeholders most relevant to their operations, and have established stakeholder engagement channels and mechanisms to collect expectations from internal and external stakeholders.

In additional, the development finance nature of the Bank has enabled the Bank to consider both social and environmental benefits as well as stakeholder expectations and impact while defining corporate strategy, developing new products and company policies.

We suggest the Bank to more fully utilize the stakeholder engagement mechanisms which the Bank has established to further identify and analyse stakeholder expectations and to further promote the Bank's social responsibility activities.

Materiality

During 2011, the Bank introduced key social responsibility performance indicators into its performance appraisal system to provide incentives to staff to promote social responsibility and to further integrate social responsibility into the Bank's

operational management systems. With regard to the information disclosed in the SR Report, the Bank has considered economic, social and environmental impacts collectively according to government policy guidelines and the principles of the Triple Bottom Line, and has assessed the materiality of relevant information. The Bank has organised a series of training and capacity building activities around sustainable development and social responsibility to further improve the Bank's capability to identify and assess the materiality of social responsibility issues.

We suggest the Bank to use the quantitative information collected by the social responsibility indicator systems to guide the identification, evaluation and reporting of key social responsibility issues with regard to the Bank and its key stakeholders.

Responsiveness

In 2011, the Bank has actively responded to the key stakeholder expectations within its "six key responsibility areas" and promoted its social responsibility philosophy through its "prior planning" strategy.

In addition, during 2011, the Bank has collaborated on domestic and international initiatives, high-level conferences and international symposiums around sustainability and social responsibility to provide perspectives and reflections from China and to push the social responsibility agenda forward together with its domestic and international peers.

Global Compact LEAD: a high-level corporate sustainability leadership platform launched by the United Nations Global Compact and participated by leading member enterprises of the Global Compact seeking sustainable development.

Two basics and one pillar: "two basics" refer to the infrastructure and the basic industries, while "one pillar" refers to the country's pillar industry.

Strategic emerging industries: In 2010, the Chinese Government identified seven strategic emerging industries, namely energy-saving and environment-friendly industries, new-generation information technologies, bio-technology, high-end equipment manufacturing, new energies, new-materials and new-energy vehicles.

Small- and medium-sized enterprises: as defined by the Ministry of Industry and Information Technology in a classification standard issued in 2011.

San Nong: namely farmers, rural areas and agriculture. In Chinese, these three issues are generally referred to the San Nong issues.

Student loans: CDB's student loans include loans granted at students' hometowns and loans granted in the colleges where the students study. Both of them target financially-strapped students pursuing higher education who may apply for loans either at their home towns or after entering colleges.

Emergency loans: referring to short-term loans due in no more than one year granted by CDB in emergency response to help local governments, key enterprises or governmental departments to cope with contingencies before the arrival of government's disaster relief funds or the affected institutions or enterprises resumed their normal operation.

Two highs and one surplus enterprise: "Two highs" refers to high-pollution and high energy-consuming enterprises, and "one surplus" refers to resource-intensive enterprise.

Ten major energy-saving projects: refers to the projects with regarding to energy conservation and oil replacements, renovation of coal-fired industrial boilers, regional combined heat and power generation, surplus heat and pressure utilization, energy conservation of motor system, power systems optimization, environment-friendly building, green lighting, energy conservation in governmental departments, energy-saving monitoring and technical services.

Loans to Central and Western Areas: refers to loan projects situated at the central and western China. In line with the relevant governmental regulations, the central and western areas include Shanxi, Jilin, Heilongjiang, Anhui, Jiangxi, Henan, Hubei, Hunan, Inner Mongolia, Guangxi, Chongqing, Sichuan, Guizhou, Yunnan, Tibet, Shannxi, Gansu, Qinghai, Ningxia and Xinjiang.

households: Housing for low-and middle-income households are organized by the Chinese government or constructed with the input of social forces, with an aim to ease the housing difficulty facing low-and middle-income households. Such housing is available for purchase or lease. CDB's housing loans to low-and middle-income households refer to lending for the development and construction of such housing and their supporting facilities, home purchase by local governments according to relevant regulations

for low-and middle-income households and the

areas.

Environmental impact assessment for loans: To secure administrative approval for a loan, every project must be evaluated in line with China's Environmental Impact Law and No. 5 and No. 2 Decrees of the Ministry of Environmental Protection which specify the approving procedures and management methods respectively.

Loans for environmental protection, energy conservation and emission reduction: refers to loans for projects in the following three categories:

Watershed and urban environmental treatment: which include comprehensive regional environmental treatment, water pipe construction, non-point source pollution control, urban sewage disposal and recycling, recycling and pollution-free treatment of urban domestic wastes, disposal of hazardous and

medical wastes, urban atmospheric environmental protection, urban ecological environmental restoration and greening.

Industrial pollution treatment and recycling economy: which include industrial pollution treatment, clean production, flue gas desulfurization of coal-fired

power plants and iron steel plants and the utilization

of recycled resources.

Clean Energy and the ten major energy-saving projects: which mainly include regional combined heat and power generation, surplus heat and pressure utilization; energy conservation of motor systems; environment-friendly building, utilization of nuclear, wind and solar energies.

Corporate annuity: an endowment insurance established by an enterprise and its employees in line with laws on a voluntary basis as the supplement to the basic old-age pension.

Charity donations: According to the stipulation of China's Law on Donations for Public Welfare Undertakings, CDB's charity donations refer to the properties gratis and voluntarily donated in the name of CDB to legally-established philanthropic organizations and non-profit public institutions for public welfare undertakings
