Environmental Control - IMPLEMENTATION OF THE AGENCY'S WASTE SORTING

1 - AIM

In the frame of our Management system and our commitment in a step of Durable Development, we have decided to integrate the aspect of « Environmental Management » in the current organization of our structure (Quality and Safety).

One of the most noticeable actions in our agency of Beaumont Hague, corresponds to the implementation of the waste selective sorting.

2 - PRINCIPLE OF METHOD

- · Identification of generated wastes
- Partnership with « communes, departments and regions » to identify the possible collecting
- Identification of means to implement and supply of the latter
- Implementation of the selective sorting in the offices
- Achievement of specific collecting places
- Sensitization of the Personnel and the Company in charge of the maintenance of premises

3 - IMPLEMENTATION OF THE SELECTIVE SORTING

The generated wastes come from two activities:

- The office's activity
- And the premises activity

It's about wastes which are easily identified such as : paper, plastic matter, and ungraded gravel for the offices, to which we add old iron, wood, used oils for the workshop.

It also seems to be essential to separate the collecting of batteries and glass.

The partnership with the « communes, departments and regions » represents an essential phase. The Community of « Communes » has specifically created the function of « Adviser in waste sorting » to help the companies to set up the selective sorting, to mark the required collecting places, and to sensitize the users. Grabs and plastic bags are becomingly put at the companies' disposal.

To implement the selective sorting, and dissociate the circuits of waste processing, we have identified various needs. After having consulted our concerned suppliers, we have launched supplies of dustbins and collecting containers.

Office's double-entry dustbins, modules of fire-resistant sorting, and a battery container have been supplied and installed in our premises at the strategic points. Collecting places for metals, used oils and wood have been identified.

The Agency's personnel, being already used to sorting the personnel wastes, has been informed about the new modalities of the sorting, and has immediately approved the step. We have marked different collecting places by means of placarding, and we also have sensitized the whole personnel about the possibilities that he was granted.

Colour codes have been installed to ease the marking of the collecting containers.

The company in charge of the maintenance of the premises has implemented everything to continue our step and respect the circuits of the wastes.

4 - RESULT FOR THE IMPLEMENTATION OF THE WASTE SELECTIVE SORTING

Today, the collecting places are all identified and used in well knowing.

Our wastes are managed in totality so as to follow the good circuits of processing and / or recycling.
