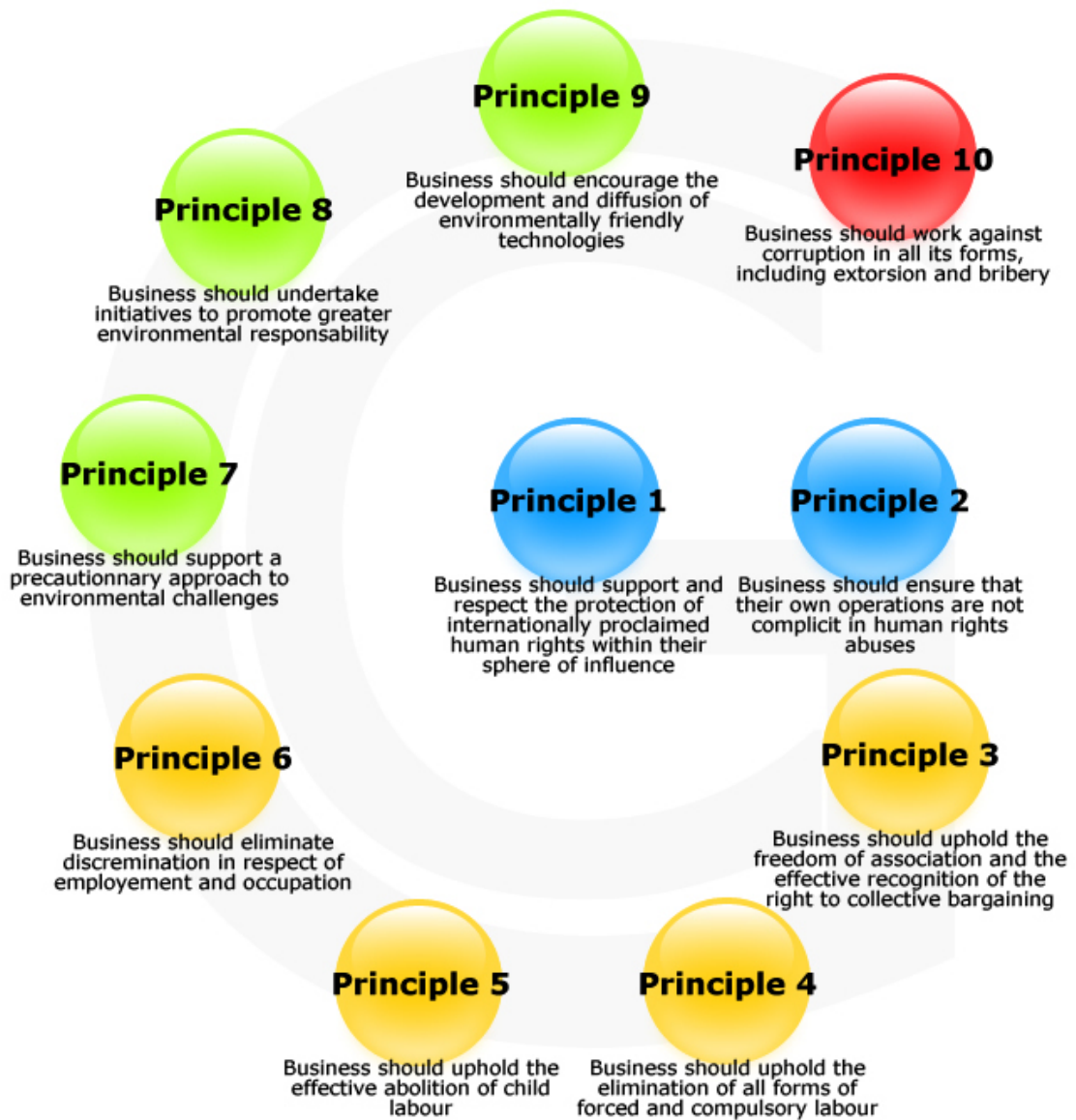

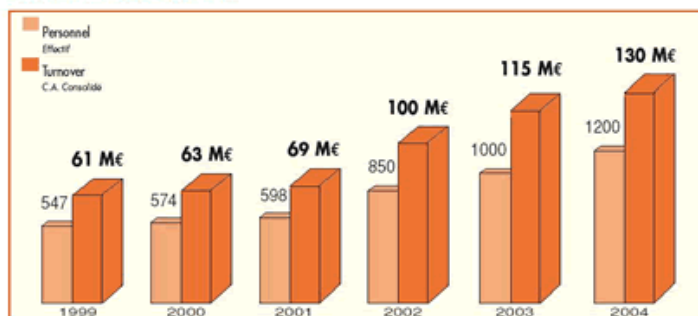

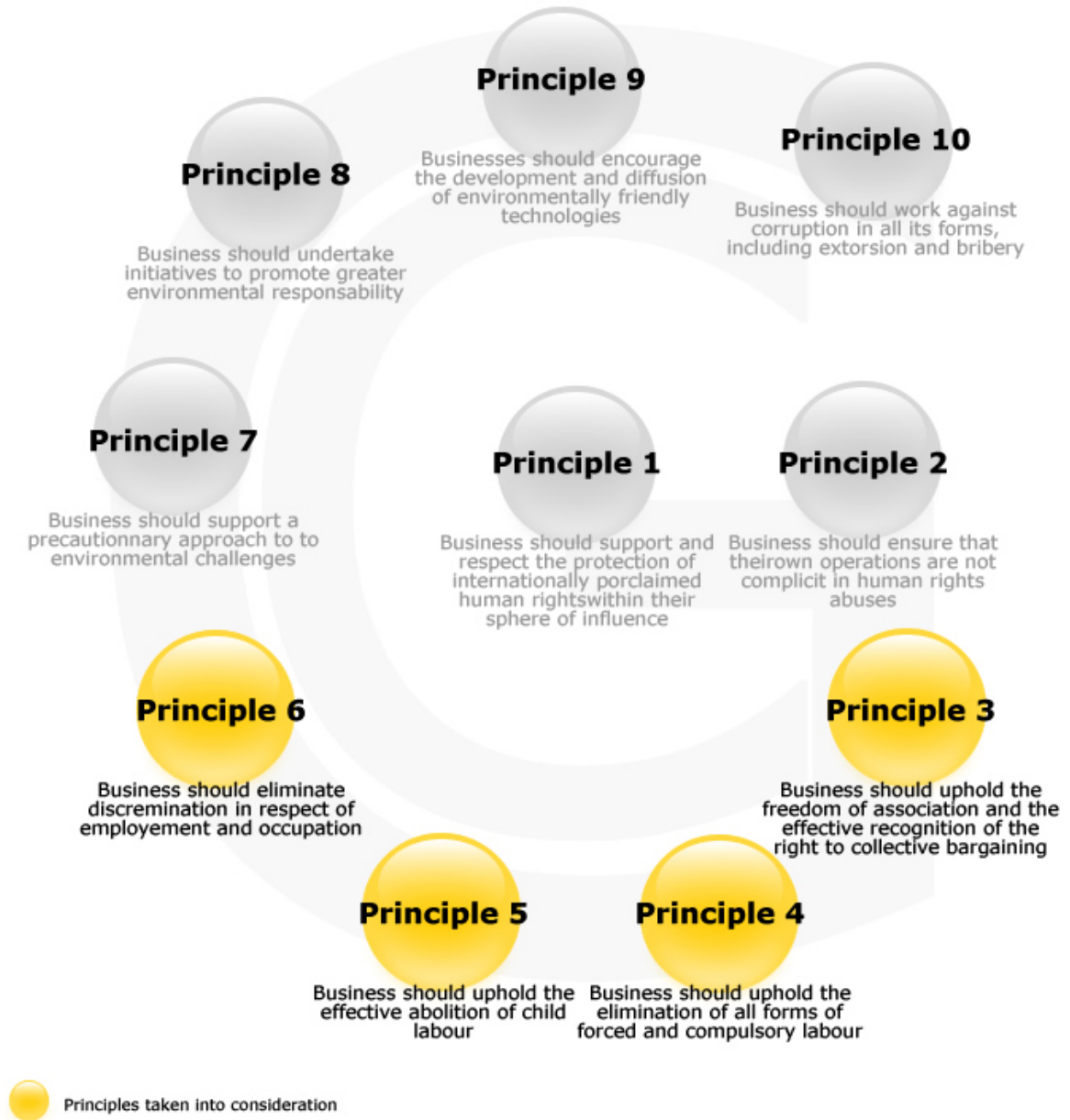

**Results**

■ **Since 2001**

The retention of all polluting products with respect to the environment;  
The selective sorting of all wastes and treatment within the accredited channels;  
The improvement of fire risk prevention through efficient alarm systems, staff training...

■ **Since 2002**

The implementation of devices preventing from polluting sewerage systems and tap water;  
The choice of raw materials in compliance with legal requirements.

■ **Since 2003**

75% of NIEF PLASTIC's lifting appliances have been equipped with electrolyte-gelled batteries in order to prevent from explosion and pollution hazards (former batteries contained electrolyte liquid).

■ **Since 2004**

50% of our computers have been upgraded with LCD screens (which require less energy and raw material than usual screens).
