THE 10 PRINCIPLES OF THE GLOBAL COMPACT

HUMAN RIGHTS

Principle 1:

Business should **support and respect the protection of internationally proclaimed human rights.**

- Group management tool adapted. Implementation in each plant in 2013-2014.
- Safety Group policy.
- Works Council and OHS committee in place and meetings held regularly according to legal requirements.
Elections are held to renew those instances regularly.
Continued Works Council and OHS committee meetings with an annual prevention plan showing that progress is on schedule.
- Social dialogue toughened (Managers, Direction, follow-up care, ...).
- Transparency of all economic and labour data.

Principle 4:

Business should uphold the **elimination of all forms of forced and compulsory labour.**

Mersen additional actions:

- Update of the supplier guidelines and of the purchasing ethics guidelines V.2014, available within our company in the Quality system In Lotus Notes and sent to all our suppliers.

Principle 5:

Business should uphold the **effective abolition of child labour**.

Mersen additional actions:

- Update of the supplier guidelines and of the purchasing ethics guidelines V.2014, available within our company in the Quality system In Lotus Notes and sent to all our suppliers.

- Organization of waste sorting on our plants.

Principle 9:

Business should encourage the development and diffusion of environmentally friendly technologies.

Mersen additional actions:

- Continued deployment of our mastery of the REACH Directive in Europe, which enables us to respond to our customers' queries while improving our control of how hazardous substances are used in our workshops, on our production lines and at our workstations.
- Continued establishment of Product Environmental Profiles (PEP) and Life Cycle Analyses (LCA) as part of all new product development projects.
- 8 PEP approved and registered in the "PEP ecopasseport" association.
- Continuation of our participation in the "PEP ecopassport" eco-declaration program in liaison with the PEP association.
- In 2013, conditions of application of the new ROHS Directive have been analysed in collaboration with Gimelec.
Our REACH status declarations by products families have been updated twice further to the evolution of the list of worrying substances.
Use of components with Cr VI, Be and Cd Is forbidden.
- Presentation of the status of demand on our markets in terms of sustainable development and eco-design, made to the European Management Committee beginning of 2014 to help advance thought on the suitability of our organizations to give pertinent answers in the short, medium and long-term to our customers and to demonstrate how committed Mersen is in these fields.
As a concrete result about this presentation above, a ROHS actions plan is in progress since beginning of 2014: short term actions and middle term actions concerning the adaptation of our ranges with the market.
