Today, I sincerely hope to re-join the United Nations Global Compact, and I am pleased to confirm that **Egylière Travel** supports all the Principles mentioned above. With this communication, we express our intent to implement those principles.

We are committed to making the UN Global Compact and its principles part of the strategy, culture and day-to-day operations of our company, and to engaging in collaborative projects which advance the broader development goals of the United Nations, particularly the Sustainable Development Goals. **Egylière Travel** will make a clear statement of this commitment to our stakeholders and the general public.
