Confirmation of supporting the Ten Principles of the UN Global Compact

Dear Mr. Secretary-General,

I am pleased to confirm that *intelligent fluids* supports the Ten Principles of the United Nations Global Compact on human rights, labour, environment and anti-corruption. - A description of practical actions (i.e., disclosure of any relevant policies, procedures, activities) that the company has taken (or plans to undertake) to implement the UN Global Compact principles in each of the four issue areas (human rights, labour, environment, anti-corruption).
- A measurement of outcomes (i.e., the degree to which targets/performance indicators were met, or other qualitative or quantitative measurements of results).
