We aim to do that through the submission of a Communication on Progress (COP) that conveys our organizations efforts and dedication to enforce the Ten Principles as well the submission of the yearly required report to document our efforts and developments and our perseverance towards renewing our commitment to the UN Global Compact. MPOI vows to disclose all its actions undertaken towards this initiative while providing KPI's to analyze the degree to which our targets have been met.
