Finally, I commit project44 to the annual submission of the Communication on Progress (COP) that provides you and the United Nations Global Compact a description of what project44 has accomplished

to date, examples of how our customers have leveraged project44 to achieve their supply chain sustainability goals, and measurements of outcomes.
