Dear Mr. Secretary-General,

I am pleased to confirm that T.E.I.M. bluegr wholeheartedly supports and promotes the Ten Principles of the United Nations Global Compact on human rights (principles 1-2), labour (principles 3-6), environment (principles 7-9), and anti-corruption (principle 10).

We have previously participated in the initiative from 2008 until 2014, when we requested to be delisted, due mainly to administrative reasons. We are now more prepared and ready to rejoin, pledging to make progress and take action in support of UN goals. With this letter of Re-commitment, we wish to express our intent to respect and support internationally proclaimed human rights, to do our part in the effective elimination of forced and child labour and employment discrimination, to promote environmental responsibility and awareness of environmentally friendly technologies, and to work against corruption in all its forms.

We are committed to making the UN Global Compact and its principles part of our strategy, culture, and day-to-day operations, and to engaging in partnerships and collaborative projects which advance the broader development goals of the United Nations, particularly the Sustainable Development Goals. T.E.I.M bluegr will issue a clear statement of this commitment to our people, partners, stakeholders, and guests, as well as the general public.

This includes the three necessary elements listed below:

- A description of practical actions (relevant policies, procedures, activities) that the company has taken (or plans to undertake) to implement the UN Global Compact principles in each of the four issue areas listed above.
- A measurement of outcomes (i.e., the degree to which targets/performance indicators were met, or other qualitative or quantitative measurements of results).
