Dear Secretary General,

Cardno Emerging Markets (Australia) was acquired by DT Global on 01 September 2022.

As a result of this acquisition, our current United Nations Global Compact membership has been updated to reflect our new company name of DT Global Asia Pacific Pty Ltd ('DT Global Asia Pacific'). Our subsidiary membership has been consolidated into a new, global membership under DT Global USA.

We are pleased to re-confirm our ongoing support of the Ten Principles of the United Nations Global Compact on human rights, labour, environment and anti-corruption. We express our ongoing commitment to making the UN Global Compact and its principles part of the strategy, culture and day-to-day operations of our company, and to engaging in collaborative projects which advance the broader development goals of the United Nations, particularly the Sustainable Development Goals.

DT Global Asia Pacific recognises that a key requirement for participation in the UN Global Compact is the annual submission of a Communication on Progress (CoP) that describes our company's efforts to implement the Ten Principles. Due to the changes in company structure, we will not be developing our CoP report under the name of 'Cardno Emerging Markets' but instead, our annual COP will be developed to reflect our expanded business operations and posted on the UN Global Compact website under the DT Global US membership.

As per UNGC requirements, the CoP will include:

- A statement signed by the chief executive expressing continued support for the UN Global Compact and renewing our ongoing commitment to the initiative and its principles. This is separate from our updated letter of commitment to join the UN Global Compact.
- The completion of the online questionnaire of the Communication on Progress through which we will disclose our company's continuous efforts to integrate the Ten Principles into our business strategy, culture and daily operations, and contribute to United Nations goals, particularly the Sustainable Development Goals.
