I would like to apply for UN Global Membership. I am pleased to confirm that Compass Housing Services Co. Ltd supports the Ten Principles of the United Nations Global Compact on human rights, labour, environment and anti-corruption. With this communication, we express our intent to implement those principles. We are committed to making the UN Global Compact and its principles part of the strategy, culture and day-to-day operations of our organisation, and to engaging in collaborative projects which advance the broader development goals of the United Nations, particularly the Sustainable Development Goals. Compass Housing Services Co. Ltd will make a clear statement of this commitment to our stakeholders and the general public. We are currently integrating our strategic planning process with the SDGs. Compass Housing is a not-for-profit NGO.

We recognize that a key requirement for participation in the Global Compact is the submission of a Communication on Engagement (COE) that describes our organization's efforts to support the implementation of the ten principles and to engage with the Global Compact. We support public accountability and transparency, and therefore commit to report on progress within two years of joining the Global Compact and every two years thereafter according to the Global Compact COE policy.

We also pledge to actively participate in and engage with the UN Global Compact. Compass Housing Services has engaged fully with the UN Habitat III process with key team members attendance at PrepCom 2 and 3 and at UN Habitat III, Quito. This has led to my initial UN General Assembly of Partners role as Co-Chair of the Civil Society Organisations, Partner Constituency Group and subsequent election to the role of Vice President of the UN General Assembly of Partners. My Compass Housing Services colleague, Larry O'Brien was elected to the Co-Chair role with CSO in my place.

Compass Housing Services has also played a major advocacy role promoting the New Urban Agenda and the Sustainable Development Goals in the Pacific region by organising three key events. We were:

• Conveners of the first southern hemisphere *Implementing the New Urban Agenda in Australasia* and *Pacific Region*, two-day conference in Melbourne, May 2017 (240 international delegates).




