Dear Secretary-General,

I am pleased to confirm that **Madre Integrated Engineering** supports the Ten Principles of the United Nations Global Compact on human rights, labour, environment, and anti-corruption. With this communication, we express our commitment to making the UN Global Compact and its principles part of the strategy, culture, and day-to-day operations of our company, and to engaging in collaborative projects that advance the broader development goals of the United Nations, particularly the Sustainable Development Goals. **Madre Integrated Engineering** will make a clear statement of this commitment to our stakeholders and the general public.

With the sudden shift to remote work and the health and safety concerns of our employees at the forefront, ensuring their well-being became our top priority. We also extended our support to the families of our affected employees during these trying times.

Due to the necessary adjustments and the limited number of dedicated employees available for critical tasks, we encountered coordination challenges that hindered our ability to fulfill our commitments to the UN Global Compact. Nevertheless, we remained steadfast in our commitment to sustainability principles, despite the adversity.
