Dear Secretary-General,

I am pleased to confirm Liberty Global's support for the Ten Principles of the United Nations Global Compact on human rights, labor, environment and anti-corruption.

With this communication, I express our commitment to making the UN Global Compact and its principles part of the strategy, culture and day-to-day operations of our company, and to engaging in collaborative projects which advance the broader development goals of the United Nations, particularly the Sustainable Development Goals. Liberty Global will make a clear statement of this commitment to our stakeholders and the general public. Liberty Global will be joining two of our wholly-owned operations – Telenet and Sunrise – who have already committed to these principles and are currently members of the UN Global Compact.

Liberty Global invests in fiber-based and 5G networks across six European countries, providing 85 million fixed and mobile connections. We recognize the pivotal role we play in society and have articulated our priorities through our **People Planet Progress** strategy, aimed at addressing the most pressing issues facing our world and global society today.

Treating **People** – our customers, partners, employees, and communities – fairly is paramount to us. We are committed to high human rights standards and practices. We are also committed to creating greater diversity, equity, inclusion and a culture of Belonging in our workforce. In our communities, we support programs and partnerships focused on digital equity, digital skills, and enhanced accessibility. Additionally, we encourage employee volunteering to champion these priorities, creating truly connected communities across our markets.

Aligned with the goals of the Paris Agreement to limit global warming to no more than 1.5°C, we are dedicated to reducing our carbon footprint. To protect our **Planet**, we are working towards achieving our Scope 1 & 2 net zero ambition by 2030, as announced in 2021. This includes a Science Based Targets initiative approved target of 50% emissions reduction in Scope 1 & 2 by 2030 compared to our 2019 baseline. As of 2022, we have already achieved a 25% reduction. Our ongoing carbon reduction ambitions are underpinned by product circularity, improving energy efficiency, sourcing energy from renewable sources, and electrifying our fleet. We continue to work on understanding our Scope 3 emissions with the aim of setting meaningful near-term and long-term net zero ambitions on the principles of science-based net zero targets.


Our commitment to **Progress** means that we are focused on transparent and sustainable operations and practices. Our governance structures and processes support these objectives both within our company and throughout our value chain. Through our annual Corporate Responsibility report, we share our progress with our investors as well as other important stakeholders. We also participate in key sustainability indices, including the Dow Jones Sustainability Index and receive ratings from the Carbon Disclosure Project (CDP) index. Liberty Global recognizes that a key requirement for participation in the UN Global Compact is the annual submission of a Communication on Progress (CoP) that describes our company's efforts to implement the Ten Principles. We support public accountability and transparency, and therefore commit to report on progress starting the calendar year after joining the UN Global Compact, and annually thereafter according to the UN Global Compact CoP policy. This includes:

- A CEO statement expressing my continued support for the UN Global Compact and renewing our ongoing commitment to the initiative and its principles. This is separate from our initial letter of commitment to join the UN Global Compact.
- The completion of the online questionnaire of the Communication on Progress through which we will disclose our company's continuous efforts to integrate the Ten Principles into our business strategy, culture and daily operations, and contribute to United Nations goals, particularly the Sustainable Development Goals.

I firmly believe that our **People Planet Progress** strategy aligns with the principles of the UN Global Compact, and our participation in this initiative will further enhance our commitment and impact across these areas.
