Support of the Ten Principles of the United Nations Global Compact on human rights, labour, environment and anti-corruption

Dear Secretary-General,

I am pleased to confirm that Teollisuuden Voima Oyj supports the Ten Principles of the United Nations Global Compact on human rights, labour, environment and anti-corruption. With this communication, we express our commitment to making the UN Global Compact and its principles part of the strategy, culture and day-to-day operations of our company, and to engaging in collaborative projects which advance the broader development goals of the United Nations, particularly the Sustainable Development Goals. Teollisuuden Voima Oyj will make a clear statement of this commitment to our stakeholders and the general public.
