I am pleased to confirm **Transparency International – Lebanon (TI-LB)** supports the ten principles of the UN Global Compact with respect to human rights, labor, environment and anti-corruption. With this commitment, we express our intent to support the Global Compact advancing these principles, and will make a clear statement of this commitment to our stakeholders and the general public.

We also pledge to participate in and engage with the UN Global Compact in the following way(s):

During the reporting period, TI-Lebanon focused mostly on its internal repositioning in areas of anti-corruption in both the public, private and non-profit sectors. While its engagement on these issues was not directly linked to the UN Global Compact Networks' events and activities, TI-Lebanon was able to engage with a wide array of Civil Society Organizations and Private Sector Enterprises on matters of transparency, access to information and whistleblower protection with state institutions, corruption risk assessments and internal good governance and transparency with civil society organizations, and is recently delving into targeted interventions regarding integrity and good governance in the private sector, particularly in the context of public procurement reforms.

Given the alignment of these endeavors with the UN Global Compact Networks' principles and envisaged activities for Civil Society Organizations, TI-Lebanon is committed to further exploring systematic collaborations with the network in terms of raising the awareness of its private and non-profit sector members on issues related to good governance, integrity and transparency. This can be made possible through designing and co-implementing information sessions, workshops, and communities of practice that allow peer-learning and greater progress towards adherence to these principles across the sectors.

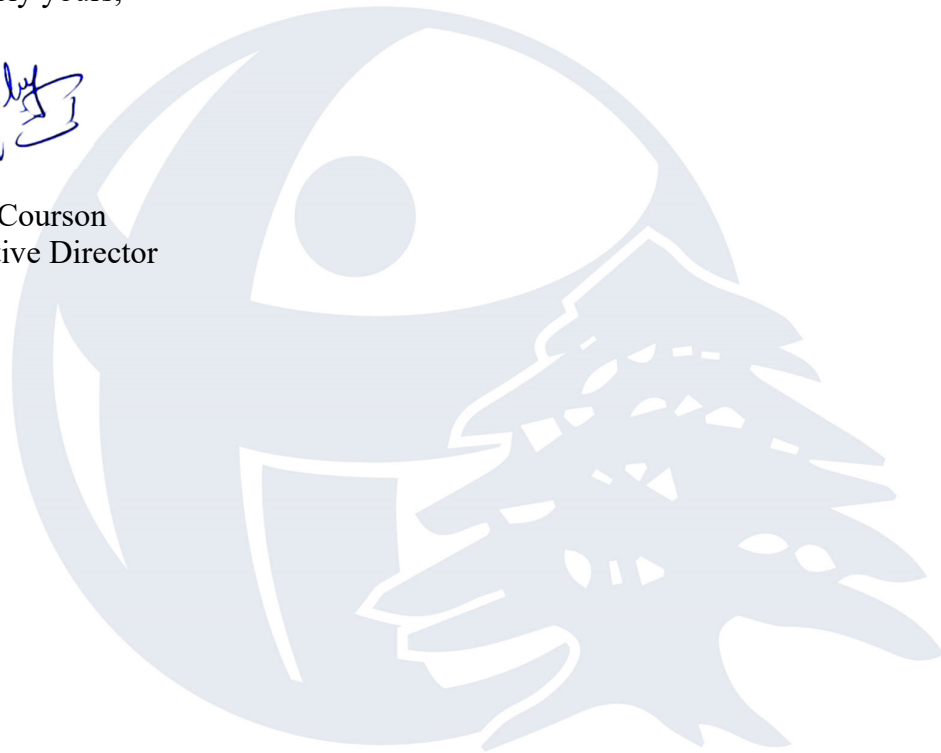
