Dear Secretary-General,

I am pleased to confirm that SOCAR AQS supports the Ten Principles of the United Nations Global Compact on human rights, labour, environment and anti-corruption. With this communication, we express our commitment to making the UN Global Compact and its principles part of the strategy, culture and day-to-day operations of our company, and to engaging in collaborative projects which advance the broader development goals of the United Nations, particularly the Sustainable Development Goals. SOCAR AQS will make a clear statement of this commitment to our stakeholders and the general public.

We wish to bring to your attention that SOCAR AQS previously joined the initiative and was approved as a participant in 2018. However, we were delisted solely due to limited engagement opportunities and participant support at the country level, which was related to the lack of representation in Azerbaijan, an issue we cordially understand. Now, with UN Global Compact having senior local presence that ensures proactive promotion of engagement opportunities, continued participant support and visible country operations evident through numerous flagship events and rapid growth in corporate membership, SOCAR AQS is prepared to fully commit, engage and utilize the opportunities available through the initiative to further its corporate sustainability profile, incorporate and promote the Ten Principles and contribute to the attainment of the sustainable development agenda. We further note that since Global Compact's established permanent presence in Azerbaijan over a year ago, SOCAR AQS has already and actively engaged with the Initiative as a partner in Azerbaijan and has now decided to re-join the initiative formally, contribute to and benefit from it as a participant.

We recognize that a key requirement for participation in the UN Global Compact is the annual submission of a Communication on Progress (CoP) that describes our company's efforts to implement the Ten Principles. We support public accountability and transparency, and therefore commit to report on progress starting the calendar year after joining the UN Global Compact, and annually thereafter according to the UN Global Compact CoP policy. This includes:
