ISO 14001 certification in Belgium and Slovakia

On 21 December 2009, we qualified for the ISO 14001 certificate in Belgium for our environmental management system. The key focuses are monitoring compliance with regulations, constantly improving environmental performance and increasing the involvement of all employees. KBC also constantly evaluates its





environmental policy. Based on previous voluntary audits, we already received the Ecodynamic Business Label for our buildings on the Havenlaan in Brussels and the West Flanders Environment Charter for our offices in that province. The ISO 14001 certificate applies to all KBC's support services in Belgium and was extended for another three-year period at the end of October 2015. ČSOB Slovakia, too, was awarded ISO 14001 certification, which was extended for three years at the beginning of 2015.

On 31 January 2013, KBC Belgium gained EMAS certification for its support services, making KBC the first Belgian financial institution allowed to register for this European Eco-Management and Audit Scheme. KBC has been fully EMAS registered since 1 April 2013.
