*Through the period of two year Croatian Chamber of Economy conducted the following actions:*

- *Organize workshops and trainings for our members on topics within four main pillars of ten UN Global Compact goals:*
  - *Human rights – organisation with partners of one workshop related to human rights*
  - *Labour standards – organisation a number of workshops related to the CSR issues and workers wrights*
  - *Environment – in the period of this Communication CCE had organized a number of public meetings, workshops and technical consultations with relevant stakeholders (institutions and business) related to the environmental issues.*
  - *Corruption – anticorruption activities are recent topic followed by CCE. Specific focus is on strengthening business in Croatia while frightening corruption. CCE organised public-private dialog on the subject.*
- *Through its activities CCE organized, with partner organisations, education for its members related to the significance of CSR, how to incorporate CSR into the everyday business was organized based on the good practical examples. - *Every year we are carrying through project on self-evaluation for our members on corporate social responsibility – Indeks DOP-a. This project is connected to evaluation process on CSR practice within each individual company. The evaluation is partially automatic and partially done by independent committee. This project is conducted with partner organisation continuously from 2007. The self-evaluation enables business to view themselves in the light of their practice in relation to the social activities, environmental practice and economic performance. This project is recognized by the businesses as a tool to improve their practice and their understanding of topics that are in reality 10 Global Compact principles*
- *In the period of two years CCE actively organized a number of round tables related to the promotion and understanding of specific principles. Additionally CCE is actively involved in promotion of green technologies and is involved in promotion of green procurement. Further, CCE has a project focused on activities that would in future eliminate bribery and improve transparency. This project is still on going and its full results are expected by the end of 2017*
- *Participation on COP 21 meeting – CCE was actively involved in preparatory activities on national level and one representative of CCE was present on COP21 meeting*
