(\*\*) The collection owned by *IP* was founded on 2014, December 15th, thanks to the idea and donation of Michela Cocchi, Founder and President of LLF. The collection is constituted by garments and accessories, dated back to '80, witnessing the evolution of the last thirty years of couture and prêt-à-porter, through examples of historical and iconic brands, line bis, street style, mass product.

This ensemble, at present assembling more than 500 different and various pieces from five continents, expresses transformation fashion and its industry has had in the last decades that, on one hand, has brought a deep democratization of fashion product, and on the other hand, has made emerge as central the theme of human rights, specifically with reference to protection of workers – focusing on women and children, environment, IP, complex and globalised supply chains – 'Made in' issue included.
