- XII to carry out and promote research activities related to nature conservation;

XIII - promote the creation and maintain tree nurseries;

XIV - disseminating conservation knowledge and principles of sustainable development through their actions, courses, competitions, publications, lectures and conferences;

XV - sign agreements, adjustments, agreements and partnerships, aimed at achieving its goals;

XVI - to involve people interested in ecological and social work of any kind, defined by the General Assembly;

XVII - practice and disseminate cooperative production methods and environmental protection;

XVIII - promoting environmental education, recreation and leisure activities and sociocultural integration of the community.
