- ProData Consult fully supports freedom of association and all employees have the right to collective bargaining.
- We support the elimination of all forms of forced or compulsory labour.
- ProData Consult financially supports Unicef and thus an organization working on abolishing child labour in all its forms.
- Non-discrimination and labour rights are an integral part of our Code of Conduct.
- We do not discriminate due to race, political or religious beliefs or sexual observation and have a no tolerance policy on any cases of discrimination discovered.
- ProData Consult welcomes a diverse labour force and sees differences as strengths. We work towards having a diversified labour force.
- All employees have once a year an employee development interview and conversation with the line manager, with the purpose to give the employees the opportunity to influence on their own personal and professional development, in the company.

MEASUREMENT OF OUTCOME:

- No instances of forced and compulsory labour nor child labour were detected.
- No cases of discrimination were detected.
- Although we operate in a traditionally male dominated business segment (IT), we have an administration with +50% women employed by 2017.
- No work injuries were reported.
