Memorandum of Understanding (MoU)

This Memorandum of Understanding is executed on 7th day of June 2015 by and among **UDYAMA** which is an NGO registered under Register of Societies Act XXI of 1860, with its Coordination office at HIG-140-K-6-Kalingavihar, Bhubaneswar-751019, in the state of Odissa, represented by its authorized representative, Pradeep Mohapatra, Secretary as one party.

And

ICCo which is an autonomous registered trust with its head office at C-19/A, Green Park Extension, New Delhi, India represented by its authorized representative, Alay Barah, Executive Director

Udyama and the ICCo hereby agree upon the following terms:

Duration: The term of this Memorandum of Understanding shall be five years initially, and shall be deemed to have commenced on 07/06/2015. The term shall be renewed with the agreement of both the organizations. The MoU shall stand terminated on 07/06/2020, unless Udyama and ICCo mutually agree to extend/renew theterm.

PURPOSE

The purpose of this collaborative partnership is to jointly identify and work towards a society free of poverty and ensure social justice to the resource poor and disadvantaged communities in the country. Both parties shall jointly develop and share their respective expertise to address development challenges in India. Both parties shall strive to generate and share resources to achieve this purpose.

1. SCOPE

The scope of the MoU is limited to the following areas:

- Joint resource mobilization by both parties towards a common goal, joint bidding for institutional funds and synergizing fundraising activities
- Jointly implementing programs and activities that are within the purview of the partnership

Joint learning and sharing of experiences for enhancing the capacities of both parties on the activities
of the mission.

- Provide mutual technical expertise for enhancing learning and development of both parties
- ICCo & UDYAMA will share expertises, learning, office and human resource
- Other forms of institutional collaboration as and when they arise achieving the above mentioned purpose

2. RESPONSIBILITIES

In pursuance of above, NOW IT IS AGREED BY AND BETWEEN THE PARTIES AS FOLLOWS the following broad responsibilities of each organization under this MoU:

Role of ICCo and Udyama:

- 2.1 ICCo will play the Project Monitoring and Evaluation Role whereas Udyama will be in Implementation Role and vice versa.
- 2.2 For smooth coordination of roles of both the organizations, ICCo and Udyama will arrange discussion based on the nature of the projects taking up as a join responsibility.
- 2.3 ICCo will play a major role as a technical support organization through its network and linkage at National and Global levels.
 - Identify potential institutional resources and opportunities for fundraising on the issues identified under this MoU
 - Develop the capacities of UDYAMA to access the above mentioned opportunities and support in the process of fundraising
 - Identify specific program areas for developing and designing specific projects for joint implementation
- 3. Termination: The Memorandum of Understanding can be terminated by Udyama or ICCo: -

- 3.1 By Udyama or ICCo giving written notice of immediate termination if one of the parties performs unlawful activities.
- 3.2In the event of insufficient or poor performance of one of the organizations, the other shall have the right to discontinue the partnership.

3.3 After giving three months' notice of termination in writing to the other party

4. Terms and Conditions: ICCo and Udyama agree that, this MoU will be subject to the following terms and conditions:

The both organizations will:

(A)

- Mutually agree to work together to achieve common objectives of securing sustainable livelihoods and dignity and justice for all
- Identify the donor/funding organizations for jointly submission of projects in mutually agreed working area
- Agree to work in the areas of Agriculture & Natural Resource Management- allied sectors, Handloom
 and handicraft, skill building, DRR, Climate Change Adaptation, Clean Energy and Livelihood to meet
 the common objectives of ICCo and Udyama.
- Agree to work in India broadly and North Eastern States (Assam, Manipur, Nagaland, Sikkim, Tripura, Mizoram, Arunachal Pradesh Meghalaya) of India in specific for the benefit of poor, vulnerable people.
- Agree to give best of services, knowledge to the community/ beneficiaries as per strengths of the organizations
- 6. Both organisations have agreed to share office, human resources and maximise resource utilisation

(B)

- Ensure that the fund received will be used as per budget and role division agreed by ICCo and Udyama.
- 2. Ensure that the funds will not be used to create corpus.
- 3. Ensure completion of time to time identifiedwork by the organizations in the whole period of agreement
- Ensure completion of work of any approved project within the timeframe as per role and clear division of activitiesagreed by both the organization.

5. Task of the organizations:ICCo and Udyama

- 1. Information sharing and gathering for the benefit of both the organizations
- 2. Feasibility and viability study before submission of project
- 3. Mobilization of resource and resource person for the benefit of the organizations
- 4. Periodic meet for strategic discussion.
