In particular, this partnership and collaboration with others contributed to the performance of thousands of free surgeries in several countries and over a million clinical consultations and treatments and is supporting the process of quality public health.

PROFOH has developed a new partnership with some corporate bodies like Access Bank Nigeria and Clinical Translational Scientific Research limited Nigeria for a comprehensive health intervention Corporate Social Responsibility program , these firms share the same commitment to social justice, their support was also very vital in our medical interventions in line with Principle 1. PROFOH partnership with United Nations Convention against Corruption coalition(UNCAC) another Global Compact member, led to the appointment of its Executive Director as the regional coordinator for West and Central Africa(25 countries) in July 2012,

- PROFOH has been recognized as organization as a leading humanitarian organization and won several prestigious Awards in Greece, Nepal, Nigeria, etc . We have received official invitations from several countries including Cameroon, South Sudan, etc
- PROFOH Executive Director was appointed the regional coordinator for West and Central Africa (25 countries) in July 2012, an assignment that increased membership and expanded the war against corruption, with a new definition added to corruption dictionary, (stealing of election result became corruption for the first time in the region and thus reforms were introduced by some governments) it made a difference.
