Labour

- Kärcher Futuretech do not tolerates any discrimination based on sex, age, race, nationality, disability, social origin or sexual leanings. Kärcher Futuretech advocates equal opportunity.
- Kärcher Fututech comdemns forced labour and physical punishment, threat and harassment of employees.
- Condemnation of child labour and compliance with the statutory regulations pertaining to the minimum age of employees.
- Kärcher Futuretech is certified "Beruf und Familie"

- Definition of environmental goals:

 - Waste management improval
 - Development of ecofriendly products
 - EU regulations such as REACH or ROHS are taken into account while selecting parts and components
- · Environmentally relevant norms are regularly reviewed

- Kärcher Futuretech is among others ISO 14001 and ISO 50001 certified
- The 2017 environmental goals have been achieved
- Materials are chosed and used in an ecofriendly way

- The existing process to check the due diligence of our sales partners is repeatedly trained and strictly followed.
- Clearance of suppliers of Kärcher Futuretech is only possible after due diligence check and written confirmation by the suppliers to adhere to the Kärcher Code of Conduct.
