Over the past two years, the Global Coalition for Peace and Security has taken action on combating human trafficking, transnational organized crimes, violent extremism, community wellness, social justice and women's rights. GlobalCops engagement focused on working with stakeholders and policy makers to find lasting solutions to the scourge of terrorism, nuclear proliferation and ban of the world's most dangerous bombs.
