3. Measurements of Outcomes;

Opensanit Company has employed more than 100 employees whom were all brought to the awareness on the Human Rights. In the same period about 50 employees including the Managers and Heads of departments were trained on ethic concepts and governance.

Complaints are dealt from within through a disciplinary committee that undertakes proper investigations into any complaint before any disciplinary action is taken.

The percentage of recycled materials is 65% out of the monthly total production.
