- Other administrative services


The main task of the BSCC is to stimulate the economic relations and facilitate the communication between companies from Bulgaria and Switzerland and to present Bulgaria as a reliable destination for building business partnerships (production, assembly, service, joint projects, etc.).

The Bulgarian-Swiss Chamber of Commerce has focused on three U.N. Global Compact areas that are most aligned with its work – Labor, Environment, Anti-Corruption.

Activities in the period March 2016 – March 2018

(1) BSCC initiated the signing of a joint letter together with the 9 most important bilateral chambers in the country, representing more than 80% of the total foreign investment, aiming to support the completion of the long awaited judicial reform in Bulgaria focused on anticorruption.

- (2) BSCC coordinated successfully the Swiss-supported project for the introduction of dual-track principles in the Bulgarian vocational education system.
- (3) BSCC' support of Roma minority integration and other socially oriented and charity-like projects are unseparable part of BSCC' life.
- (4) BSCC continued its cooperation with the Municipality of Lausanne on the Restart Project donating more 5200 quality recycled computers to NGOs, orphanages, municipalities, schools and hospitals throughout Bulgaria.
- (5) BSCC initiated the project "Business Partnerships for Better Society" financed by the Swiss Contribution Program aiming to improve the quality of the labor conditions of the Bulgarian enterprises and to forge links with high quality Swiss companies.
- (6) With BSCC support Swiss investors opened new production facilities or expanded the existing ones thus creating hundreds of new working places including in the less developed regions of the country.
