The Foundation for Post Conflict Development (FPCD) is a United States 501 (c)(3) public charity organization that assists post conflict communities. The FPCD has been a proud signatory to the United Nations Global Compact since 7 December 2006. Since the new rules have come into effect about communication on engagement, this serves as the second report and summary of activities.

We Support the UN Global Compact Logo

Since 2006, permission has been granted in different manifestations for the FPCD to use the "We Support" Logo on its website. Where possible the same logo is used in electronic newsletters, and annual reports, showing the FPCD's commitment to the ten principles. The Logo is accompanied with a description of the UN Global Compact and a direct link to the UN Global Compact for those interested in learning more about this initiative. Outcome results of this activity can be measured by the number of increased visits to the UN Global Compact website.

Promotion of the UN Global Compact in the FPCD Sphere of Influence through Sustainable Development Projects for Family Health

Since our last Communication on Engagement Report, the FPCD has promoted the UN Global Compact in its sphere of influence, namely through the signing of two Memorandums of Understanding with a private corporation and a non-governmental organization. These memorandums made transfer of project funds dependent on the acceptance of the Compact, especially as relates to corruption and child labour. The FPCD is proud that its implementing

partners, **Monaco based ES-KO** and **Haiti based Foundation Saint Luke**, both agreed to the insertion of the Compact in separate signed agreements that created and operate the Princess Charlene of Monaco Women's Health and Training Center in St. Louis de Sud Haiti. This Clinic brings essential maternal and family health services to a remote area of Haiti and has received more than 1000 patients and pregnant women since it became operational in 2017.

Engagement with Global Compact Networks and Future Actions

The FPCD is officially "Associated" with the United Nations Department of Public Information and therefore has opportunities to participate with Global Compact Networks at the United Nations and New York area. The FPCD will continue in the same fashion in the next biennium and will endeavor to participate actively, provide commentary to companies on Communications on Progress and continue to incorporate the Global Compact Principles in its sphere of influence. Future actions include a Midwife Capacity Building Programme at the Princess Grace Hospital in Monaco, a new Maternity Clinic to be constructed in a post conflict country and the establishment of the On-line Institute of Post Conflict Development. In this vein, the FPCD will be sure to advocate for the UN Global Compact through its sustainable development projects and social media platforms.

Reaffirmation of Commitment

The FPCD would like to make this public disclosure to reaffirm its steadfast support to the Global Compact and its commitment to the ten principles in the areas of human rights, labour, the environment and anti-corruption. The FPCD recognizes that all development programmes must include the principles of the UN Global Compact and that through those principles business and civil society can work together for the common benefit of sustainable development.
