
# **Profile**

## **Main Activity**

**Training and development** is the field which is concerned with organizational activity aimed at bettering the performance of individuals and groups in organizational settings. It has been known by several names, including **human resource development**, and **learning and development**.

A Non-Governmental Organization (NGO) is any association having a definite cultural, economic, educational, religious or social cause or any non-profit voluntary citizens group which is organized around specific issues, such as education, environmental conservation, social welfare, rural development sanitation, healthcare or human rights, on a local, national or international level. The World Bank defines NGOs as "private organizations that pursue activities to relieve suffering, promote the interests of the poor, protect the environment, provides basic social services, or undertake community development. NGOs include an array of groups and institutions that are entirely or largely independent of government and characterized primarily by humanitarian or cooperative, rather than commercial objectives". According to a World Bank key document, the term NGO can be applied to any non-profit organization, which is entirely or largely independent from government and exists to serve humanitarian social or cultural interests either of their memberships or of social as a whole. NGOs are typically value-based organizations, which depend, wholly or in part, on charitable donations and voluntary service. Although, the NGO sector has become increasingly professionalized over the last two decades, principles of altruism and voluntarism remain key defining characteristics.

A sustainable organization is one, which is able to remain in existence for long, delivering the same or better level and quality of service, enduring and withstanding hardships, moving along its declared mission and striving towards the vision set.

NGOs provide much needed services to their respective communities, and thorough planning during the start-up process is crucial to develop an effective and professional organization that is able to meet the challenges faced by the world today.

The programmes of NGOs include:

- (1) To develop network between Government Health Personnel and NGO's with a view to take maximum advantage of government Infrastructure.
- (2) Promotion of safe motherhood through ante-natal/pre-natal and post-natal care;
- (3) Child survival through immunization;
- (4) Prevention and treatment of RTIs and STDs;
- (5) Health sexuality and general information to adolescent boys and girls;
- (6) Effective referral system;
- (7) Nutritional services to vulnerable groups;
- (8) Women empowerment, skill development for poor girls through training in computer, cutting and tailoring etc.
- (9) Drug de-addiction projects.

#### Healthcare

Nongovernmental organizations have a long history of active involvement in the promotion of human well-being. In particular, NGOs provide important links between the community and government. They possess certain strengths and characteristics that enable them to function as effective and dynamic agents in this process. In addition, they have exhibited a special capacity to work within the community in response to expressed needs. They have a flexibility and freedom to respond in innovative and creative ways to a wide range of requests and situations.

#### **Primary Health Care and Development**

Nongovernmental organizations support the view that the promotion of primary health care must be closely tied to a concern for total human development. The totality of human development and, in fact, a holistic view of health encompasses the physical, mental, social, and spiritual well-being of the individual. III-health comes to rich and poor alike. However, much ill-health is a result of poverty and in itself is a serious barrier to breaking out of the bondage of poverty. Thus substantial improvements in the well-being of people cannot be expected merely as a result of better health care, but requires a whole range of social, economic, political, and cultural activities, i.e., primary health care must be an integral part of the overall development of society.

#### What NGOs Can Do

- 1. At all stages in the development of primary health care programs, NGOs can be effective. Recognition by government of the contributions NGOs can make in support of primary health care will ensure maximum benefits of these contributions to the national health program.
- 2. NGOs can work for greater understanding and positive attitudes toward primary health care by: (a) promoting dialogue both within and among NGOs;
- (b) sustaining dialogue with governmental authorities;
- (c) providing information and creating new ways of explaining primary health care to the general public; and (d) strengthening means of communication to accomplish this.
- 3. NGOs can assist national policy formation in the areas of health care and integrated human development. They can present health care needs based on their contacts with communities, and they can also interpret primary health care plans to relevant donor agencies.
- 4. NGOs can establish means for greater collaboration and coordination of primary health care activities. This can be done among NGOs and between them and governments, locally, nationally, and internationally.

# Our Role in Environmental Management

Enactment of statutes on Pollution Control and the experience gained in implementation of the various provisions of these Acts in the past more than two decades had indicated that Govt. machinery alone cannot effectively cope-up with the task of pollution control until supported by the masses. The need for participation of masses in achieving the targets committed in the Policy Statements for Abatement of Pollution has been felt strongly. Public interest litigations have successfully demonstrated that responsible and concerned NGOs and public spirited individuals can bring about significant pressure on polluting industries for adopting pollution control measures.

We (NGO) being one of the most effective media to reach the people these days, may play a significant role in this regards. NGOs are assisting the State Pollution Control Boards to a greater extent in providing first hand information and generating mass awareness with regard to control of pollution and can better function in this field in the following ways:

- By conducting preliminary river surveys and survey in air pollution control area for identification of any pollution source.
- By keeping vigil on abstraction of water/discharge of sewage trade effluent by any industry in quantity in relation to flow/volume.
- By conducting sampling and analysis of river/well water to ascertain the quality of river/well water.
- By providing information regarding any cause or permit any poisonous, noxious or polluting matter into any stream or well or on land or in air.
- By keeping vigil in the surrounding area, river, well, land and air against pollution and reporting to State Board/Central Board, if found any.
- By providing information whether any river stretch requires prohibition on use for disposal of polluting matters for notification under Section 24 of the Water Act.
- By providing information regarding violation of consent such as discharges in odd hours.
- By publishing the minimum height of the stack/chimney prescribed for the industry/industrial operation etc. and ambient air and ambient water standards.
- By publishing the notified restricted areas where industries, industrial operations etc. shall not be carried out or shall be carried out subject to certain safe-guards.
- By providing information on fish kill or other sudden damage to the environment not noticed by the State Board.

As far as, Central Board is concerned, it has been extending its full co-operation by providing financial assistance for conducting mass awareness programme in their area. The water testing kit developed by CPCB is being provided to NGOs on subsidised rates making their task easy. Simultaneously the technical publications are also being provided on subsidised rates to NGOs by CPCB.

# PARTICIPATORY PROGRAMMES

As NGO we have taken up activities, which help the implementing authorities in prevention and control of pollution. We have also taken up activities to create mass awareness. Capable and established with sufficient infrastructure facilities to train small NGOs for conducting/organising mass awareness programmes.

# • <u>Skill Upgradation For Professional Graduates – Presently we are executing this Project 2016-19</u>

The scheme aims to empower the SC & ST communities by assisting the economically weaker sections of students among them through coaching institutions for enhancing their skills and capabilities to make them employable in industries, services and business sectors in addition to the government sector. It has built-in resilience to adapt to the market dynamics on a continuous basis so that the target groups are not deprived of the professional acumen demanded by the changing/emerging market needs and opportunities for employment at domestic as well as international levels.

This scheme called "Skill Upgradation for Sc & ST Students has been formulated keeping in view the emerging trends of employment in the era of economic reforms, liberalization and globalization.

Under this scheme we provide Free coaching for Qualifying examinations for admission in technical/professional courses such as engineering, law, medical, management, information technology etc. and language/aptitude examinations for seeking admission in foreign universities.

#### 1. IELTS 2. TOEFL 3. GRE 4. GMAT

The Government of Telangana has taken a policy decision to provide financial assistance to SC students desirous of pursuing higher studies in Foreign Countries. Most of the SC students, due to their extreme backwardness, poor knowledge of English and other disabilities are often unable to perform up to the mark in the above said qualifying exams. Therefore, with a view to equip the students with requisite skills by providing them the benefit of coaching for the above exams it is proposed to facilitate coaching in TOEFL / IELTS / GRE / GMAT etc., in the existing & reputed coaching institutions to make possible admission of SC students in professional courses like Medicine, Engineering, Pharmacy, Nursing etc and for PG Courses in Pure Sciences, Humanities, Social Studies etc., in reputed foreign universities by obtaining higher scores in the above said examinations. Accordingly Govt. issued G.O.Ms.No.55, SW (Edn.1) dept. Dt.29.06.2013, issuing the guideline with regard to "coaching to SC students for eligibility test such as TOEFL/IELTS and GRE/GMAT and other for admissions in foreign universities to SC graduates or final year students at graduation level whose family Income is less than 2.00 lakh per annum. An amount of Rs.175.00 lakhs is provided during the year 2015-16 under scheme.

• Empanelled as Training Partner under MEPMA (Mission for Elimination of Poverty in Muncipal Areas), Department of Municipal Administration & Urban development, (Govt. of Telangana) - in different Sectors, for implementing its Placement Linked Skill Training Programmes (2017-2020).

The Govt. of Telangana established a Mission called MEPMA for formulating strategies to implement poverty reduction programmes in all (74) urban Local Bodies of Telangana. MEPMA is a society set up by the Department of Municipal Administration & Urban Development, Government of Telangana (GoT) to provide employment to the urban unemployed youth.

Set up Nine years back, MEPMA has emerged as one of the largest Livelihood mission working for the urban underprivileged youth in Urban Areas. To date it has trained more than 50,000 trained and placed more than 35,000 youth in Telangana districts in entry level corporate jobs out of this 55% are Women candidates. The youth are from economically and socially under privileged sections of the society.

The sectors in which MEPMA imparts Placement Linked Skills Trainings include Retail, Electronics, Health care, Logistics, Safety and Security, Construction, Automobile, BFSI, Driving, Hospitality, Non renewable

energy the training also include Soft skills like English communication, Work Readiness module, Career Planning etc.,

**MEPMA VISION & MISSION:** To provide one job for every poor urban households of urban slums who are registered in SHG network.

Create to the requirement of the poor urban slums household by imparting employability skills to the youth in family through customize training programme and placement in relevant Industry / Organizations.

MEPMA works in a public-private Partnership model with Government, companies and the urban communities as its stakeholders. The entire approach is a bottom-up approach, tailored to move the urban poor from the unorganized to the organized labor market.

• Presently we are associated as Training Partner with Stratadigm Education and Training Private Limited, a Funded partner of National Skill Development Corporation (NSDC) and a training affiliate of BFSI Sector Skill Council of India (BFSI SSC). Pradhan Mantri Kaushal Vikas Youjana (PMKVY) is a unique initiative by the Government of India that aims to offer 24 Lakh Indian youth industry-relevant skill training. Under this scheme, the trainees will be offered a monetary reward and Government certification on successful completion of training and assessment, which will help them in securing a job for a better future. The skills are also benchmarked to National Occupational Standards that have been developed by NSDC with the support of the Sector Skill Councils.

Under this Initiative we are conducting BFSI Sector Skill Council of India (BFSI SSC) courses.



# Methods/Style of Administration/ Management:

The society shall run its administration with the help and assistance of the following two bodies.

The specific works of reference of these bodies are given below:

- A) Governing Council
- B) General Body

# A. Governing Council:

It is a super body and shall function as a policy framing and a decision-making body. The head of this body shall be designated as the Chairman. The members of the Governing Council shall not exceed five. The Governing council shall consist of two founder members and three members from any category as approved by the founder members.

The Governing council shall fill in vacancies arising out of dismissal, resignation, death or permanent disability of any of its members through nominating by the founder members which shall be ratified by the General Body. The Governing Council shall hold office for five years. The governing council shall meet thrice in a year or more of them. The Governing Council shall prepare and approve an annual budget before it is presented to the General Body. Governing council shall frame the rules and regulations as well as code of conduct for employees or any other rules, which are, deemed fit by the Governing Council to be so framed.

The Governing Council shall determine and create posts, make appointments, fill in vacancies, promote, demote, suspend, dismiss, reinstate, transfer or sanction retirement of other kinds of leave to the employees of the society and shall carry on all such acts that may be deemed necessary for the proper administration and efficient management of the society and its institutions.

The Governing Council is competent to take any other special staff, keeping in view the exigencies of service of the society, institutions and its aims, objectives etc.

# **B.** General Body - Functions:

- 1. The General Body normally shall meet in the month of May each year to review the working of the society and its institutions for the whole year.
- 2. It shall approve the audited accounts of the society.
- 3. It shall approve the minute of all the meetings held during the year.
- 4. It shall approve the annual budget of the society.
- 5. Is shall adopt the annual report of the society.
- 6. It shall consider all matters, which are referred to it by the governing Council and shall fully ratify all actions taken by the founder members.
- 7. It shall approve the Annual Report submitted by the Society's Auditor.
- 8. It shall ratify any action taken by the Governing Council.

#### **General Meeting:**

The rules for the meetings and notices for the General body shall be the same as stated above.
