- CSR Centre implement a project "Step Up- Responsible Production as a Business Driver in RMG sector in Bangladesh. The objective of the project is to incorporate CSR into the RMG sector in Bangladesh by capacity building initiatives.
- It developed two guidebooks on "Directory for RMG Workers-Specific Social Services in Dhaka" and "Factory Guidebook for effective Worker- Management Communication".
