The NGO was founded in 2009 by H.S.H. Princess Karina Bagration-Moukhransky, Mr Parvis Hanson and H.E. Dr Bernard Marquet to contribute to global, sustainable economic and social growth, peace, mutual help, and tolerance, through support and creation opportunities for young international leaders motivated to bring, in their turn, positive changes to their own communities.

Initiatives and Principles

The NGO launches works on and supports various innovative international humanitarian projects tackling with the subjects namely:

Initiatives 2016-2018

Dream Center

Working with our Swiss partner organization Association DETI the new initiative Dream Center in Ukraine is helping 40 children from large and foster families to have the opportunity to attend the extra curriculum classes.

Over the year we have run several fund raising campaigns to raise funds to support the Dream Center with educational working materials, pay teachers, provide clothing, toys for the children attending.

This all year round project will be continued to receive financial support from DETI and our organization. Also the aspiration is to grow this initiative to other regions of the Ukraine.

Teachers Against Violence Project

“Teachers Against Violence Project” with two aims:

1. To unite teachers, parents and children around ideas of non-violence and peaceful education.
2. To donate the personalized “The Olympic Games” book to charitable auctions helping to raise funds for peace building initiatives worldwide.

In 2016 and 2018 funds raised through lot donations for “Sports Stars to Children” charitable auction organized by UN and Malta Order, proceeds went to help sports team made of refugee children.

Giving Initiative

The ongoing Giving initiative was launched in autumn of 2015 to help Ukrainian people with clothes, children clothes and toys donated from France and Switzerland.

This ongoing initiative is organized in partnership with Femmes Internationales Murs Brisés, France; Orella and Rebelux, Switzerland. Femmes Internationales Murs Brisés helps with the collection in France. Orella and Rebelux helps with the coordination and collection in Switzerland and Princess Carina Organization with the distribution in Ukraine to the people in need and children in orphanages.

In 2016 we accelerated growth with new partners joining our network for donations of clothes and toys. Also we included new destinations to support in our network.

Over 120 000 CHF, 3500 kgs, 6000 items of clothes, children clothes and toys have been donated, shipped and distributed in support of Ukrainian people, families and orphanages in need.
