In 2004, then NTUC Secretary General, Mr Lim Boon Heng led a high-level CSR study mission to the United Kingdom to learn how corporations integrate CSR into their businesses. This led to the formation of CSR Singapore in 2005. A decade on, CSR Singapore renamed itself to Global Compact Network Singapore, formally asserting its role as the local chapter of United Nations Global Compact (UNGC). I want to thank Mr Lim, and past Presidents of GCNS for their foresight and passion in championing sustainability in Singapore. These leaders recognised early on that prosperity can

only be built on foundations of peaceful society, equitable access and a world that is abundant with natural resources. GCNS will continue to convene stakeholders to conduct business responsibly through the alignment of UNGC's Ten Principles on Human Rights, Labour, Environment and Anti-Corruption.

Sustainability is now firmly recognised as a mainstream topic for businesses around the world. Singapore is taking the lead on many fronts. SGX has made it mandatory for all its listed companies to report of their Environment, Social and Governance practices from 2017. The Singapore Budget 2018 announced the implementation of Carbon Tax on large emitters taking effect from 2019. In the same budget, it was also announced that diesel taxes would be restructured and vehicle incentive schemes adjusted.

GCNS can play a pivotal role in advancing the sustainable development goals of corporations and future leaders in Singapore. The 2030 Agenda on Global Goals is also an opportunity for GCNS' members to review their leadership in advancing SDGs, to share a common duty to secure a better living for generations to come. To this extent, GCNS' vision is to be the leading sustainability platform, to enable its members and future business leaders to achieve outstanding sustainability ambitions.

I would like to thank our Principal Members, Management Committee, Members and corporate donors for their continuing and unwavering support which has made the promotion of corporate sustainability possible. To the Secretariat staff who continue to work hard in organising meaningful programmes, I extend my appreciation. GCNS will continue to grow in influencing the stewardship of Singapore businesses in sustainable strategies.

In addition to the wide range of activities and events organised for Members, 2017 was an exciting year for forging strategic relations and partnerships for the medium- to long-term. These strategic relations would provide both operational and financial longevity for GCNS. The Financial Report is at Annex 1.

Four Memoranda of Association (MoUs) were signed with the National Trades Union Congress (NTUC), National Volunteer and Philanthropy Centre (NVPC), Global Green Connect (GGC) and the Maritime and Port Authority of Singapore (MPA).

In addition, Collaboration Agreements were inked with Bird & Bird ATMD and the Singapore Exchange (SGX). The Agreement with Bird & Bird ATMD - a leading international legal practice with over 1,200 lawyers globally - cemented the law firm's commitment to the sustainability cause by performing their services pro bono as external legal counsel to GCNS. The SGX Agreement confirmed GCNS as the body to implement the series of Sustainability Reporting Workshops to prepare Singapore-listed companies to comply with Sustainability Reporting regulatory requirements.

The operational units delivered events and activities for Members to build their capacity and knowledge in corporate sustainability. The Membership Reports are at Annex 2,2A & 2B. A summary of the range of events and initiatives for 2017 is as follows:

The MoU served to further strengthen the working relationship with NTUC, already one of our Principal Members, in upskilling and preparing the Singapore labour force for the Future Economy. This includes a strategic alliance to promote the following programmes:

The MoU served to strengthen the working partnership with MPA, the driving force behind the Maritime Singapore Green Initiative and Green Awareness Programme, to encourage the maritime industry to promote sustainable shipping.

The strategic alliance will assist Singapore maritime companies in complying with the Singapore Exchange's (SGX's) mandatory reporting requirements through the following:

- (a) Providing Singapore-incorporated maritime companies listed on SGX with training on Sustainability Reporting in accordance with SGX requirements;
- (b) Convening a C-suite Roundtable for the maritime industry; and
- (c) Collaborating towards launching an annual MPA-sponsored category for the maritime sector at the GCNS Annual Apex Corporate Sustainability Awards Ceremony.

The Sustainable Reporting Workshops and Roundtable will be rolled out from Q2 of 2018.

In its ninth edition, the Summit created a collaborative environment where participants were engaged in interactive conversations on how adopting sustainable policies and practices presented business opportunities in the Future Economy.

The highlight of 2017 were the Sustainability Reporting Workshops. GCNS had been appointed by the Singapore Exchange (SGX) to organise one-day workshops to help listed companies prepare their Sustainability Reports in accordance with new regulatory guidelines and rules. In total, 24 workshops were conducted between February and July 2017, upskilling 409 participants from 242 companies. Of these companies, 229 were listed companies and 13 were unlisted. The latter group of unlisted companies were keen to learn more about sustainability reporting even when they are not required to do so, indicating the growing awareness of the importance of how non-financial business disclosures impact stakeholders.

Feedback from participants was very positive, with many participants indicating that they had acquired a better understanding of the rationale behind the need to report, as well as the skills to craft a report.

Experienced consultants were engaged to discuss the course context and content with SGX, and to conduct the workshops. GCNS is grateful to the following consultants who were involved in the process, and who made the roll-out a huge success:

In addition to, and in support of, the Sustainability Reporting Workshops, a special Sustainability Reporting Seminar was organised by GCNS to assist listed companies appreciate the principles and rationale behind the new SGX requirements, and better understand why companies should go beyond ticking the box during the course of their sustainability reporting work. The emphasis of the Seminar was to highlight how sustainability disclosures could effectively engage investors.

Some of the key learning points from the seminar were as follows:

- The importance of understanding the relationship between interchangeable terms like Sustainability, ESG and impact investing, as these terms could be viewed as a continuum in the different ways of sustainability investing.
- Companies that manage the challenges of sustainability are better equipped to create value in the long term for investors.
- The world has become more transparent due to technology. Companies are scrutinised more thoroughly in their supply chains, and this could lead to the possibility of yielding more positive results.

In an eventful year for training and upskilling in sustainability tools, GCNS was also privileged to have Ms Alyson Slater (Director, Knowledge and Emerging Markets of GRI) fly in to conduct a two-day workshop on "Progressing on SDGs Through GRI Sustainability Reporting" in August 2017. She shared the latest global developments in advancing the SDGs, discussed the main challenges of reporting on the SDGs, and how GRI Sustainability Reporting Standards can be aligned and linked to SDGs. Feedback from the trainings and workshops were positive and participants felt that they were adequately prepared to develop a sustainability report for their organisations in 2018.





The Youth and Outreach team had a successful year engaging Singapore youths in sustainability. This included initiatives like the inaugural GCNS Youth Forum, the annual CDL-GCNS Young CSR Leaders Awards, and the Sustainability Internship Programme (SIP).

## CDL-GCNS Young CSR Leaders Award













Launched in 2011, the CDL-GCNS Young CSR Leaders Award is a case competition that promotes corporate sustainability though youth leadership in Singapore. Targeted at youths aged between 17 and 30, the Award cultivates a new generation to champion a sustainable future for Singapore and beyond by incorporating sustainability into business strategies and practices. The competition also seeks to encourage participating organisations to practice and possibly adopt viable strategies proposed by the student teams.

In its 7th year of competition, a record of 132 teams from various educational institutes participated in the competition. Ten finalist teams had the opportunity of experiencing a work attachment to apply sustainability principles in their respective assigned organisations, mentored by professional sustainability consultants.

Mr Chan Chun Sing, Secretary-General, NTUC and Minister, Prime Minister's Office presented the prizes to the top three winning teams during the GCNS Annual Summit on 29 August 2017.

Innovative ideas received from teams included Team Viride's proposal for AkzoNobel to reduce and reuse paint through revamping the packaging of marine coatings, and creating platforms for the buying and selling of paint among users. Other innovative ideas included encouraging change in recycling behaviour in both public and the industrial sectors in Singapore through the use of technology (Team Environ Inn/Veolia ES Singapore), capitalising on existing CSR programmes though interactive stakeholder engagement (Team The Bok Choys/Informatics Education), and tapping on existing company expertise with a mobile app to encourage volunteering, mentoring and capability building (Team Excelsior/ Nanyang Polytechnic).

This year, a Special Recognition Award was given to Team Excelsior from Nanyang Polytechnic for their outstanding performance.

The inaugural GCNS Youth Forum consisted of site visits and a Forum.

Site visits were organised to three venues: Hilton Singapore and Asia Pacific Breweries on 21 April 2017, and APRIL Group on 29 May 2017. The two-day Forum at NTUC Centre from 22 – 23 April 2017.

In total, 289 youths aged between 17 - 27 years old from tertiary institutions and corporations participated in the three-day event. These organisations comprised 27 institutes of higher learning (IHLs) and 41 corporations.

As a for-youth-by-youth initiative to inculcate leadership qualities in Singapore's future generation, a Youth Organising Committee (YOC) was formed to plan and manage the event. The YOC members comprised 9 multi-ethnic students and young working adults. In addition, there were ad-hoc volunteers who assisted in various capacities over the three-day event.

The Forum programme comprised 5 plenary sessions, 1 debate, an MOU signing with NTUC, and a dialogue session with Guest-of-Honour, Mr Heng Chee How, Senior Minister of State, Prime Minister's Office, and Deputy Secretary General, NTUC. For the plenary sessions, 22 speakers and panellists from the government, civil society and the private sector supported the event with their expertise.

The MOU signing marked the launch of two GCNS' initiatives - The Sustainability Internship Programme (SIP) and the Sustainability Professionals Programme (SPP). The SIP targets youths interested to explore a career in the sustainability field. The SPP caters to professionals with a minimum two years of working experience seeking a career change or those seeking skills upgrading.

Supported by Young NTUC, National Youth Council and the National Environment Agency, the Sustainability Internship Programme (SIP) is a youth initiative by GCNS that has the objectives of developing our youth talent pool to meet the increasing demand in green jobs, and to enhance their career prospects in the sustainability arena.

Participants for SIP attended a compulsory training workshop designed to equip them with basic knowledge on corporate sustainability, as well as skills and tools in engaging potential employers. Topics covered during the training included the following:

- Introduction to Corporate Sustainability
- · Introduction to Sustainability Reporting
- Introduction to Sustainable Development Goals (SDGs)
- · Networking and Relationship Building
- Writing a Resume and Cover Letter

Sustainability consultants such as CSR Asia, Paia Consulting and Sustinere Pte. Ltd conducted the training workshops relating to sustainability and SDGs. Other skills training were conducted by The Global Citizen and MetaMind Training.

Following the completion of the training, participants joined a pool of trained candidates and were matched with appropriate companies seeking interns. To complete the programme, participants would have to complete one of the following with the company they are attached to:

- · Assist in producing a Sustainability Report;
- · Craft an innovative sustainability policy for the organisation; or
- Assist in completing existing projects/initiatives in the organisation.

As at 31 December 2017, there were 6 successful matches for participants, including 3 internship placements and 2 having secured full-time employment.

Staff development was implemented in 2017 to facilitate experiential learning in the team to better understand the sustainable operations and practices of Singapore enterprises, as well as gain new insights relevant to the Four Pillars of UNGC, namely Human Rights, Labour, Environment and Anti-Corruption.

#### SPD (formerly the Society for the Physically Disabled)

Date: 22 June 2017



GCNS had an insightful visit to SPD (formerly the Society for the Physically Disabled) in June. SPD works towards the integration of physically disadvantaged people into mainstream society, including assisting in the search for job opportunities. They offer a range of programmes like the Employment Support Programme, rehabilitation services and training courses to them. The Employment Support Programme is implemented to prepare and train people before they enter into the workforce.

Movie – "An Inconvenient Sequel: Truth to Power"

Date: 21 August 2017



The team caught the movie together as part of staff development and learning about climate change. A discussion was held after the movie, which highlighted the global impacts of climate change. Learning points from the movie/discussion include the following:

- The importance of increased investment in renewable energy, and how people especially the youths have to step forward and take action.
- The poor suffered the most from climate change, illustrated by scenes taken from Typhoon Haiyan in the Philippines in 2013 and the 2015 floods in Chennai.
- How complex and intricate climate negotiations can get, and how obstacles had to be overcome to get all parties aboard the Paris Climate Agreement.

# Markono Print Media Pte Ltd Date: 14 September 2017



Markono is a family owned business established in 1967 that specialises in printing, binding and exporting books. The site visit included a sharing session on Markono's history and their CSR policies (for example energy conservation by using solar panels, and enhancing employees' wellbeing through initiatives like fruits day), followed by an informative plant tour.

Semakau Landfill Date : 23 November 2017



NEA kindly provided GCNS staff with a complimentary visit to Semakau Island in conjunction with Clean & Green Singapore to understand more about the landfill and its operations. The team learnt how the island started its operations on 1 April 1999 to manage the issue of limited space and an increase in solid waste produced.

The team learnt that ashes from incineration are transported in barges from Tuas Marine Transfer Station - 2 barges during off seasons, 4 barges during peak seasons - to the island for dumping into the cells. A layer of earth would cover the cell once completed, eventually forming a green landscape.

NEA started the development of Phase II in 2011 and announced the completion on September 2015. The estimated time frame for Phase II was brought forward from 2045 to 2035 as there was an increase in produced waste. Singaporeans can do their part by reducing waste instead of solely focusing on reusing and recycling.



# SUSTAINABILITY REPORT 2016




We are delighted to announce that a small team comprising our Executives undertook the responsibility of compiling an internal Sustainability Report on the organisation. Among other frameworks, the team also took reference from the Code of Governance for Charities and Institution of Public Character (IPC).

The young team critically examined the policies and practices of the various business units with reference to the United Nations Global Compact's four pillars of Labour, Human Rights, Anti-corruption and the Environment. Following their three-month long examination, the team came up with the Report which comprised their analysis of the organisation's policies and practices, as well as recommendations for improvement.

We congratulate the team for an impressive effort. Building on the success of this exercise, GCNS will make Sustainability Reporting an annual exercise.










# COMPOSITION OF GCNS MEMBERS BY TYPE (as at 31 Dec 2017)
