

主营业务

Main Business

中材建设主营业务为水泥工程项目总承包,具有完整的EPC总承包服务链,可针对不同客户需求及环境特点,在各种规模水泥生产线的工程咨询、设计研发、设备制造和成套、土建安装、生产调试、备品备件、售后服务和生产管理等方面,为客户提供EPC、EP等模式的个性化"总承包"集成服务。

近年来,中材建设积极探索和推进多元发展战略,在建筑、冶金、电力、市政、环保和主营业务延伸等方面进行了有益的尝试,开发和推广了节能、环保、低排放的水泥生产项目的改造技术,以及利用余热发电、脱硫脱硝技术等。

CBMI engages in turn-key cement plant projects. The company provides customized EPC- or EP-mode general contracting integrated service in such aspects as engineering consultation, design and R&D, equipment manufacturing and complete set, civil engineering and installation, production and commissioning, spare parts and components, after-sales service, and production management of cement production line at various scales for clients in accordance with their requirements and environmental characteristics.

In recent years, CBMI has actively explored and promoted multi-business development strategy. Good explorations have been made in building, metallurgy, electricity, municipal construction, environmental protection and extension of main business. It developed and promoted reconstruction technology of cement production projects with the advantage of energy saving, pro-environment and low emission, and used the technologies of cogeneration and desulfurization and denitrification.

经营规模

Operation scale

目前中材建设业务主要集中在海外,遍布欧亚非美,客户资源主要集中在拉法基豪瑞、海德堡、西迈克斯等高端市场,具有良好的品牌和信誉。

在中国水泥工业建设史上,中材建设承建了全球最大的包括两条万吨线水泥厂项目和国内首条全套引进技术生产线、首条自行开发干法旋窑生产线、首条中外合资生产线、首个国际总承包模式"交钥匙"项目,并首次向欧洲国家出口水泥生产线成套设备等,创造了业内多项第一。

中材建设先后承建了中国国内水泥行业大多数的水泥生产线重点项目,其中包括绝大多数外商投资项目和规模超过日产水泥熟料4000吨以上的水泥生产线项目,累计在全球建设水泥生产线项目约170个。

中材建设千余人的职工队伍可在全球十几个国家同时展开超100亿元人民币投资额、20多个项目的建设工作。

Currently, CBMI's main businesses are mainly located overseas, spreading over Europe, Asia, Africa and America, while its client resources are largely from high-end markets including Lafarge-Holcim, Heidelberg and Italcementi Group, with good brand and fame.

In the construction history of China, CBMI contracted the largest cement project including two 10kt cement lines around the globe and the first production line of full introduction, the first dry method rotary kiln production line of independent R & D, the first production line based on Sino-foreign joint venture, the first international EPC turnkey project, and the first to export complete set of equipment for cement production line to European countries, it has been the first for many honors in Industry.

CBMI has contracted most key projects of cement production line in the domestic cement industry, including the vast majority of foreign investment projects and the cement production line projects with scale reaching more than 4000 t/d cement clinker, it has built nearly 170 cement production lines around the globe.

With over 1,000 employees, CBMI could construct more than 10 projects totaling nearly 20 billion yuan in more than 10 counties simultaneously.



2017年六一儿童节前夕,中材建设赞比亚工业园项目到项目所在地学校看望慰问当地小朋友,并向他们捐赠书包。课本、电脑 等学习用品。

2017年,中村建设赞比亚工业园项目部还邀请中国医疗队到项目所在村诊所举行义诊活动。

2017年,中材建设阿尔及利亚BC项目部重视当地社会文化教育事业的发展,针对比斯克拉省Brains市三所学校里相对贫穷的 120名学生进行助学帮扶和捐资助学,共捐出120套约1000件学习用品。

In 2017, SOKOTO Project Department in Nigeria was highly praised by principal, teachers and students of Usman dan Fodio University for its supply of crane after knowing the university needed to replace transformer equipment and considering deficiency and expensiveness of local crane leasing.

Staffs of Industrial Park Project in Zambia of the Company visited students in local school in the project's place before Children's Day in 2017 and donated them school supplies, such as schoolbags, textbooks and computers,

In 2017, Department of Industrial Park Project in Zambia invited Chinese medical team to give a volunteer medical consultation in clinic of the village where the project is located.

With a focus on cultural education development of local society, BC Project Department in Algeria donated 120 sets of around 1,000 schools supplies to 120 poor students from three schools of Brains, Biskra in 2017.

技术研发与设计

2017年,中材建设强化技术创新,提升核心能力。一是加强技术研发,完成移动式模块化粉磨站开发工作,积极推 进智能化技术开发,获得了7项新型专利授权,专利受理13项,11项技术荣获2017年集团"中联水泥杯"技术革新奖 项。二是创新设计手段,积极推进3D和BIM设计,菲律宾CEMEX项目成为业内首个全面采用3D设计完成的项目。三 是切实做好项目设计和市场投标技术支撑工作,为公司市场开拓和项目顺利实施提供有力技术保障,2017年技术中 心完成投标设计及施工设计图纸21843A1张,同比去年增加25.3%

采购供货

2017年,大宗物资和原材料价格一路走高,中材建设采购工作在严格公开公平公正的原则下,积极提高网上采购、 打包采购、 集团内部采购比例,紧密结合市场变化,细化节点、动态跟踪、定期梳理,努力降低采购成本。全年完 成采购额17.91亿元,其中设备采购14.72亿元,签订合同1260个;大宗物资采购量3.19亿元,签订合同899个;两 年期备件采购3277万元,产品交付量是上一年度的2倍。

物流运输

2017年,中材建设结合海关AEO高级认证要求,努力提升物流管理水平。一是开发使用出口报关系统,规范报关管 理流程;二是完善物流信息平台,实施物流动态管理,提升物流管控能力;三是创新物流操作模式,采用一船或多船 一招、COA大包以及海陆联运等相结合的模式,降低物流成本;公司2017年发货量24.71万立方米/11.32万吨,完成 外贸出口额折合4.21亿美元,与上一年度相比,货物发运量增加43.2%,出口额增加120.4%

Technical R&D and Design

We highlighted technical innovation and improved core capacity in 2017. 1. CBMI strengthened technical R&D, completed development of mobile modular grinding station and boosted development of intelligent technology actively: obtained licensing of 7 patents for utility model, passed acceptance of 13 patents accepted and saw 11 technologies winning 2017 CNBM "CUCC Cement Cup" Technical Improvement Award, 2, We innovated technical means and advanced 3D and BIM design actively; saw CEMEX Project in the Philippines becoming the first project completed by applying 3D design fully in the industry. 3. We completed technical support work duly for project design and market bidding, so as to provide technical quarantee for the Company's market exploitation and smooth implementation of project. Technical Center made 21,843 A1 drawings for bidding design and construction design, with a 25.3% YoY growth.

Procurement & Supply

With price of bulk materials and raw material rising continuously in 2017, CBMI increased proportion of online procurement, packaged procurement and Inside of the group vigorously by following the principle of openness, fairness, impartiality strictly; subdivided node and carried out dynamic tracing and regular management in strict accordance with market change and tried to lower procurement cost. In the whole year, we finished RMB 1.791 billion purchase amount; of which, equipment purchase was RMB 1.472 billion, with 1,260 contracts signed, and purchase amount of bulk materials was RMB 319 million, with 899 contract signed; two-year purchase for spare parts reached RMB 32.77 million, with product delivery two times of that of the last year.

Logistics & transportation

In 2017, CBMI tried to improve logistics management according to requirements of customs AEO advanced certification: 1. CBMI developed and applied export declaration system and specified customs declaration procedure, 2. CBMI improved logistics information platform, implemented dynamic logistics management and raised logistics control ability, 3, CBMI innovated logistics operating mode and adopted the mode integrating one-ship or multi-ship with one move, COA general contracting and sea-land intermodal transport, so as to lower logistics cost, Our shipment in 2017 was 247,100 m3/113,200 t and trade export amount was USD 421 million, with a YoY growth of 43.2% and 120.4% respectively.

牛产运营

Production & Operation

In 2017, CBMI production and operation business showed a good development trend; 1, CBMI over-fulfilled annual goal of EDO production and operation and mine operation project again, saw product quality leading in Nigeria and was highly praised by owners and local users. 2. We concluded multiple production and operation contracts successfully such as BUA Project and UNICEM Project in Nigeria and BC Project in Algeria. Amount of production and operation contracts signed in 2017 reached RMB 1.411 billion, accounting for 25.74% of total amount of contracts signed in the whole year, and production and operation became the important component and significant growth point of our business,

Commissioning Service

CBMI had a heavy production commissioning task in 2017; Focused on multiple new projects such as BC Project in Algeria. PPC Project in South Africa, SOKOTO Project in Nigeria, Environmental Protection Project of BEH Annaide and Flying Ash Project in Harbin, we carried out commissioning work in strict accordance with the work goal established at the beginning of year and demand of project construction progress and completed follow-up performance testing task of cement grinding mill commissioning of BISKRA Project in Algeria and follow-up performance testing task of UCIC Project in Saudi Arabia and commissioning and production task of the whole years smoothly and excellently.

CBMI applied for 2 invention patents and 5 patents for utility model and technical and equipment R&D of new business part and had 12 technical innovation achievements. 5. CBMI established R&D team and realized targeted, rhythmed and effective technical innovation guidance under the premise of ensuring production task.

Strengthening of Technical R&D

In 2017, CBMI increased 11 R&D projects in 2017, besides executing 9 technical R&D projects of last year continuously. With respect to establishment of scientific research team, we founded multiple scientific research teams successively focused on key and difficult points of design. In addition, we made special school-enterprise technical exchange with Wuhan University of Technology for many times and completed technical and scheme reserves in aspects of intelligence of single set equipment, full lifetime of project and intelligent factory based on project actuality, demand of final user and digital, information and internet + technology. In particular, parts of information system achievements would be applied in Zahana Project and BECHAR Project in Algeria.

Project management bench-marking

In 2017, the CBMI did well in all projects and showed many highlights. To be specific, in BC Project in Algeria, the precalcining tower was capped in 76 days, breaking the record, and the A clinker production line was put into operation 4 months ahead of the time limit agreed in the contract; in PPC Project in South Africa, every employee took multiple posts and won the award of RMB 7.7 million from the owner, overcoming the difficulty with work visas and other unfavorable factors; Industrial Park Project in Zambia was spoken highly of by State Councilor Wang Yong and the Group leadership and it was praised by Zambian President Lungu as a real factory "in forests"; as for EDO Project, Nigerian Vice President praised in his visit that it adopted the most advanced emission technology to build the most environmental environmentally friendly factory in Africa; Great Wall Automobile Project in Russia made full use of local resources to create a multiple project management mode, overcoming unfavorable factors such as rough weather and local policy restrictions.

施工工法创新

中材建设阿尔及利亚 BISKRA 熟料库直径 60 米,原计划采用普通落地操作脚手架倒模方式,但因工期紧,且投入大量脚手架和造成过多模板的损耗,经过多次研讨,最终确定改型的三脚架倒模方式进行熟料库的库壁施工。该工法主要在操作平台系统上、模板支护系统、质量控制系统及在模板拆除过程中如何应用新型设备等4个方面进行创新和优化。其制定本着安全性、操作便利性、经济性及保证质量为前提,尤其在方案制定中,安全方面的考虑以为操作者提供安全的作业环境及空间优于安全监督管控为目标,做到根本的安全。

采用新型三脚架倒模施工,仅 45 天完成了库壁施工,比原来普通倒模方式至少提前一个半月;库壁混凝土表观质量达到了清水混凝土的要求,质量良好,而安全得到有效控制,没有发生任何安全问题;通过新型的三脚架倒模方式赢得了业主的好评,为项目赶回工期,为熟料线提前点火奠定了基础,最终业主对我们项目部给予了针对熟料库专项赶工奖励近 30 万欧元。

Innovation of construction method

In BISKRA Project in Algeria of CBMI, the clinker silo has a diameter of 60 m. As planned, it was intended to adopt the normal floor-to-ceiling scaffolding reverse-mold mode. However, due to the tight schedule, a large input of scaffolding, and a big waste of frameworks, it was finalized through several discussions to adopt the modified scaffolding reverse-mold mode instead for the construction of clinker silo walls. This construction method innovated and optimized 4 aspects: operation platform system, framework support system, quality control system, and how to use new types of equipment during framework removal. It was prepared on the premise of safety, operating convenience, cost-effectiveness, and quality assurance. Especially with respect to safety, the scheme was made with a view that providing operators with a safe working environment and space took precedence over safety supervision and control, ensuring safety fundamentally.

The new scaffolding reverse-mold mode adopted, the construction of clinker silo walls was completed in only 45 days, which was at least one month and a half ahead of the estimated time in the case where the normal reverse-mold mode was adopted. The surface quality of silo wall concrete was good, reaching requirements for as-cast finish concrete. And not any safety problem occurred. Besides winning the owner's favorable comments, the use of this new scaffolding reverse-mold mode made the project complete in the required duration, which lays a foundation for the advance ignition of clinker line. At last, the owner awarded EUR 300,000 to our project department for the earlier completion of clinker silo.

Bulgarian Devnya project won the Luban Prize of China Construction Engineering (Overseas Project)

On November 6, 2017, the CBMI's EPC project of the 4000t/d clinker production line of the Devnya Cement Plant in Bulgaria (hereinafter referred to as the "Bulgarian Devnya Project") was awarded the Luban Prize of China Construction Engineering (Overseas Project). This is another national honor that the project has won after winning the "2014 Best Architecture Prize" in Bulgaria.

The Luban Prize of China Construction Engineering is the supreme award for the guality of construction engineering in China, representing the highest level of current engineering construction quality in China. The Luban Prize is known as the "Oscar of Chinese

The EPC project of the 4000t/d clinker production line in the Devnya cement plant in Bulgaria is the largest single investment project in Bulgaria in 25 years and built using dry process technology. The project is located in Devnya, eastern Bulgaria. The project is invested by the Italian Cement Group, with its Bulgarian subsidiary DEVNYA CEMENT AD as the owner, and CBMI as the contractor. On June 15, 2017, the Bulgarian Devnya project got the FAC certificate issued by the owner, marking the successful completion of the project.



2017年,中材建设始终坚持"安全第一、预防为主、综合治理"的方针,深入贯彻落实上级单位各项安全要求, 完善安全管理体系,强化"红线意识",深化隐患排查治理,不断提高本质化安全水平,公司全年整体安全 生产形势平稳,所有在建项目均未发生重伤及以上生产安全责任事故。

In 2017, CBMI always adhered to the principle of "safety and prevention first, comprehensive management", thoroughly implemented the safety requirements of higher-level institutes, improved the safety management system, strengthened the "red line awareness", deepened the investigation and control of hidden dangers and constantly improved the level of essential safety. Thus, the company's overall safety production situation was stable throughout the year, and all projects under construction were clear of such production safety responsibility accidents as serious injuries and above.



Strengthen safe production management

完善安全管理制度

2017年,为贯彻落实国家职业健康安全法律法规,规范公司高温津贴发放工作,保障员工健康权益,中材建设编制 印发了《高温津贴发放管理办法》。为促进中材国际(哈尔滨)环境资源有限公司安全管理的积极运行,公司编制了 中材国际(哈尔滨)环境资源有限公司安全管理体系文件。中材建设还承担编制了部分安全管理制度文件,包括《临 边孔洞作业安全管理规程》、《防火与防爆安全管理规程》、《焊接、切割和打磨作业安全管理规程》、《桩机施工 安全管理规程》、《高空作业安全管理规程》等共11个制度文件。

落实安全生产责任

2017年以来,中材建设围绕"党政同责、一岗双责、齐抓共管"的要求,按照国家安监总局《企业安全生产安全生 产责任体系"五落实五到位"规定》等相关规定,进一步落实安全生产主体责任,强化项目现场安全管理和领导责任, 细化了各部门、分(子)公司、项目经理部安全管理责任。2017年签订安全生产责任书覆盖率达到100%。

Improve the safety management system

In 2017, in order to implement the national occupational health and safety laws and regulations, standardize the distribution of the company's high-temperature allowances, and safeguard the health rights and interests of employees, CBMI prepared and issued the Measures for the Administration on the Distribution of the Company's High-temperature Allowances. In order to promote the safety management of Sinoma International (Harbin) Environmental Resources Co., Ltd., the safety management system documents of Sinoma International (Harbin) Environmental Resources Co., Ltd. was formulated. CBMI also undertook the preparation of some safety management system documents, including 11 system documents, such as the Safety Management Regulations for Side Holes, Safety Management Regulations for Fire and Explosion Protection, Safety Management Regulations for Welding, Cutting and Grinding, Safety Management Regulations for Pile Driver Construction and Safety Management Regulations for Work at Height.

Implement safe production responsibility

Since 2017, in accordance with the requirements of "Co-responsibility of Party and Government and Making Concerted Efforts" and Provision of Putting in Place the Corporate Safety Production Responsibility System, CBMI further has implemented the responsibility of safety production, strengthened workplace safety management and leadership responsibilities, and refined the responsibility for safety management of various departments, branches (subsidiaries), and project manager. In 2017, all staff concerned executed the safety production responsibility form.

实施全员培训工程

2017年,中村建设先后组织参与了防火防灾安全培训、供应链培训、消防知识讲座、危险化学品安全管理人员培训、 安全生产标准化信息平台操作培训等,提升了员工的安全意识和安全技能。此外,中材建设组织完成三类人员培训考 核 23 人次, 所有人员均取得安全培训考核合格证书 2017 年截止 11 月底, 中材建设各项目经理部共组织开展各项安 全基础培训和高空作业、起重吊装、脚手架作业、密闭空间作业等专项培训 330 场,累计培训 13742 人次。通过开 展形式多样的培训,提高了管理人员的安全责任意识,专业人员的安全管理水平,作业人员的安全文化素质。

构建安全生产监管新常态

2017年,中国建材集团、中材股份、中材国际领导先后多次对中材建设阿尔及利亚 BC、阿尔及利亚 BISKRA、赞比 亚中材水泥、南非 PPC、乌干达、蕉岭塔牌、尼日利亚 EDO 等项目进行了安全检查,充分肯定了各项目安全管理工 作。1月-11月,公司领导先后带队进行项目现场安全大检查42次,查出隐患121项,隐患整改完成率100%;公 司领导与项目员工开展安全谈心 44 人次。通过公司领导人员安全检查及与员工安全谈心活动,公司领导和员工一起 消除安全隐患、解决安全生产问题,既增强了各级负责人坚守"红线"的能力,又增强了敢于担当的责任意识。1-11 月,各项目经理部除正常的安全日检、周检、月检及巡检外,共计开展了712次专项或综合安全检查,查出各类隐患 7212 项,全部完成整改,整改完成率100%。

Ensure full staff training

In 2017, CBMI successively conducted fire and disaster prevention safety training, supply chain training, fire knowledge lectures, training of dangerous chemicals safety management personnel, and safety production standardization information platform operation training, etc. Such move improved employees' safety awareness and skills. In addition, CBMI completed trainings on 23 persons in three types, all of whom obtained safety training conformance certificates. By the end of November 2017, CBMI has provided 330 special trainings associated with safety basics and work at height, lifting, scaffolding and confined space operations, covering 13,742 persons. Diverse trainings provided have enhanced the management's safety responsibility awareness, the safety management level of professionals, and the safe and cultural competency of operators.

Construct a new normal of safety production supervision

In 2017, leaders of CNBM, SINOMA and Sinoma Int. have repeatedly carried out safety inspections on such projects as CBMI's Algerian BC, Algerian BISKRA, CBMI Cement in Zimbia, South African PPC, Uganda, Jiaoling Ta Pai, Nigerian EDO. They fully affirmed the safety management of each project, especially giving high recognition on non-premium projects. From January to November, the company's leaders led the team to conduct 42 safety inspections on the workplace, and identified 121 hazards, all of which were rectified; the company's leaders and project staff conducted 44 safety talks. In addition, the company's leaders and employees worked together to eliminate safety hazards and solve safety production problems. It not only enhances the ability of responsible persons at all levels to adhere to the "red line", but also heightens the sense to take responsibility. From January to November, in addition to the normal daily, weekly, monthly inspections and walkdown, all project managers carried out 712 special or comprehensive safety inspections, and found 7.212 hazards, all of which were rectified.

推进安全管理信息化

2017年,中材建设继续推进安全信息平台建设,加强现场各项安全生产信息的完善性和准确性,提升公司安全基础管理。 2017年以来,公司使用中材国际安全信息平台的项目13个,其中新开设账户6个。2017年公司安全管理部共计完成11期"安全信息平台运行报告"。各项目反馈对信息平台运行过程中的问题30余条,均妥善解决,为平台的不断优化提出了有效建议,截止目前为止,公司网络状况较好的项目安全信息平台运行情况保持良好。

强化风险管控

2017 年,中材建设组织部门、分(子)公司、项目经理部进行了危险源辨识及评价,有效管理内部风险,组织开展危险源辨识及评价工作,共识别一般危险源 255 项,其中重大危险源 13 项,均采取了措施,制定了方案进行了控制。中材建设先后针对阿尔及利亚、印度尼西亚、菲律宾、俄罗斯等境外国家潜在风险,及时向相应项目提供风险提示,便于项目实现风险超前预控,为项目部提供了有力的信息保障。

安全文化建设

2017年6月,为贯彻落实上级单位文件要求,打造中材建设特色安全文化,中材建设围绕"全面落实企业安全生产主体责任"安全月主题,分公司总部和各项目部,组织开展了各项安全生产月活动,包括安全签名、安全演讲、安全猜字游戏、"最美安全员"和"示范项目"评选等,活动内容丰富,主题突出,使员工的安全知识得到了巩固,安全意识得到了进一步的提高。安全生产月期间,公司共计开展安全教育培训35余次,累计培训4904余人;累计检查项目5个,查处隐患19项,隐患整改完成率100%。

Advance information technology-based safety management

In 2017, CBMI continued to promote the construction of a safety information platform, strengthen the integrity and accuracy of all safety production information on the workplace, and enhance the company's safety basic management. Since 2017, the company has used 13 projects of CBMI International Safety Information Platform, including 6 new accounts. In 2017, the company's Safety Management Department completed a total of 11 "Safety Information Platform Operation Reports". Over 30 problems in the operation process of the information platform through the project feedbacks have been properly solved. It has put forward effective suggestions for the continuous optimization of the platform. As of now, the operation status of the project safety information platform with better network status is well maintained.

Strengthen risk management

In 2017, CBMI coordinated departments, branches (subsidiaries) and project manager department to identify and assess hazard sources. We effectively managed internal risks, and conducted hazard source identification and evaluation. A total of 255 general hazard sources were identified, including 12 major hazard sources. Relevant control measures and solutions were put in place. With respect to the potential risks of such countries in Algeria, Indonesia, the Philippines, Russia, CBMI provided risk warnings to relevant projects in a timely manner, which facilitated the project to achieve risk pre-control and provide strong information guarantee for the project department.

Safety culture construction

In June 2017, in order to implement the document requirements of the superior institute and build a special corporate safety culture, CBMI attached great importance to the safety month theme of "fully putting in place the main responsibility of corporate safety production". The headquarters and the project departments hosted a series of events, including safety signatures, safety speeches, safety puzzle games, selection of "the most beautiful security specialists" and "demonstration project", etc. The activities were rich in content and prominent in theme. They helped consolidate employees' safety knowledge and further enhance their safety awareness. During the safety production month, the company carried out over 35 safety education trainings, covering over 4,904 staff; 5 inspection items were completed and all 19 hazards detected were rectified.

安全生产实例

2017年,中材建设始终把安全生产工作摆在首位,始终把落实安全责任作为安全生产管理的主要抓手,始终把提升安全生产管理水平作为安全生产基础工作常抓不懈。

2017年,公司7个在建、新建项目引入了"多媒体安全培训工具箱",培训内容丰富,涵盖了入场培训、分部分项危险作业培训、管理人员培训、工各种培训等,使用多媒体培训工具箱,既提高了培训效率,又减少了人力成本。

阿尔及利亚 BC 项目和中国建材赞比亚工业园项目投入大量人力、物力、财力搭建"体验式安全培训区",两个项目因地制宜,分别设置了安全帽撞击体验区、灭火器演示体验区、安全用电体验区、平衡木体验区、安全带体验区、搬运重物体验区、钢丝绳使用体验区、高空坠落体验区等,利用创新的培训模式,开展全面、系统的安全教育培训,进一步提高了项目员工的安全素质。

2017年,为继续促进项目经理履职尽责工作落实,进一步夯实项目安全管理基础,公司要求新成立的项目,即阿尔及利亚 BECHAR、阿尔及利亚 ZAHANA、乌干达、肯尼亚、喀麦隆等五个项目经理在赴任现场前,在安全责任履职约谈会上向公司领导汇报项目安全管理体系建设情况,并就规范项目安全管理、落实安全主体责任做出郑重承诺。通过这一举措将对项目的安全责任落实和制度落实具有重大意义。

Safety production example

In 2017, CBMI always put safety production in the first place, regarded the implementation of safety responsibility as the main focus of safety production management, and took improvement on the safety production management level as the basic work of safety production.

In 2017, the company's 7 ongoing and new projects introduced the "multimedia safety training toolbox". The training content is rich, covering the mobilization, sub-sectional risky operation, management personnel, various disciplines training, etc. The multimedia safety training toolbox helped not only improve training efficiency but also reduce labor costs.

The Algerian BC project and the CNBM Industrial Park project in Zambia invested a large amount of manpower, materials and financial resources to build an "experiential safety training zone". The two projects were adapted to local conditions, and respectively set up a helmet impact experience zone, a fire extinguisher demonstration experience zone, and a safe electricity experience zone, a balance beam experience zone, a seat belt experience zone, a heavy object handling experience zone, the wire rope use experience zone, aerial drop experience zone, etc. The innovative training mode is used to carry out comprehensive and systematic safety education and training. Such move helps further improve the safety competency of the project staff.

In 2017, in order to continue to promote the implementation of the project manager's due diligence work, and further consolidate the project safety management foundation, the company posed a request for managers of the new project. For the five new projects, i.e. Algerian BECHAR, Algerian ZAHANA, and those in Uganda, Kenya, Cameroon, the managers before mobilization were required to report the construction of the safety management system to the corporate leaders during the safety responsibility performance interview meeting. In addition, they needed to make a solemn commitment to standardize project safety management and implement safety responsibility. Such moves would be of great significance to the implementation of the project's safety responsibility and the system.



The company upheld the goal of expanding diversified projects, strengthening energy conservation and environmental protection and industrial development. In addition, the company attached parallel importance to the development of two new business segments. The company closely focused on the group's strategic arrangement and its own market positioning, fully grasped the market opportunities, and catered to needs of customers. By overcoming the difficulties of increasing competition, our company broadened the mindset, and worked together to better accomplish the various work goals set at the beginning of the year.

2017年,中材建设组建科研技术小组。以绿色发展为主题,围绕设计工作中的重点难点,先后成立了多个科研课题小组,获得了5项新型专利授权,初步完成了移动式粉磨站的技术研发工作,其中自主研发的干冷式排渣系列环保设备和危废配伍系统已应用到常州危废项目。

Improved institutional system

In 2017, in order to make better use of the scale advantage of the Group's cement production line, combined with the country's vigorous development of the environmental protection industry for hazardous waste disposal, CBMI and Solid Waste and Chemicals Management Center of the Ministry of Environmental Protection concluded a contract on the preparation of the Industry Development Planning of Co-processing Hazardous Wastes with the CBMI's Cement Kiln. The draft of the planning report was received on December 4, 2017. Next, we would move to the planning report review before the field research.

R&D on the energy saving and environment protection technology

In 2017, CBMI established a research and technology team. With the theme of green development and focusing on the key difficulties in the design, the company set up several scientific research groups and won five licensed new patents. Besides, the company initially completed the technology research and development of the mobile grinding station, and the proprietary dry cooling type slagging series environmental protection equipment and hazardous waste compatibility system had been applied to the Changzhou hazardous waste project.

2017年,中材建设重点围绕主要客户如长城汽车、北控环保、三星集团,重点区域如阿尔及利亚、马来西亚、尼日利亚、俄罗斯区域、重点领域如工业、环保等领域进行项目拓展。全年跟踪项目 21 个(指编制了技术和商务价格方案的项目),全年签约9个合同,其中签订了5个节能环保项目,如下:北控衡兴环保危废生产管理合同、北控常州安耐得危废达标达产服务合同、哈尔滨水泥窑协同处置飞灰项目、北控淮安洪泽蓝天回转窑危废改造项目、北控淮安洪泽污泥烘干危废改造项目。

In 2017, CBMI expanded its businesses by focusing on such important customers as GWM, Beijing Enterprises Holdings Environment Technology Co., Ltd., Samsung Group, key areas such as Algeria, Malaysia, Nigeria, Russia, and key segments such as industry and environmental protection. In the whole year, 21 projects were tracked (referring to the preparation of technical and commercial price plan). 9 contracts were signed throughout the year, among which there were 5 energy conservation and environmental protection projects: BEH Hengxing Environment Hazardous Waste Production Management Contract, BEH Changzhou Annaide Hazardous Waste Compliance Service Contract, Harbin Cement Kiln Co-processing Flying Ash Project, BEH Huai'an Hongze Blue Sky Rotary Kiln Hazardous Waste Rectification Project and BEH Huai'an Hongze Sludge Drying Hazardous Waste Rectification Project.

The following measures have been adopted:

The company had 216 scientific research personnel, accounting for 18.57% of the company's total staff. In 2017, 45 employees were added. Among them, there were 22 college graduates and 23 from the society.

In 2017, the total amount of Ping An Insurance claims for CBMI was 269,508 yuan. 8 cases of inpatient and outpatient with special diseases were completed, and the amount of claims was 132,916 yuan; the medical expenses of workers with work-related injuries were reimbursed for 17 times, and the amount of claims was 540,47.10 yuan; the reimbursement of retired cadres was 5 times, and the amount of claims was 17,508 yuan. In accordance with the Circular on Adjusting the Subsidy Standards for Living Difficulties of Staff Members after the Death of Staff in Institutions and Authorities, the living relief fund were distributed to 17 survivors of employees; extending favor campaign. The Labor Union arranged special personnel to visit 10 sick workers, family members of deceased workers, employees with deceased parents and disaster-stricken workers, and sent the organization's concerns to the employees and their families; having overcome various difficulties and actively communicated with relevant education bureaus and schools in Tianjin and Tangshan, the company properly processed the schooling transfer procedures for 12 children with household registration migrated to Tianjin;

In 2017, a total of 116 housing provident fund data were reviewed and the corresponding money was withdrawn.

The company organized a team to participate in the "Boda Cup" 2017 Basketball League in Yizhuang, and won the "Excellent Organization Award"; The company organized a team to participate in the "CBMI Cup" badminton competition, entered the quarter-finals, and won the "Excellent Organization Award".

In 2017, at the beginning of the CBMI Algerian ZAHANA project, a civilized construction administration approach was formulated. Wastes and scraps were subject to the centralized recycling treatment to minimize the environmental impact arising out of the construction. At present, Nigerian regional subsidiary SINORIA is carrying out a deal worthy of 225.6 million US dollars, including: local split of cement project of 202 million US dollars, local split of production and operation of 19.4 million US dollars, sales of factory FABCOM 4 million US dollars/year. In step with the diversified development, the regional company coordinates, managements and serves regional projects, rationally deploys regional equipment, materials and funds to leverage regional project clustering effects and reduce project costs and risks.

Progress of Algerian UICEM project

On January 18, 2017, the Nigerian Unicem project received a PAC certificate issued by the owner, seven weeks ahead of the contract period. Through the joint efforts of the project staff, the Unicem project commenced the ignition and materials feeding on August 23, 2017, and completed the performance evaluation of the clinker and cement lines in less than 4 months. Besides, we obtained the PAC certificate issued by the owner seven weeks ahead of the contract period. The project has been free from major construction and production safety incidents during the implementation.

尼日利亚 SOKOTO 项目进展

2017年,尼日利亚 SOKOTO 项目设计工作全部完成,设备订货全部完成,发运除补发设备以及在线分析仪以外全部完 成。现场施工自 2014 年 12 月 1 日开始, 2017 年土建工作基本完工, 现场钢结构、机械安装和电气安装工作已接近尾 声,整体进度已经达到94.59%。从12月开始陆续进入设备单机试车阶段。项目部根据实际情况设定4个节点目标: 2018年1月初石灰石堆棚进料;2月初生料磨开磨,生料入均化库;点火目标为3月12日;出水泥时间为4月中下旬。 2017年度工程款回收总体状况良好,现场施工成本可控。

Progress of Algerian SOKOTO project

In 2017, the design of the SOKOTO project in Nigeria and the equipment order were fully completed. All the shipments were completed except for the additional equipment and the online analyzer. On-site construction began on December 1, 2014. The civil work in 2017 was basically completed. The on-site steel structure, mechanical and electrical installations are close to completion, and it's up to 94.59% of the overall progress. Since December, it will successively move to the stage of single equipment test. The project department sets 4 milestone targets according to the actual situation: mobilization of limestone pile shed in early January 2018; raw material grinding commencement in early February, raw material access to homogenization pool; target date for ignition March 12; cementing time Mid-to-late April. In 2017, the overall scenario of the collection pf project money was sound and the construction cost in the workplace under control.
