## Description of Actions

This Ineval Foundation has been a proud member of the [Global Compact](#) since its inception in 2005, an initiative to improve the respect of corporations to the needs of the people that is in line with the principles and the efforts we pioneered since our own inception in 2001.

Our most important activities in compliance (and exceeding by far) of the [10 principles of the Compact](#) are:

- Collaborated in the drafting and subsequent dissemination of the standard [ISO 26000](#), which we did via our participation in the Ethics Committee of AENOR, of which we are a founding member. Also via countless seminars to teach its implementation in Companies, especially in India.
- The creation and support of Social Economy initiatives, such as the Institute for Social Currency, [“Instituto de la Moneda Social”](#), which provides a meeting point for more than 40 experts of Spanish-speaking countries and beyond, who have spearheaded countless social projects and, via the Institute, share their knowledge to activists and society at large.
- Our leading participation in the drafting of the [National Values Plan](#) “Pla Nacional de Valors”, coordinating the Economy Space, discussing Values and Policies with Catalan Government officials and 20 Corporation Leaders. A five-year effort from 2011 to 2015.
- Our engagement with the [Conscious Country Platform](#), “Plataforma País Conscient”, an assembly of people determined to push mainstream society towards a business attitude and Government policies which be more people-conscious. Work started this year of 2016 and is expected to continue for another five years.
- Our program for “Natural Leadership” of Corporations called [“Los 5 pilares del Liderazgo Natural”](#) which in essence calls for values to be applied to the management of corporations in an efficient way.

## Measurement of Outcomes

Such broad efforts, which are our main “raison d’être”, aim at the creation of climates and, therefore, are not prone to an accurate metric of the outcomes. However, some data are outstanding, as follows:

- Our Facebook Page on Natural Leadership and Human Management Methods sports 26000+ Likes.
- The Barcelona Corporation, Ajuntament de Barcelona, has widely disseminated the publication “Fichas de Moneda Social”, which our experts made for them in 2016.
- The publication of ISO-26000/2010 in November of 2010 is in itself an outstanding outcome of our cooperation work along the lines of the Global Compact, as are the current improvements to the Standard. According to ISO in Geneva, this standard is the best selling ever.
- We sponsor and administer the new means of exchange for the betterment of the welfare of women, Venushina. The mere fact that the association “Red Global de Mujeres Prósperas” has entrusted to Ineval their means of exchange and even their corporate headquarters, speaks of our prestige as a foundation committed to social welfare.
