MEMBERSHIP TO THE BOARD OF DIRECTORS

OCEAN CONFERENCE 2017

IUCN contributed greatly to the Voluntary commitments made at the SDG 14 Ocean Conference in June 2017 in close collaboration with UNGC. Among them, the Action Platform for Source-to Sea Management (S2S Platform), the Blue Carbon Initiative, the Sustainable Ocean Initiative (SOI), and the International Coral Reef Initiative (ICRI).

THE FUTURE

In the next two years, IUCN's work will focus on three specific areas:

Valuing biodiversity enhances IUCN's work to ensure business impacts and dependencies on biodiversity are integrated into business decision making.

Promoting biodiversity net gain consolidates IUCN's work to help business demonstrate the benefits of a biodiversity net gain goal in and around their operations, with the support of civil society and regulators.

Investing in nature expands IUCN's work to foster conservation incentives and investments at scale, in collaboration with business, and especially financial institutions.

At the next IUCN World Conservation Congress in June 2020 we hope to mobilize a strong business engagement component in the next quadrennial program and therefore count on UNGC support to help mobilize the business community for that event and building up the next IUCN program.

II. Measurement of outcomes

In addition to measuring our outcomes according to IUCN's Monitoring & Evaluation framework, we will track our support to the UN Global Compact by measuring how many corporate members of the UNGC we engage in the reporting period.
