

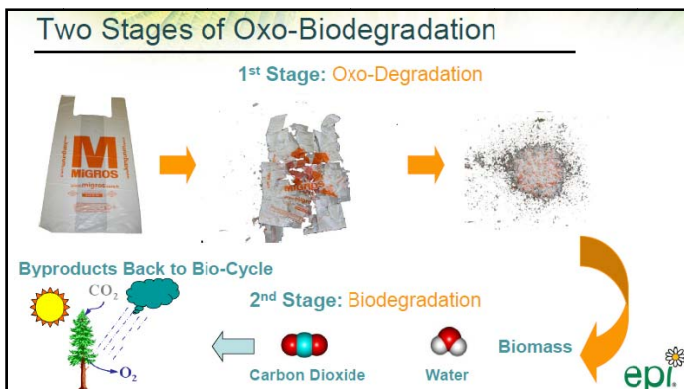

## **VII. Conclusion**

The PE white book bags incorporating DCP 125 @ 1% will have 18 months product life at 35°C storage temperature from the manufacturing date. At the end of their product life, the PE bags are degradable within 24-36 months when disposed of in an environment where oxygen, UV light and heat are present.
