## PROFILE

### Children Watch Cadres of Wonokusumo

#### **Brief introduction to Children Watch Cadres of Wonokusumo and their importance for the community.**

*Kader Pemantau Anak Wonokusumo* (Children Watch Cadres of Wonokusumo) was formed to observe children aged 0 to 18 years old in Wonokusumo urban village to meet their rights on a daily basis. The group consists of 39 housewives as the representative members from each hamlet. It started in a month of July 2016 where hamlet cadres found violence and sexual abuse cases against children. As mothers themselves, the representative members felt necessary for them to spare some time in providing comfortable environment for their children to grow well protected.

#### **Areas covered by the child protection group.**

Currently, the group works in Wonokusumo, Semampir sub-district, Surabaya. However, they work together with cadres from Ampel, Ujung, Sidotopo, and Pegirian hamlets since a month ago. The sub-district office directs them to develop through this partnership.

#### **Up to date achievements**

Assisted by Gugah Nurani Indonesia, the cadres group has disseminated activity related to child protection issue at local health post as well as in the neighborhood. They also have assisted and supported child case management also monitored the conditions affected by such cases.

#### **Cases dealt by the group since 2016.**

The group has assisted in a sexual abuse case of a 12 year old boy against a 9 year old girl. Later, the group reported the findings to the leader of the hamlet and sub-district, as well as the local police. As a result, the parents of the girl demanded the expulsion of the boy from his school.

#### **The act of the group in the above case.**

When the case happened, the group was just recently formed. The members did not know how to handle a child protection case. All that they understood was that as child observers they were only supposed to observe and not to directly handle the case. All that they could do was to provide coordination with the local stakeholders and feedback to the parents of both involved children in the said case, and left the rest of the case to the police. Learning from this experience, the group decided to seek knowledge on child protection procedure and case support from GNI to support them in capacity building activity.

#### **What have they learned after supported by GNI.**

Equipped with the knowledge gained from GNI, a cadre of the group who happen to be the owner of an iced tea stall observed an unusual activity of the local children who often visit the stall put some kind of a pill in into their drinks bought at the stall. This situation was immediately reported to the parents, community leader, and the hamlet leader to prevent recurring of the situation to avoid potential drugs abuse.

#### **The most significant changes in the group after supported by GNI.**

Before 2016, only physical fights were reported to the police and no importance were given to any social incidents. After supported by GNI, the group could reach the community people to talk, to share opinions, and information referring to cases for any support. Since there has been a system built in the community, the group has started receiving reports on child related case.

#### **Parents' reaction after the existence of the child protection group.**

The parents feel helpful with the existence of GNI program and child protection group. They are provided with medium to discuss child protection related cases to handle. For instance when was a case of a child abused by a family member, the group provided assistance to the family member to reconcile with the child.

#### **The group's aspiration to consistently protecting children in Wonokusumo.**

It is understood that the support of the group is not reached every nook and corner of Wonokusumo yet, but with the existence of the cadres in each hamlet, it is hoped that the community members will eventually get familiar with the function of the group. Hopefully, the child protection group will also be known to the people along with other existing community groups for their common benefits.

## Strategic Objective

# PEOPLE ENJOY THE RIGHT TO EDUCATION

Education is not only a human right in itself, but an essential right to realize other human rights. In addition, education is an opportunity for individuals to develop their own abilities and improve their quality of life, and is the cornerstone of self-empowerment.

GNI will endeavor to ensure that children have access to quality public education regardless of gender, and that support adults to enjoy the right to education.

Firstly, children should be able to receive equal education regardless of their gender and their family's economic condition. GNI will help children who are in difficult situations to access opportunities to education. GNI will also support parents and others who have great influence on children's educational rights to recognize the importance of children's right to education. In addition, GNI will make efforts to improve the quality of primary and secondary education to ensure proper education rights. At the same time, GNI will create an environment in which girls can receive education in safe conditions.

Furthermore, GNI will create opportunities for adults to obtain basic literacy skills such as reading, writing, speaking and listening, and numeracy to improve their social life. Assistance for a lifelong education will also be provided to resolve their own issues.





## THE AFFORDABLE FACILITY FOR EARLY CHILDHOOD EDUCATION

Located at Menteng Tenggulun area, Buah Menteng 09 Early Childhood Education facility has become an affordable solution for pre-school aged children. To access a regular kindergarten, parents around this dense area are burdened by the amount of payment they have to make to enroll their children.

According to Ms. Mulyani, the headmistress of Buah Menteng 09, the significant difference since the establishment of Early Childhood Education facility in Batavia CDP is quite feasible in contrast to situation before where children used to wander around the neighborhood. But now, children are eager to wake up in the morning to attend their classes. Hopefully the government pays more attention to this condition and do not consider teachers as volunteers only.

## GUGAH NURANI INDONESIA SUPPORTS EARLY CHILDHOOD EDUCATION TEACHERS

The capacity building for early childhood education teacher is a subject that still needs to be done independently concerning the lack of access to government programs. Gugah Nurani Indonesia facilitates training on teaching methods and the provision of educational material support for As-Syifa school which is located at one of the coverage areas of Batavia CDP in Cakung.

Ms. Siti Mahmuda, the headmistress of the school claims that the number of enrolled students is increasing over the years. Teachers have developed themselves in procedure of school management as well as in capacity. Since half of the teachers have no formal background in education, increased capacity is needed to provide a better quality of the learning for the students.

**Being one of sponsored child in Deli Serdang CDP since 2012, Lando (14), has grown up so much over the years. Currently studying in secondary school, our early record of him shows his diligence in attending school. Living only with his grandmother and limited resources do not discourage him to go to school everyday even though his school is located around 20 km from his house and he has no means of transportation. GNI supported his transportation so he can go to school.**

**Hi Lando! Now that you are a teenager and attending secondary school, what do you like the most about going to school?**

My friends, with whom I can share my experience in school, play, crack jokes and laugh together. I really like meeting my friends in school.

**We heard that you did not come to school for a while.**

Since my school is now located quite far from my house. I could no longer walk there, well, actually I could but it'll take three hours so I guess it's not possible for me. I used to go to school with my friend by his motorcycle. He also lives nearby. But unfortunately, his motorcycle was broken and since I could not share the reparation cost, he then charged me to pay Rp10.000 every time I go with him to school.

**That is very unfortunate, so how did you respond to that?**

My grandmother asked him for a discount, since we could not afford to pay the sum of money everyday, but he rejected the idea. You see, my grandmother has a problem with her health so she cannot work, our family income is very unsteady. I understand that so I didn't push her and choose to stay at home and help her instead.

**But now you are attending school again, we also heard that you never miss a day in school.**

GNI visited my grandmother the other day. They said they could provide a transportation for me to go to school. I was so excited hearing that. So now everyday, I don't have to worry about not being able to attend school because of transportation. There is someone who drops me and picks me up at school now.

**What is the most significant change you feel now that you do not have to worry about anymore?**

I can't think of any (laugh) but it definitely put my grandmother's mind and mine at ease. It lessens our burden as well, especially my grandmother's because I have been able to go to school again.

**We appreciate your motivation in going to school against all odds. Why do you think it is important to go to school?**

Because in school I can learn and become smarter. If I am smart, I can achieve my dreams. Since most of my friends go to school, I don't like to be left behind. That's what motivates me to go to school.

**Your grandmother said that she could support you only up to secondary school.**

I have to finish high school no matter how. The cost of attending high school will be higher than now so I said to my grandmother that maybe I can save some money now and work in the field after school. But my grandmother doesn't like me working in the field, she said it's dangerous.

**You attend school until midday. What is your activity outside school?**

I sometimes go with my friends to the field nearby and play football there. I also participated football competition sometimes. But mostly, everyday I shepherding my neighbor's cows and get paid for it then give it to my grandmother.

**Education is one of your rights as a child and through education, you can achieve many things in life. Do you have any wish for yourself when you grow up and become an adult?**

I want to be a soldier one day. When I earn some money, I want to give it to my grandmother. I want to be able to support her because she has supported me in every way she could since I was very little. So I told her to keep her health until I can do that.

## Strategic Objective

# PEOPLE EXERCISE THE RIGHT TO HEALTH

The right to health is a fundamental human right and is one of the essential conditions for exercising other human rights. This includes both the right to health and physical control, the right to privacy, and the right to health care systems that provide equal opportunity to enjoy the highest level of health obtainable.

GNI recognize that ensuring people's right to health is more than important. Therefore, we will work to ensure that people have access to basic health services. GNI will also focus on protection of mothers and young children under the age of five and ensure that people practice sexual reproductive health behaviours in the community. In addition, GNI will improve the access to drinking water and hygiene facilities to provide safe and sufficient drinking water.

## CLEAN WATER RESOURCE FOR MUTEN SUB-VILLAGERS, KULON PROGO DISTRICT, YOGYAKARTA

Previously, the residents of Muten sub-village had to walk a few kilometers to get to the springs for clean water. The contour of the hilly land and a trail to follow was the challenge. Water source in their neighborhood was murky so it was not feasible to use for daily needs.

The Indonesian jargon “*sumber air sudah dekat* (water source is nearby)” has become a reality now for the villagers since the construction of water reservoir close to their houses. The community actively got involved right from the beginning of the reservoir construction until the installation of pipes. All were done hand-in-hand by the community people. They also formed a committee to maintain the sustainability of this public facility.

Sulastri is one of the beneficiaries of this project. According to her, the water is clean and has enough amount of supply also safe enough for daily consumption. She adds that the water supply is all good for laundry, dishes, cooking and drinking. Not to forget the convenience the villagers enjoy.

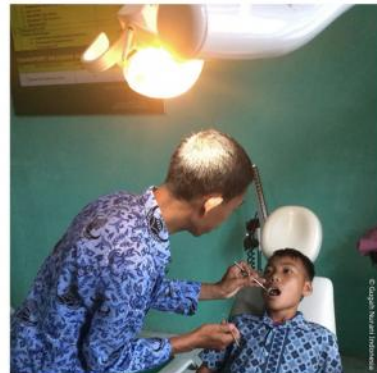

lis lives in a village in the foothills of Halimun mountain. She gave birth to her second daughter with a cleft lip. Her first daughter is one of our sponsored children in Bogor Cileuksa CDP. GNI heard the news about the new baby from local health cadres who visited her house to check on her baby's and her health condition. She was much worried for she needed to support her daughters without her husband who left her and moved out of the village. The baby's condition got weaker due to limited breastmilk from her mother.

**We have been supporting the mother and the child since 2017 and continued to do so in 2018. Bogor Cileuksa CDP has established a good cooperation with the village, including its health cadres. Together, we ensure that people living in the village can have access to good health services.**

**Your baby is almost two years old now. Please briefly explain how she is doing now?**

Wina is my second daughter. She was born in late 2017 with a cleft lip but she's doing great now. She eats a lot and is growing well. She is a very active child now.

**Let's go back to the time when she was just born. Can you explain the condition of your second daughter when she was born?**

She was born healthy. Later, she had problem drinking due to the cleft lip she was born with. My worries grew as the production of my breastmilk dropped drastically, until it completely stopped producing. As a result my daughter started getting weaker every day. I was very confused without my husband at that time. I had to do everything on my own to support my family. I could not work because much attention was to be paid to my second daughter with her condition. Fortunately, from time to time the village midwife and GNI staff sometimes visited me to check on my daughter's condition and provided me with necessary care and support.

**Other than those visits, in what form the care and support you received from GNI and the village for your family?**

During one of the visits, the local midwife informed me that a special kind of milk bottle was needed for my daughter due to her cleft lip. I was glad when one of GNI staff members brought me the bottle and a supply of formula milk, breast pump, and diapers for my baby. Ever since, my daughter is getting better and stronger.

**We see that Wina has no cleft lip anymore.**

The village midwife told me that there were many hospitals which offered cleft lip surgery but they could not promise the schedule. Several days later, my friend told me about a hospital which offered free cleft lip surgery, but the hospital was very far away from here, so I contacted GNI staff members and they found out more information from the hospital for me. After registering Wina to undergo a preliminary treatment, we had to wait until Wina was three months old for her first treatment. After that, Wina underwent two surgeries in seven months period.

**You had to wait for five months before Wina underwent for her second surgery. How did you prepared her for her second surgery while recovering from her first surgery?**

Since Wina was not well before her first surgery, the doctor advised me to take a good care of Wina before the second surgery. With the help and kindness of GNI, Wina regained her health faster than expected. After the first surgery and before the second surgery, I got enough support from GNI in form of nutritions which helped me maintain Wina's health condition.

**The hospital was located very far from here, how did you managed to get there from this village which practically hard to reach even from the Bogor city?**

I wished I didn't have to go too far for my daughter's treatment. However, since my village was located in the foothills of Halimun mountain, I had no choice. Fortunately, my anxiousness was wiped out by GNI who provided a car for my mobility to the hospital. I was also accompanied by GNI staff at all time during my visits to the hospital to assist me and explain the regulations. The involvement of GNI in every form of assistance for my daughter's treatment was much valuable than the free cleft lip surgery that I got from the hospital. No matter how many times I had to get back to the hospital, GNI was always willing to support and make sure that we were well taken care of during the trip.

## Strategic Objective

# PEOPLE BUILD INCLUSIVE AND DEMOCRATIC COMMUNITY

The social structure of a community has a profound effect on one's life. The social structure leaves people in poverty is unjust. Social inequality and oppression are neither right nor natural. Likewise, poverty made from those is not natural. Every human being has an inalienable dignity and rights including the right to pursue his life according to his free will.

First, GNI will strive to raise people's awareness about inclusiveness and non-discrimination in order to eliminate discrimination and exclusion. That is, GNI will try to help people recognize that any kind of discrimination is wrong and respect each other as subjects of equal rights. In this end, we will support democratic operation of community organizations. The establishment of democratic decision-making in community allows no people isolated or discriminated.

Our activities will also include promotion of opportunities for everyone to share ideas and opinions with one another. This would also help all the people stand as fair members of the community. Furthermore, GNI will support people to have more community activities. Community activities promote chances to people be together regardless of social class and wealth.





## PROFILE

### “THE COMMITTEE AIMS FOR INDEPENDENCY AND WELL DEVELOPED VILLAGE POST GNI ASSISTANCES”

#### History of the Village People Empowerment Committee of Bulucina, Deli Serdang.

In 2011, when Gugah Nurani Indonesia entered Bulucina, we became members of Community Development Committee (CDC), a group formed by the organization. But, the English nomenclature was difficult to pronounce and understand by the community people. Then in 2016, after being equipped with training and assistance, by the result of plenary meeting, we proclaimed ourselves into a new organization of our own under the name *Komite Pemberdayaan Masyarakat Desa* (Village People Empowerment Committee). We have the articles of association and bylaws also plan our own programs. As a partner of GNI, we implemented the community development programs. We provide input for activities planning and in-charge for its execution. For example, this year together we run dissemination on reproduction health for the youths.

#### The importance to be part of the committee.

There are hundreds of Gugah Nurani Indonesia sponsored children in Bulucina village. I am one of the representative from sponsored child's parents. By joining the committee, we could observe and monitor the achievement and the benefits of the programs. We could also give inputs to the implementation of any activities. In addition, I, personally, have interest to be involved in Gugah Nurani Indonesia's activities in education, health, and economic sectors.

#### The most significant change after the committee runs its own functions.

Our functions have been well understood by the community people. They notice how this committee empower people in the village. Moreover, some of them have changed their mindset to care more for others. This is not going to be an easy process. However, the spirit would remain alive as long as the willingness from the community people exists.

#### The goals of the committee in the near future.

We hope that the committee becomes less dependent on Gugah Nurani Indonesia. The committee aims for independency and well developed village post GNI assistances. Many things have been facilitated to us by GNI, such as farming, processing of poultry feed, and cooperative programs. To actively get involved in every activities is the obligation for the people because all programs lead to the increment of the people's welfare.

For example, through poultry feed fermentation training, we have learned that all parts of a plant is possible to use as poultry feed for the livestock. Previously, the community people used only the tender leaves while discarding the rest of a plant. We would like to carry on this kind of effort for our community. We also hope that the village officials could take part to respond the programs that have been planned by the committee.

In 2018, Gugah Nurani Indonesia assisted 20 community groups (CDC) at 15 CDPs, with 356 members in total. Amongst those, two groups had actively involved in the village planning also established their own article of association and bylaws.

## Strategic Objective

# PEOPLE ACHIEVE ECONOMIC CAPACITY DEVELOPMENT THROUGH SOLIDARITY AND COOPERATION

In order to create 'a world without hunger, where people live in harmony', we need to achieve not only social empowerment but economic empowerment. People can only begin to think about the future when they are free from everyday survival.

We will focus on strengthening capacity of social economic organizations in order to promote the social economy. Therefore, we will support social economic organizations' democratic operation, which is critical to hold social values over capital. We will also assist social economic organizations economically sustainable through increasing its market competitiveness and access to markets. We will assist people to have increased knowledge on finance and access to financial services so that finance, which is one of the pillars of economic competence, can reach everyone.

In 2018, Gugah Nurani Indonesia had assisted 22 economic groups spread in 15 CDPs. Total number of people who joined the groups was 913, consists of 383 male members and 527 female members. Currently, 4 business groups had already started to run their commerce activity.

## BUSINESS GROUP FORMATION

In 2018, Surabaya Wonokusumo CDP partnered with Pristine Institute Indonesia to conduct a potential business assessment. This activity involved 63 local business enthusiasts and the residents of Wonokusumo.

Currently, Surabaya Wonokusumo CDP is assisting one business group which produces fashion accessories under the name of Syandera Collection. The type of business itself match with result from the assessment. Syandera Collection received an intensive training throughout the year. A monthly meeting is set to gather all members while updating their craftsmanship.

Syandera Collection business group started to cooperate with an accessories store for the sales. However, there remains challenges to overcome, such as the sporadic practice and uncoordinated marketing strategy, inconsistency of the product output, and the licensing process that still need to be done. In the future, together we will try to form product and mechanism standards as another step to prepare the business readiness.

## Strategic Objective

# PEOPLE ARE PROTECTED FROM DISASTERS

Disasters lead to human and economic losses and damages in infrastructure. Especially the effects of accelerating climate change escalate the frequency and magnitude of disasters and widening affecting areas where we thought were once safe. Communities that do not have proper resources to prepare are the most vulnerable to disasters, and often times the majority of victims are children, women, and the poor.

Disasters recovery is critical but often neglected. Emergency support can enable people to overcome immediate problems, but increased vulnerabilities such as damaged infrastructures, broken livelihoods and collapsed safety nets bring about another disaster. In the end, the community cannot sustain and collapse.

We will support and protect those who suffer from disasters. In this effort, we will make sure that the necessary aid is available to the victim in the shortest amount of time in the event of a disaster. In addition, we will provide assistance to the victims for their rapid recovery to daily life.



## LOMBOK EARTHQUAKE

Series of moderate to strong earthquakes had rocked cities and regencies in Lombok Island, West Nusa Tenggara (NTB), in the month of July and August 2018. At the end of emergency period, i.e. 17 August 2018, National Disaster Management Authority (BNPB) had verified an overall fatalities at 431,426 people internally displaced and 81,590 property damages. The biggest damage was in the North Lombok district. Thousands of houses were damaged, and most of those killed were hit by collapsed houses. The number of death toll in North Lombok was 404 from total victims of 483. And the number of injured in North Lombok was 829 from total injured 1,416 (17 August 2018).

To respond to this condition, Gugah Nurani Indonesia dispatched our team to Pemenang sub-district, North Lombok. We mobilized seven doctors to deliver medical services for 6,736 people, distributing 30 communal tents, 3,000 pieces of baby diapers, 1,500 blankets, 1,500 kits of Non Food Items (NFI) including hygiene supplies, towels, first aid kits, and installation of 10 water and sanitation facilities. In addition, to the help from our partners, we also delivered individual tents, stoves, cooking pots, biomass stoves, sleeping mattresses, blankets, medicines, fresh food items, generators, shoes for children, water seal latrines, pipes, cements, and water tanks.

In Gugah Nurani Indonesia's efforts to respond to the disaster, we cooperated with Pemenang sub-district officials, medical practitioners and the Indonesian army.

## DONGGALA EARTHQUAKE

A 7.4 magnitude tectonic earthquake had occurred in Donggala district, Central Sulawesi on the 28 September 2018 on 17:02 WIB located at 26 kilometers from North Donggala Central Sulawesi, with a depth of 10 kilometers in northeast. The disaster affected not only Donggala Regency but also the neighboring areas such as Palu City, Sigi Regency, and Parigi Moutong Regency. Until 22 October 2018, more than 600,000 people were affected, including at least 180,000 children. More than 205,870 people have been internally displaced in the worst-hit city of Palu, and around 67,310 homes had been destroyed or damaged.

With the support of Good Neighbors Korea, Good Neighbors Japan, and Good Neighbors USA, Gugah Nurani Indonesia focused the emergency responses to 6 villages at Donggala Regency. We distributed 150 family tents, 1,500 hygiene kits, 1,500 blankets, medicines, 4,337 mattresses, and 1,789 kitchenware packages. During the recovery period, we established the Child Friendly Space (CFS) where children could access free and structured playground, recreation, and learning activities to get back to normalcy of life. The CFS had been formed in 4 villages, namely Loli Dondo, Boya, Salu bomba, and Kola Kola with the coordination of the village authority. The project started on 1 December 2018 and ended on 27 March 2019.

In performing the response, Gugah Nurani Indonesia's efforts to respond to the disaster, we cooperated with Donggala Regency government and Indonesian army in local level. While in national level, we coordinated with The ASEAN Coordinating Centre for Humanitarian Assistance on Disaster Management and the National Cluster of joint NGO, INGO, and government on protection and evacuation.

Until came the day when the four of us were queuing for a toilet session at the teacher’s toilet. I remember how I almost lost control which forced me to run to the student’s toilet at the other side of the school. That time, I had informed that the water tap in the toilet was dry as in most part of the village. I could manage the situation with the necessary supply I carried, but the horrible scene was that human waste scattered everywhere in a room where I was standing!

Living in Indonesia is not always the problem of traffic jams and poor internet connection, –a common complaint from an urban-raised. But also facing problems like own a toilet with no access to water, live at a foothill area that has no direct source of water because it has been controlled by certain people, you have rivers that you have to share with buffalos, motorcycle cleaners, and the greatest –garbage trowers. This is just to talk about water issue only.

Now let us talk about what have you done. What is it?

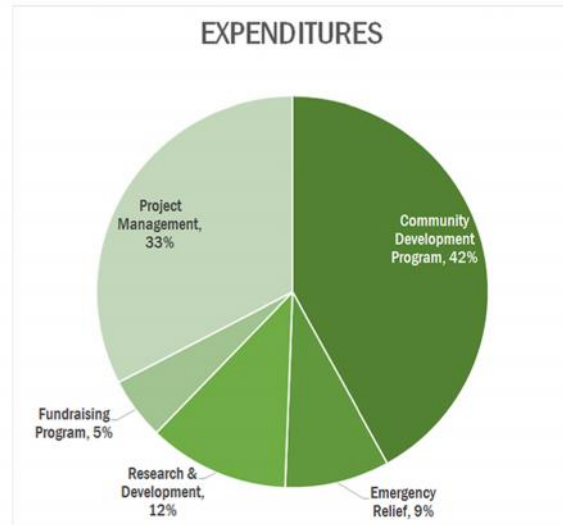
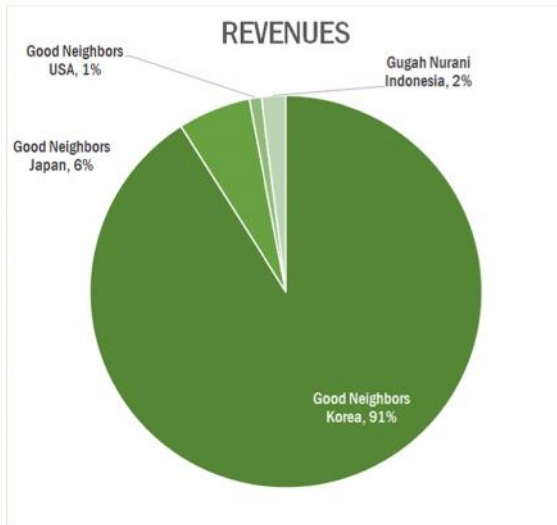
