STAFF STRENGTH

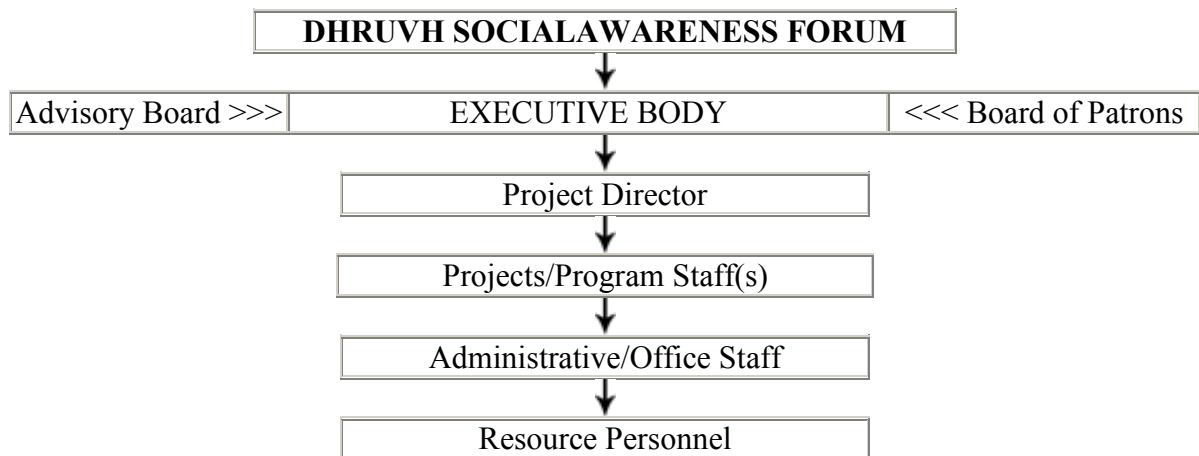

DHRUVH Social Awareness Forum's execution of projects/ program structure is as follows:-



Executive Body : The Executive Body is elected/nominated by the majority of the general members of the organization. Its prime responsibilities are overall supervision, guidance and policy decisions in consultation with the Advisory Board and Patrons Board. The Executive Body oversees program/project implementation in the designated targets areas in consonance with the ideas and requirements of donors and all stakeholders with a view to achieving sustainable growth and development.

Project Director : The Project Director is responsible for the evaluation and smooth execution of the specific project/program in a transparent manner and is responsible and accountable to the Executive Body towards the implementation and impact of the project/program in the designated areas. He is the second in command after the Executive Body.

Project/Program Staff : They will monitor and be accountable to the Project Director at all times and keep him informed of all results or shortcomings in the implementation of the program/project. The NGO has skeletal staff attending to our on going projects and depending upon the uniqueness and time-bound manner of a particular program/project, qualified professionals are appointed on contract for the execution of such programs/projects in consultation with the Project Director.

Administrative Staff : The administrative staff are primarily engaged with the day-to-day routine office work and consists of an Office-Superintendent and clerical staff including supporting staff.

Resource Persons : The Executive Body in consultation with the Project Director engages resource persons according to the requirement of a program/project. The resource persons will be experts in their own field of social work. Their views on various social issues may well be a motivating force or catalyst to the targeted audience. Awareness of a social problem is the first and foremost requirement before embarking on social reforms. Information, evaluation and communication form the bedrock of any awareness program.
