Part II. Description of Actions

The Institute for Global Environmental Strategies (IGES) has promoted the GC and its principles through the following activities:

- 1) Collaborated with Global Compact Network Japan (GCNJ) to promote the Sustainable Development Goals (SDGs) among business and other stakeholders in Japan and beyond.
 - ✧ Conducted joint research on the status of SDGs awareness and integration into business activities by Japanese companies to understand the overall picture of SDG implementation taken by Japanese companies. (August 2017 - July 2019).
 - ✧ Jointly collaborated with GCNJ to translate “Integrating the SDGs into Corporate Reporting: A Practical Guide” and “In Focus: Addressing Investor Needs in Business Reporting on the SDGs” and published the Japanese version. Held a joint symposium to widely disseminate the importance of SDGs reporting among Japanese companies and other stakeholders (January 2019).
 - ✧ Published two joint research reports between IGES and GCNJ in 2018 and 2019, called “SDGs and Business for the Future – Actions by private companies in Japan” and “Main streaming the SDGs in Business – Actions by companies and organizations in Japan” respectively.
 - ✧ Disseminated the key findings from the above-mentioned joint research report through invited lectures, media briefings and articles by other organizations (e.g. Global Compact Progress Report 2019)
- 2) Provided support to UNGC business participants in their own sustainability implementation and disclosure efforts through above-mentioned activities as well as continued participation in GCNJ study groups and other related meetings, such as:
 - ✧ Participated in and promoted the above-mentioned outputs in HLPF etc.
 - ✧ Jointly organized and invited GCNJ members to the annual conference, “International Forum for Sustainable Asia and the Pacific (ISAP) in 2018 and 2019 organized by IGES and United Nations University Institute of Advanced Studies (UNU-IAS).
 - ✧ Invited a senior manager of UN Global Compact (UNGC) to a side event host by IGES in occasion of the High Level Political Forum (HLPF) 2019. Helped UNGC invite the vice president of Japanese Ministry of the Environment at an event held by UNGC at TICAD 7.
 - ✧ Regularly participated in GCNJ study groups on SDGs, ESG, and Reporting.
 - ✧ An IGES researcher will soon become a reviewer of “United Nations Global Compact Academy review”.
 - ✧ Apart from the joint activity, IGES fully supports GCNJ’s activities as the president of IGES serves as a board member and an IGES researcher does as a member of SDGs Taskforce of GCNJ.

Part III. Measurement of Outcomes

As a result of the above-mentioned activities, IGES has contributed to the increased recognition of SDGs among Japanese business and beyond through several outcomes witnessed so far, including: increased media coverage, invited lectures, as well as a growing number of business participants and membership in UN Global Compact/GCNJ networks. More details are as follows:

- ✧ Witnessed the increased number of new UN Global Compact/GCNJ business membership in this two years
- ✧ Increased media coverage on the key findings from the IGES-GCNJ joint research in key Japanese newspapers and online articles (approx. more than 30 times).
- ✧ Increased number of invited lectures on the key findings from the IGES-GCNJ joint research as well as the translated reports. During 2017 – 2019, IGES conducted more than 40 lectures in Asia, including Japan.
- ✧ Distributed more than 500 copies of the IGES-GCNJ joint report at UN and other relevant events (e.g. HLPF, Asia Pacific Forum on Sustainable Development, WBCSD annual event, CSR Asia Summit).
- ✧ Increased number of partnerships formalised with mutual aims to advance the UN Global Compact principles through joint research and participation to GCNJ working groups.
